

GUIDELINES FOR FILING A GUARDIANSHIP AND/OR CONSERVATORSHIP

You can request a copy of the Winnebago Tribal Code's Guardianship and Conservatorship Code, which is located in Title 18 of the Winnebago Tribal Code, from the Tribal Court. You should review that Code prior to filing your Petition.

REQUEST A GUARDIANSHIP IF – You are only looking for legal decision-making power for the Ward, and not for authority to spend the money of or handle the property of the Ward.

REQUEST A CONSERVATORSHIP IF – You are only looking for the authority to spend the money of or handle the property of the Ward, and not for legal decision-making power for the Ward.

REQUEST BOTH A GUARDIANSHIP AND CONSERVATORSHIP IF – You are looking for legal decision-making power for the Ward and for the authority to spend the money of or handle the property of the Ward, and not for legal decision-making power for the Ward.

In the Petition, you can ask for an **EMERGENCY** order which will be considered before any hearing is held, and would be based solely on the information you put in to the Petition. You can also ask for a **TEMPORARY** order which would be considered before a final hearing, but after the Ward is given notice that you have requested a Guardianship and/or a Conservatorship.

At the final hearing, the judge will decide if you should be awarded what you are asking for in your Petition. If there is anyone that disagrees with what you are asking for (including the Ward), you must be prepared to present witnesses and evidence to show why you should get what you are asking for.

If you are appointed as a Guardian and/or a Conservator, you will have reports you will need to file from time to time. The Court will give you forms to fill out for your reports. If you do not file these reports when required, you could be removed from your position.

If you have any questions, you should consult an attorney to help you.


