



2017 A2 & A3 ARCHERY DEER SEASON PERMIT APPLICATION

APPLICATION INFORMATION

- Applications will be accepted as soon as they are available. Please assist us by applying early.
- You must use an official 2017 Deer Season Permit application form. Previous year's application forms will not be considered.
- All information must be filled in completely and legibly. Incomplete or illegible applications will not be considered.
- Application deadline is July 21, 2017.

PERMIT INFORMATION

- Permit package includes: 1 doe tag, 1 either sex tag and cabin rental.
*Note: Opting out of staying in cabins does not affect total permit price.
- Permits are available on a first-come, first-served basis. 14 permits will be available per season.
- Priority is given to groups of 2-4 people.
- Permit is good for hunting in both Zones 1 & 2 (see attached maps).

ARCHERY SEASON DATES

- **1st Season** – September 2, 2017 – September 10, 2017
- **2nd Season** – September 16, 2017 – September 24, 2017
- **3rd Season** – September 30, 2017 – October 8, 2017
- **4th Season** – October 14, 2017 – October 22, 2017
- **5th Season** – October 28, 2017 – November 5, 2017
- **6th Season** – November 6, 2017 – November 14, 2017
- **7th Season** – November 15, 2017 – November 23, 2017

CLASSIFICATIONS

- **A2** – Non-tribal member.
- **A3** – Member of another federally recognized tribe.
*A3 applicants must submit a copy of their valid tribal enrollment identification card along with their application.

FEES

- **Security deposit fee** - \$200.00
*This fee is non-refundable and secures your permit for the 2017 Archery Deer Season.
- **Permit fee** - \$1000.00
- *\$100.00 discount for A3 applicants. Security deposit can be deducted from permit fee, once paid in full. (ex. \$1000.00 - \$200.00 = \$800.00 due)
- **Habitat Stamp fee** - \$20.00
*2017 Winnebago Wildlife & Parks Habitat Stamp fee is required for all deer, turkey, small game and upland bird permits. Only one Habitat Stamp is necessary for all hunting during the 2017 season.
- **Payment must be in the form of a money order or certified check. We do not accept cash or personal checks.**

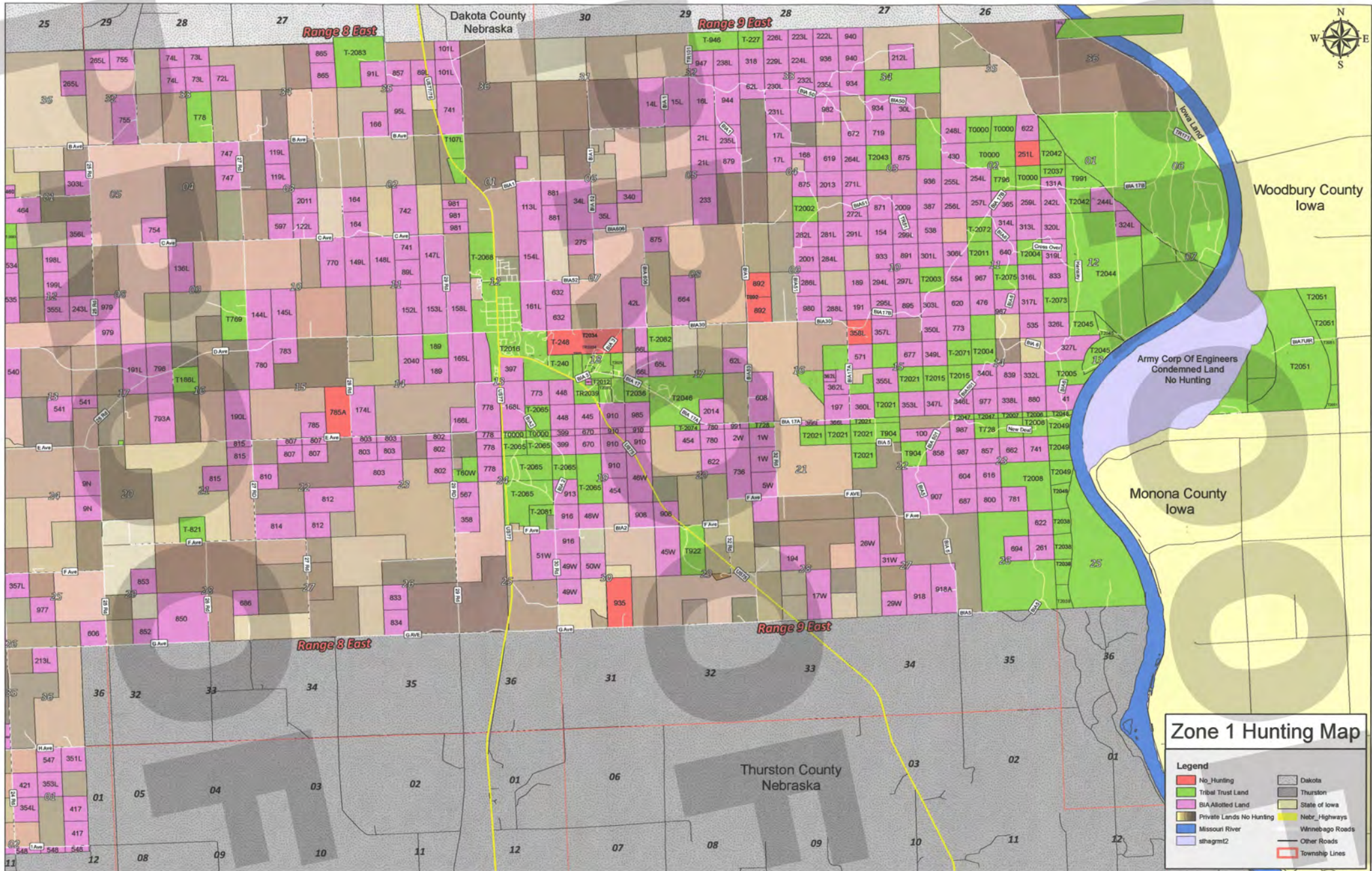

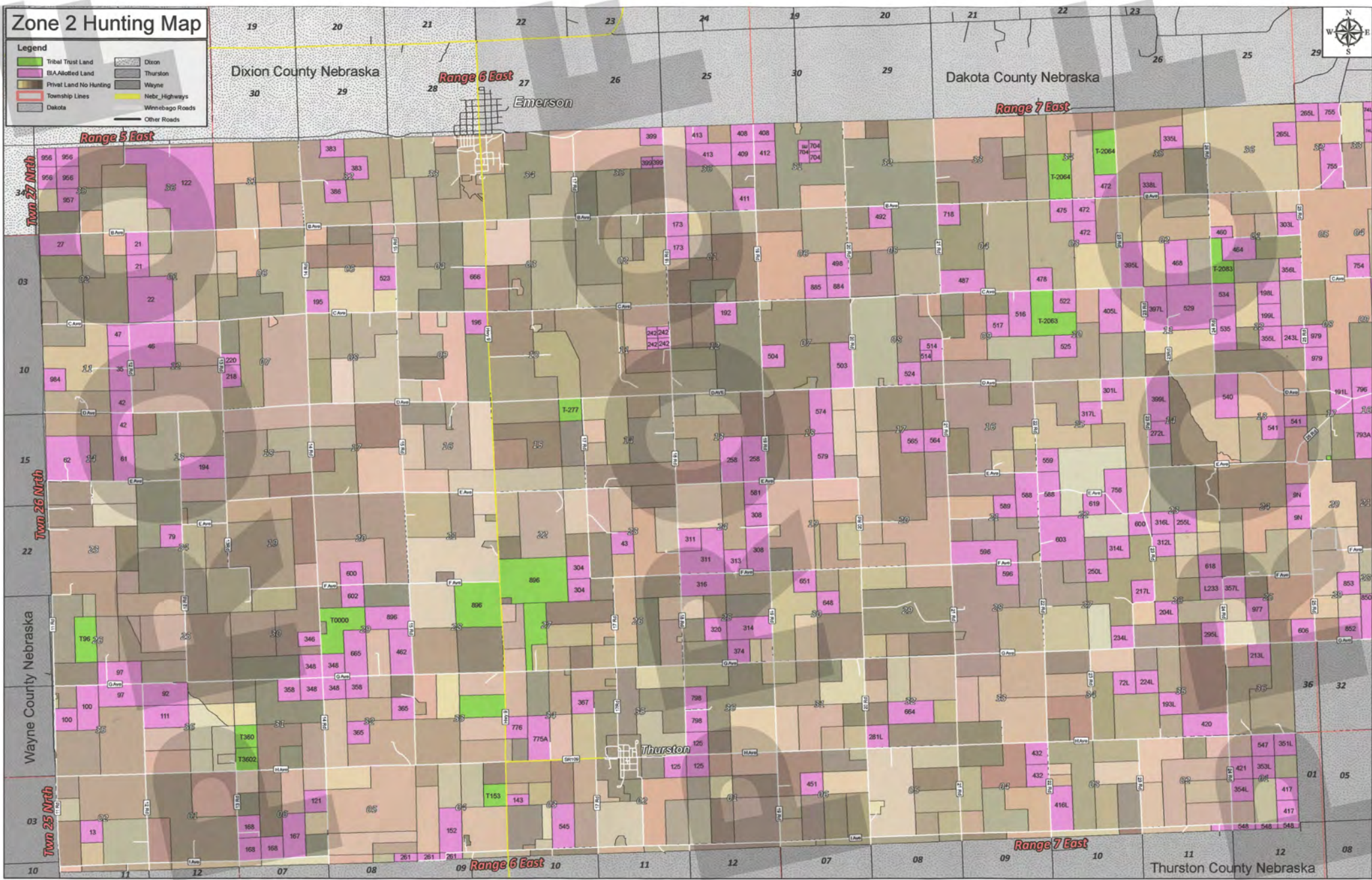
