



2017 FALL TURKEY SEASON PERMIT APPLICATION

APPLICATION INFORMATION

- Applications will be accepted as soon as they are available.
- Permits will be on a first-come, first-served basis.
- You must use an official 2017 Fall Turkey Season Permit application form. Previous year's application forms will not be considered.
- All information must be filled in completely and legibly. Incomplete or illegible applications will not be considered.
- Once your application and full payment are processed, you will receive confirmation via your personal method of choice. Permits can be picked up in person at the WL&P Dept. office as early as 1 day before the season begins. Please bring your I.D. You must pick up and sign for your own permit.

SEASON DATES

- **Archery** – September 4, 2017 – September 29, 2017
- **Shotgun** – October 2, 2017 – October 27, 2017

BAG LIMIT

- 2 turkeys of either sex (toms and/or hens preferred). Additional turkey tags can be purchased at \$50.00 per tag.

FEES

- A \$25.00 application fee is required to process your application.
- Permit fees: Archery - \$75.00
Shotgun - \$75.00
- A \$20.00 2017 Winnebago Wildlife & Parks Habitat Stamp fee is required for all deer, turkey, small game and upland bird permits. Only one Habitat Stamp is necessary for all hunting during the 2017 season.
- Please include these fees along with the price of the permit.
- Payment must be in the form of a money order or certified check. We do not accept cash or personal checks.
