APPLICATION INFORMATION

- Applications will be accepted as soon as they are available. Please assist us by applying early.
- Permits will be on a first-come, first-served basis.
- **Applications and full payment must be received by the close of business on March 12, 2018 for the 1st Season and April 9, 2018.**
- You must use an official 2018 Spring Turkey Season Permit application form. Previous year's application forms will not be considered.
- **All information must be filled in completely and legibly. Incomplete or illegible applications will not be considered.**
- Once your application and full payment are received/processed, you will receive confirmation via your personal method of choice.
- Permits can be picked up at the WL&P office as early as 1 day before the season begins. Please bring a valid form of I.D. You must pick up and sign for your own permit.

SEASON DATES

- **1st Season Spring Turkey:** March 17, 2018 – April 6, 2018
- **2nd Season Spring Turkey:** April 14, 2018 – May 4, 2018

FEES

- Permit fees: 1st Season - \$200.00
2nd Season - \$200.00
- A \$25.00 application fee is required to process your application.
- A \$20.00 2018 Winnebago Wildlife & Parks Habitat Stamp fee is required for all deer, turkey, small game and upland bird permits. Only one Habitat Stamp is necessary for all hunting during the 2018 season.
- **Please include these fees along with the price of the permit.**
- **Payment must be in the form of a money order or certified check. We do not accept cash or personal checks.**
- All payments received by the Winnebago Wildlife & Parks Department are non-refundable.


