
WINNEBAGO TRIBE COMMUNICATIONS HOSTS WINNEBAGO TRIBE WEBSITE LAUNCH PARTY

WINNEBAGO, NE – The Winnebago Tribe of Nebraska's (WTN) official website has recently received an all new face-lift and rebrand. On Wednesday, April 5th, 2023 the WTN Communications Dept. hosted a launch party for the community to share in a small meal, while hearing words from Tribal Council and the WTN Webmaster.

Guests were greeted by Communications Officer Garan Coons, while tribal council member Isaac Smith offered a word of prayer over the meal. "The guy at the time was Frank Hensley, who was maintaining it (website) at the time. He was looking at a different position. He wanted me to fill that spot, so he trained me on basic coding and different stuff, then basically said here you go."

Handing over the reigns she now got her first experience in web design. "I was out at Winnavegas for eight years, during that time I was able to switch it twice (management system). I was able to learn all that, then of course technology is always changing. It was a lot different at that time." improve on. Parker shared "right now I have the calendar on the tribal council page that's not lining up. In order for me not to do all the code work, I'm having them help fix it."

The website went under construction in October. "I felt like I had a fire under my feet the whole time." (Editors note: working in the same office, Christina worked constantly on the website, and also ensuring tribal council meetings were livestreamed I personally seen the work that was put into her work day. I'm not sure if she ever took a break lol.)

The website will be maintained consistently, and there is more work to be done. Parker shared "once I get everything where it needs to be, it's still going to get busy. I got to update the calendars all the time. The WIN page will need to be updated a lot."

On the main page of the website, the Upcoming Events section will showcase all events coming up. April 20th, from 9am – 11am will be the Breakfast with Council. Hosted at Whirling Thunder Wellness Center gymnasium. On May 2nd to May 4th, is the 2023 Spring Community Clean up. You can also click the "view calendar" link to view other upcoming events. THE BIG VOICE RADIO LAUNCHES YOUTH BASED RADIO SHOW Written by: Jordana R. Bass

WINNEBAGO, NE - The Big Voice radio station has recently added a ton of new shows to the line up for their listening and viewing audiences.

One in particular is a youth hosted show called Baby Bison Beats, that is hosted by Winnebago youth and Ho-Chunk Inc. apprentices Marlin Mousseau III and Morgan Earth. Who are currently placed within the Winnebago Tribe of Nebraska's (WTN) Communications Dept. Both have previously been placed with the Communications through the Summer Youth Employment Program (SYEP) and HCI Apprenticeship.

They are being mentored by Bethani Redhorn who is the WTN Communications Office Manager and host of All Request Live, as well as Jordana Bass who is the Editor of the Winnebago Indian News.

At the beginning of their apprenticeship's, they learned about branding and logo development, where they then designed their own logo for their radio show and creating their own promo graphics. Now having moved into the radio station where they now host and DJ their show for Baby Bison Beats, also gaining experience in working with the radio equipment and postproduction sound editing.

Bass expressed to the boys in a recent interview "you guys are learning things that I learned even after graduating from college. So if there any times of struggling with a task, don't feel bad cause you guys are learning advanced work."

Mousseau III expressed "it's a lot of multitasking and you have to check a lot of things and making sure everything is ready."

This isn't the first time Earth has co-hosted in the studio. He's also been with the department through SYEP, but expressed "I got more comfortable speaking outward, I'm thinking more forward and fluent, rather than up and rushed."

Baby Bison Beats have also invited guests to their show. With multiple other students apart of the HCI Apprenticeship program, and they are invited on the show to share their experiences as well, to give more of a voice to the youth of Winnebago.

Isaiah Walker (Winnebago) is the son of Esther Mercer & James Armell. He is the grandson of Eraine Mercer. His is placed at the IT Department of the WTN, under supervision of Brandon Stout.

He expressed on a recent interview

on Baby Bison Beats, "I've been wanting to go into IT for a really longtime, and it's been really good so far. I'm really finding a passion for it."

Walker learned how to make patch wires. "they're ethernet cables that are hooked up to all of your stuff." He expressed. Also assisting in setting up printers, and fixing PC computers. He adds "just all sorts of stuff that any normal IT person would do."

"The only challenging part is the down time honestly. I'm more of a work and just work, work, kind of person." Walker seems to be a good student, also adding he makes sure to get his homework done at school so he has free time after classes.

Each Friday the students are out of their worksites and are taught through the HCI apprenticeship program different "real world" lessons. He finishes off the interview to say "I learned a lot about proper job etiquette, and how to dress."

The purpose of Baby Bison Beats is to allow the youth to share their music. Stay tuned for updates in future WIN issues, as we will continue to invite other youth to **Baby Bison Beats!**







ATTENTION ALL WINNEBAGO MEDICAID MEMBERS

The continuous coverage requirement, which has allowed waiver participants to keep both waiver and Medicaid coverage even if they were no longer eligible, will expire on March 31, 2023. This means that starting March 1, 2023, the Division of Developmental Disabilities and the Division of Medicaid and Long-Term Care will resume regular reviews of Medicaid eligibility, and state Medicaid programs can begin disenrolling ineligible individuals by April 1, 2023. It is crucial that members update their contact information with Nebraska Medicaid and check their mail regularly to avoid unnecessary loss of Medicaid or Waiver coverage.

If you have questions about your coverage. TCUH Patient Benefit Coordinator, Glenda Bruggeman, is available Mon-Fri, 8AM-4:30PM in person or by phone at 402-878-3570. In addition, A NE Medicaid Representative, Liliana Flores, is available at TCUH to assist you in completing a Medicaid Application as well as answer any questions that you may have. She is here on the 1st and 3rd Thursday of every month from 9AM to 4:30PM on the 2nd Floor across from medical records. 

Mother Earth Day

Earth Day is once again quickly approaching, and April 22nd will be upon us without notice or regard for our busy schedules. So decided to take a few moments to remind us all to celebrate the planet upon which we live on this very special day. But first comes the science lesson.

Mother Earth is about 4.5 billion years old supporting about 8 billion people. She is the third planet from the sun, the fifth largest planet in our solar system and has one moon. The planet is made up of three different layers: the crust, the mantle, and the core. The crust is the outside layer or surface that we live on. 

Media Guidelines for Suicide Reporting

Great care should be given to the way in which suicides are reported in the media. Improper reporting techniques can lead to suicide contagion (copycat suicides).

One of the best examples of suicide contagion was that of the Vienna train suicides of the 1980s. For about four years, from 1984 to 1987, several individuals died by suicide by running or jumping in front of oncoming trains. The media coverage of each suicide was sensational and extensive, and caused numerous "copycat" suicides.

Finally, in 1987, a campaign was launched to alter the way the media reported the suicides. The result of the campaign was dramatic suicides and attempted suicides dropped by over 80% after only six months.

Thus, the way suicides are reported in the media can either CAUSE suicides or PREVENT suicide

Minimize coverage of suicides. Keep the stories relatively brief and do not run too many stories. But it is important to run stories!

ALWAYS provide suicide prevention information with suicide stories. This is CRITICAL.

So a statement like the following can SAVE LIVES:

Anyone who is suicidal may receive immediate help by calling 1-800-SUICIDE. Suicide is preventable, and if you are feeling suicidal, you must get help.

Do not hesitate to talk about suicide in stories.

There is a strong stigma associated with suicide, so it MUST be talked about. Sensitive articles about suicide can help REDUCE this stigma; but please be EXTREMELY careful about how you talk about it and how you cover stories about suicide.

- Do not begin a television newscast with a suicide story.
- Do not place suicide stories on the cover of newspapers or magazines.
- Do not sensationalize suicides.
- Do not romanticize suicides.
- Never portray suicides as heroic.
- Never say that a suicide "ended pain" or "ended suffering." Suicide CAUSES excruciating pain for suicide survivors.
- Also, people need to be alive to feel relief from pain. Suicide CAUSES pain.
- Be careful about describing the methods used. Do not go into great detail about the methods, and do not show detailed pictures of the locations where the suicides occurred.
- Do not say suicides occur because of one event. (Suicides rarely occur because of one event.)
- Be careful with the wordings of headlines.
- Be careful with all of the words that are used in the story.

It's hard to walk into a forest without bluejays instantly sharing news of your supposed trespass. They have sharp eyes and a sharp raucous voice. The Winnebago name for bluejay is Jejec (jay-jaych). This trickster is the symbolic storyteller of the Winnebago people. Some of their stories may not be so nice. This piece was inspired by the bluejays visiting our bird feeder right outside our kitchen window. I took this photo in February 2022 when it was very cold and the jay's feathers were full. The Winnebago Indian News (WIN) had recently published a story about the bluejay, and I was able to bring it to life." Emily Smith, Maaxi ska pj, from the Thunder Clan. I am from Winnebago, Ne and I am the new Community Outreach Coordinator for HoChunk Renaissance. My mom is Cheryl Smith, and my grandparents are Waukon and Emily Smith. I graduated from Winnebago High School and continued to Little Priest Tribal College. received my associate's degree and went on to Wayne State College. I have seven children ranging from 27 years to 11 years. I worked a variety of jobs in my past, but the best one was the Museum/Repatriation job. I started as a VISTA worker and become a full-time tribal employee in 2001. I worked with my uncle, David Lee Smith. We traveled to Illinois, Wisconsin, and Iowa to do a lot of repatriations for the Winnebago Tribe. I learned a lot while working with him and traveled to participate in a lot of meetings and burials. After he retired, I then became the Museum and Repatriation Director. I left the tribe in 2015 when I moved to Lincoln, Ne. I worked at the Crete Carrier Trucking in Billing Department for a few years, I worked part time with the Nebraska Regional Center, which is the State of NE Mental Hospital and lastly, I worked for six years at Kawasaki in the Shipping Receiving Department. I learned how to drive a forklift and I was assigned to load and unload trailers every night. I also learned how to drive other machines that we operated in the warehouse. I moved back to Sioux City in November 2022, I am glad to be back with the Winnebago Tribe of Nebraska and working with the Language. I am hoping that I can learn more and help with different projects for our community.

Lori Pearson (Woman that Walks at Night – Bear Clan) is a member of the Winnebago tribe, and a resident of Minnesota. She is the daughter of Sharon Armell Lynch and Lowell Lynch. She is the granddaughter of Alberta Rave and Lawrence Armell Sr.

She is a self-taught artist with a focus on embroidering Native designs. She is also a photographer and much of her photographs inspired her to translate Winnebago women's applique patterns to embroidery. She finds inspiration from her family, her tribe, and the land. She designs her patterns with an intentional focus on reciprocity and challenging traditional paradigms in both embroidery and Native symbolism. Each piece has been embroidered by hand.

Pearson shared "My art is inspired by the mirrored applique dress designs crafted by the women of the Winnebago Tribe. In 2019, after retiring from a 35-year corporate career in Minneapolis, MN, I started drawing and hand embroidering patterns taken from my pow wow


By engaging board members with diverse backgrounds and expertise, the Foundation is better positioned to address the complex health challenges facing our community today.

Self-care is a fluid concept, meaning that it looks different from person to person. Some people might see self-care as eating ice cream while watching Netflix, taking a bubble bath, lighting a scented candle, or going out for a jog ("Indigenizing Your,"n.d.).

WHAT IS INVOLVED WITH SELF-CARE?

Making healthy lifestyle choices Being physically active and eating healthily.

Avoiding unhealthy lifestyle habits Avoiding smoking and excessive alcohol consumption.

Self-recognition of symptoms Assessing and addressing symptoms, in partnership with a healthcare professional where necessary.

Self-monitoring

Checking for signs of deterioration or improvement.

Self-management

Managing symptoms of disease, either alone, in partnership with healthcare professionals, or alongside other people with the same health condition.

Plant Medicine

The act of harvesting, grinding and creating traditional medicines made from plants is a great way to get the body moving and to spend some time outdoors. Different berries, flowers, trees, and other plants have a variety of soothing properties.

Traditional Dance

Traditional dance gatherings are typically held for celebrations, but that doesn't mean practicing is off the table. Practicing traditional dance is a great way to get the body moving while learning the moves, stories and language of the community.
