



WINNEBAGO, NE - The Winnebago High School basketball team has recently begun its season, and both the varsity girls and boys have continued to run, gun and move that ball around. The season has only just begun. head coaches Marquel Harlan and Treivan Bear are feeling optimistic about the 2022-2023 season. The WIN met with both coaches to discuss this year's team, and how they plan on improving. Bear shared what he loved about coaching, "I just wanted to give back. Be a mentor, a good male role model, father figure type thing to the boys. WINNEBAGO PUBLIC SCHOOL INTRODUCES HOPE SQUAD

WINNEBAGO, NE – A new program has been introduced at the Winnebago Public School, one that is inclusive to all students. The HOPE Squad is a student nominated and peer to peer program. Giving tips to members on how to recognize and give guidance to students who may struggle with mental health issues.

Hope Squad began in Utah back in 1999, amid growing concerns over suicides in the district of High School principal Dr. Greg Hudnall. Who has made it his mission to prevent youth suicide. He organized the Hope Task Force, crating the Circles of Hope model. Circles for hope bring together schools, communities, mental health agencies. Dr. Hudnall's team learned that most young people wo die by suicide give a warning sign or told a friend of their struggles. But the majority of those friends never told an adult. In 2004, the team started a pilot program, a Hope Squad was to train students to identify struggling peers and refer them to adults.

The Youth Crisis Intervention Center's, Prevention Specialist Donna Wolff took the lead on introducing the program to WPS. She is a member of the Isanti Sioux Tribe, and works under the Garrett Lee Smith grant, which is all about suicide prevention. She shared "after losing my own son to suicide March 1st in 2009, I've just really gotten the education and training

and all those prevention education pieces." The program was started through ARPA funds. The process was long, she added "you have to make sure your administration is on board. You have to be partnered with a mental health agency. We've partnered with Morningstar Counseling."

The current school counselor, Lori Tremayne has been at WPS for 25 years, where she has been an elementary school teacher, elementary counselor, and 7-12 principal. She also assists with the Hope Squad. She shared



WINNEBAGO, NE - Robotics is a class such as any other, but with a few more steps to it. Instead of reading and studying to earn a decent grade, you're put to the test with how much you participate and learn. It may sound intimidating or discouraging, but it's truly anything but. Robotics takes creativity, learning, and real world experience further than any other normal class. From building a robot with screws and nuts to socializing and communicating with other teams to driving it and scoring points in a competitive environment, it gets pretty diverse. Seeing that it's only been a part of WPS for 5 years, it's still pretty new. This class is currently taught by Samantha Eberly, a high school science teacher at WPS. This year, out of the entirety of high school students, only 4 are robotics participants. Hopefully with this article, that will change.

The most recent competition for robotics as I'm writing this was November 19th, on the weekend. This competition was held pretty close, being that it was in Sioux City. Typically, the competitions are held on weekends, and partake in towns nearby. The first competition was enough to make state. I have no a few weeks ago, and was only idea what to expect from state, so an hour away in Orange City, IA. As for the amount of teams

participating, in our league there are about 22. Not all teams show up to each competition, so it's around 10 teams or lower at each competition. Overall, so far my team ranks 8th out of the 22. Our robot so far can drive and push cones functionally, but we need it to be able to pick them up and drop them on poles. We're working on a claw, the programming and building process is difficult but also very fun. My favorite part of the competition was the socialization aspect and competitive nature. Trying hard to perform well and communicate fast and efficiently puts a whole new outlook on robotics. The main challenge was dealing with stress, and also forming a plan and thinking about what you'll do once the timer begins. For the most part, it's great and was an extremely fun experience.

Ultimately, I think robotics is a great experience and it needs more participants. There are currently only 4, and for this upcoming semester, I hope other people have taken a liking to the idea of robotics and decide to join. The thing I look forward to most in the future of robotics is doing well that'll be a whole new experience for me.

"Mr. Fehringer brought the idea back to me as the school counselor."


Currently there are fourteen Hope Squad members. The program is about youth talking to youth. A nomination list was sent out to the students on who they thought were good listeners, who they could talk to, and who were concerned about others. Based off that nomination form, the students that were nominated were from a variety of different student groups. She added "it's so that everybody was represented. We brought those students in for just an introduction meeting. If they were interested, then we invited the parents. Because sometimes there could be heavy topics. Once the parents attended and signed the permission slip saying, yes, my child can be a Hope Squad member." During the initial meetings, students are trained on four core topics, and QPR training (question, persuade, refer). Those include, selfcare, inclusivity/adversity, suicide prevention, and resilience. Wolff shared "being native myself, I know the rates of suicide deaths within our community. I know that the depression and mental health status within our community is so high because of the stigma and taboo of the topic. People just don't want to reach out for help. This is just another tool that we can use to let people know, you know what? If you're not doing okay, it's okay to reach out, it's okay to talk to somebody." Some of the other topics that were taught were lessons on empathy. Tremayne shared, "they learned to be aware of themselves and be able to regulate themselves and know their emotions before they can help others with their emotions. It was pretty eye opening for them. I really got into empathy because we always just think empathy is putting ourselves in somebody else's shoes. But there is much more to that. They can help others, but they need to help themselves first."

how are you guys? What do you need? We're just checking in for their mental wellbeing and making sure they're okay."

Raising awareness to the topic of suicide prevention can reduce the number of attempts and offering the youth the tools to assist in prevention is a great program to have at WPS. As the program grows, more students are encouraged to take part. Wolff shared "we say in indian country that you are worthy. The Creator brought you here for a reason and you are worthy whether you are a seventh grader, twelfth grader, somebody sees something within you that's so valuable and worthy that you can help others. That is apart of our culture, is making sure that we reach out and help other people. We're meant to be a community; we're meant to help each other." If you or someone you know is struggling with mental health issues reach out to the Suicide Prevention Lifeline (1.800.273.8255), or dial 988 and get immediate help. Or text the 24/7 text line, with any word to 741741 for immediate help.

trained as QPR gatekeepers. QPR is an integral part of the Hope Squad curriculum. It provides students the simple steps to reach out to struggling peers and refer them to trusted adults.

QPR Institute provides online and in-person training for individuals, organizations, professionals, and veterans. The 90-minute QPR Gatekeeper Training for Suicide Prevention program teaches people how to recognize suicide warning signs, ask about suicide, and persuade people to accept professional help. As a universal intervention for troubled youth and others, QPR has been taught to more than two million people worldwide.



taught me a lot. You can teach a lot of life lessons through sports."

The impact a coach can have on their student can last years, coming full circle as a student athlete to coach. Harlan shared "I start thinking of all my coaches that impacted me, and it was Rose Springer, she was a coach at Whirling Thunder and Quince was even one of my coaches. He used to let me play with the boy's team because there wasn't a girls' team. So that was one of my very first memories where we were sprinting on those lines on the old grey court. There was also Terry Medina and Scott Aldrich. In high school it was Janelle Decora. They believed in what I could do as a player and as a person. So that really helped me. It brings it back to being circle because I know these girls that I'm coaching outside of school, and I want what's best for them. It's not about winning or losing, but the lessons you learn here."

6. Substance Abuse Prevention.

Hope Squad members understand the complexity of substance abuse, encourage peers to make healthy choices, and persuade struggling peers to get help.

BIDEN-HARRIS ADMINISTRATION ANNOUNCES \$266K GRANT TO WINNEBAGO TRIBE OF NEBRASKA FOR AIR MONITORING PROJECT

LENEXA, KAN. (DEC. 5, 2022) – The U.S. Environmental Protection Agency (EPA) has selected the Winnebago Tribe of Nebraska to receive \$266,064 for a community air pollution monitoring project.

This grant is among 132 air monitoring projects in 37 states that will receive \$53.4 million from President Biden's Inflation Reduction Act and American Rescue Plan to enhance air quality monitoring in communities across the United States. The projects are focused on communities that are underserved, historically marginalized, and overburdened by pollution, supporting President Biden's Justice40 Initiative.

The Winnebago Tribe of Nebraska will use the grant money to improve the Tribe's capacity to fully address air quality by installing equipment to monitor meteorological conditions and air pollution at various locations throughout the Winnebago Tribal Nation. The Tribe will also use the data collected from the air monitoring equipment to update emission inventories to better understand ambient air quality issues within the boundaries of the Tribal Nation.

"Funding for this air monitoring project for the Winnebago Tribe of Nebraska will give the Winnebago people the data they need to monitor their local air quality and make the improvements needed to reduce air pollution in and around their communities," said EPA Region 7 Administrator Meg McCollister. "Investing in communities such as the Winnebago Tribe of Nebraska demonstrates the Biden-Harris administration's commitment to addressing pollution in disproportionately impacted communities across our region."

The air pollution monitoring projects are made possible by over \$30 million in Inflation Reduction Act funds, which supplemented \$20 million from the American Rescue Plan and enabled EPA to support 77 additional projects, more than twice the number of projects initially selected for funding.

These grant selections further the goals of President Biden's Justice40 Initiative and Executive Order, "Tackling the Climate Crisis at Home and Abroad," which directed that 40% of the overall benefits of certain federal investments flow to overburdened communities that face disproportionately high and adverse health and environmental impacts.

EPA will start the process of awarding the funding by the end of 2022, once the grant applicants have met all legal and administrative requirements. Grantees will have three years to spend the funds from the time EPA awards the grants.

Background

In spring 2021, Congress passed the American Rescue Plan, providing EPA with a one-time supplemental appropriation of \$100 million to address health outcome disparities from pollution and the COVID-19 pandemic. Half of that \$100 million was dedicated to air quality monitoring. EPA Regions began awarding nearly \$22.5 million from this appropriation in 2022 as direct awards to state, tribal, and local air agencies for continuous monitoring of fine particles and other common pollutants.

In addition, EPA Regions are in the process of procuring monitoring equipment using \$5 million in American Rescue Plan funding to advance the EPA Regional Offices' mobile air monitoring capacity and establish air sensor loan programs. These investments will improve EPA's ability to support communities that need short-term monitoring and air quality information.

In July 2021, EPA announced the \$20 million American Rescue Plan Enhanced Air Quality Monitoring for Communities grant competition. The goal of this competition was to improve air quality monitoring in and near underserved communities across the United States; support community efforts to monitor their own air quality; and promote air quality monitoring partnerships between communities and tribal, state, and local governments. EPA received over 200 applications in response to the competition.

The Inflation Reduction Act of 2022 provides funding to EPA to deploy, integrate, support, and maintain fenceline air monitoring, screening air monitoring, national air toxics trend stations, and other air toxics and community monitoring. Specifically, the Inflation Reduction Act provides funding for grants and other activities under sections 103 and 105 of the Clean Air Act. EPA is using approximately \$32.3 million of this funding to select 77 high-scoring community monitoring applications.

Hōcąk & Umo ho History Continued

On Thursday morning, December 22nd, from 8 until noon - you are invited to Family Foundations held at the Winnebago Public School. We will open with prayer in the large gym at 8 a.m. There will be three break out sessions with nine or more topics to choose from. Also provided are: resources, food, gas cards and prizes. The prizes are for the adults who attend three sessions. Children are welcome to attend and childcare will also be provided.

I was asked to make a presentation. My presentation will cover two areas: during the first half I will attempt to answer the question 'How can we help children who have experienced bad things?" The second half will focus on 'Caring for the Caregiver.'

My first half will cover: when a child experiences bad things his/her body keeps the score; his/her behavior is affected as well as his/her emotions. I will put forward five suggestions on how to help children. Other areas that I will discuss are: help especially for teenagers, teachers and school administrators.


The second half will attempt to answer: 'how can I know if I am overloaded or have secondary trauma? Secondary trauma will be defined. I will also discuss why it is difficult to be a caregiver. And then I give some suggestions on how caregivers can take care of themselves.

Handouts to all those who attend and other helpful resources will be available at the Jesus Our Savior Lutheran Outreach - Church and Preschool table.

In 2023, I am willing to offer a more in-depth interactive healing workshop based on the Trauma Healing Institute resource of 'Healing the Wounds of Trauma.' This resource provides a strong foundation for restored lives and relationships.



Before the creation of the modern Hocak reservation in Nebraska, the "legal" Hocak reservation was in Crow Creek, South Dakota. The Hocak were forcefully exiled to Crow Creek after being blamed for the Dakota War of 1862. The Tribe greatly suffered at Crow Creek, becoming sick and starving as a result of government corruption and mismanagement. Shortly after the arrival of the Hocak in Crow Creek, efforts were made to travel down the Missouri River to meet with the Umoⁿhoⁿ so that the Hocak could leave Crow Creek in search of a better home. After making contact with the Umoⁿhoⁿ an agreement was made between the two Tribes and hundreds of Hocak traveled down the Missouri to Umoⁿhoⁿ land. Fed and supported by Umoⁿhoⁿ funds, the Hōcąk would help to serve as a buffer between the Umoⁿhoⁿ and other hostile tribes. A permanent solution to the issue of Hocak and Umonhon land was found in 1866 with the ratification of two treaties. In the first, the Umoⁿhoⁿ ceded the land which would become the basis of the modern Hocąk reservation to the U.S. government. In the second treaty the Hocak purchased the ceded Umoⁿhoⁿ land from the government creating the Hocak reservation here in Nebraska.



All the nine Winnebago were there (Red Wood) Oko-ni-kah or Little Chief was there— Waschasta—Etappe[?] Chestna—Ha—Kak Ky— Wa = ze = kah—fired at whites. I saw them with my eyes. . . . HunKah, the brother of Hah-ya-Ka-Kay—[Sen-che-wau-cho-kah], the son of Ho me no kah, a chief, a big fat fellow . . . were at the first outbreak at Red Wood. Two were killed at New Ulm. I saw three of them fire at whites and I heard the rest did. . . . [Also] Wedu-kon-ni-kah and Kay-nuk-kah [and a man from] Ke-na-hut-e-kah's band.⁹³

Merging O-ton-ka-ton-ka's testimony with Blackhawk's list, local histories, historian's notes, newspaper reports, and Winnebago tribal records, however, eleven to thirteen Ho-Chunk individuals emerge, more or less, as Sibley's prisoners:

REMEMBERING THE DAKOTA 38+2

Here is some history found regarding the Dakota 38+2 and the memorial ride schedule. This is important to us as a Tribe and people because we were close with the Dakota in the area and were forced out of Minnesota after the largest mass hanging in United States history, approved by the then President, Abraham Lincoln. The museum will be sharing information regarding this and its importance not just in our history, but the reason we want to stand by our Dakota relatives side during these memorials.

Our history, tribal nations throughout the country, have a shared history and trauma we have to face. We can only overcome this through truth sharing and learning. That is what we as a museum want to help our tribal citizens with. Learning our history and healing. Pinagigi to Franky Jackson and Jim Hallum who has been helping the museum with finding our tribes history in this traumatic event in our tribe's and ancestor's history.

We are still here.

Four of these suspects were clearly related to the Dakota through wives and mothers. As already mentioned, Big Winnebago was married to a Dakota woman, but his mother was also Dakota. Little Priest's brother, Grey Wolf, was married to Big Winnebago's half-sister, Lone Woman.⁹⁹ Maznopinka's statement to Edgerton revealed his family tie to Shining Horn (or Haytashashaka), also married to a Dakota woman.¹⁰⁰ Shining Horn was also Winneshiek's brother-in-law, according to Blackhawk, linking Winneshiek's brother, Hounka, to the Dakota.¹⁰¹ In addition, Big Eagle may have been the father of one of Lasallier's nephews.¹⁰²

A few of the suspects can be identified in terms of their clan, which also dictated obligations of "reciprocity." For example, Little Priest and Maznopinka both belonged to the bear clan, whose role in Winnebago society included "regulation of the hunt, broad disciplinary powers, and carrying into effect the orders of the Thunderbird clan chief," which at this time was Winneshiek.¹⁰³
