Winnebago, NE – The Winnebago Comprehensive Healthcare System (WCHS) celebrated it's 5-year Anniversary with a short program and reception on Wednesday, July 26th, 2023, in Winnebago, NE. This community event featured speakers, notable guests, and the announcement of Twelve Clans Unity Hospital's Center for Medicare and Medicaid Services (CMS) Certification.

The event began with short video highlighting the organization's past five years. Prior to the Winnebago Tribe of Nebraska's assumption of the hospital, it was run by Indian Health Services (IHS). In July of 2015, the Omaha-Winnebago IHS Hospital's CMS certification was revoked as the care being provided by the hospital was deemed inadequate. The Winnebago Tribe, who had been managing and growing the Public Health Department for more than 30 years, was forced to take immediate action for the health and safety of the Winnebago people. They were quick to act, exercising their right to self-governance. In July of 2018, WCHS was established as an organization that supported both the Winnebago Public Health Department and Twelve Clans Unity Hospital.

The keynote address from this past week's event was from former WCHS CEO, now Big Fire Law Partner, Danelle Smith, and centered on the importance of self-governance. "The journey of WCHS has been one of hard work, determination, and commitment of the Winnebago people to make a better life for ourselves." Since 2018, they have been working to establish

infrastructure and services with the mission of creating and maintaining the health of the Winnebago community.

"For the past 5 years, we have focused on preparation and transparency for this moment," WCHS CEO David Edwards. Next, attendees were further delighted to learn about WCHS collective achievements from board members and executive leadership, including the official announcement of their forthcoming CMS Certification. Edwards went on to explain "We have worked to ensure everything we do - from organizational structure, to policies, to care culture - is centered on our patient experience and

compliant with CMS's standards. A site visit without notes is pretty unique and very unusual for a first-time organization being certified by CMS."

The program concluded with a complementary traditional meal of buffalo meat and other picnic fare to allow the community to celebrate with WCHS employees. "Congratulations to everyone at WCHS for achieving this impressive milestone in our organization," Edwards stated, and ended the program by offering his gratitude to "everyone in the communities we serve for entrusting us with your health. "

The Sacrifice of Chief Little Priest and the History of the Nebraska Territory

Winnebago, NE: Amid the Winnebago relocation in 1863, the Winnebago Indians were moved from their home in Minnesota to a barren reservation in Dakota Territory. Groups of Winnebago soon moved down the Missouri River to the Omaha Reservation in Nebraska. It was started in July of 1866 in honor of the Last War Chief that our tribe had. Little Priest, the son of Little Priest. He was born in 1829 at Lake Kosh Ronona, Wisconsin, and trained as a medicine man. At the age of fifteen, he was made war chief after his accomplishments against the Lake Superior Chippewas. To help his people, he fought against the German settlers during the 1863 Santee outbreak. When the Winnebago were shipped down the Mississippi and up the Missouri Rivers, he ordered John Omaha and Little Hog to fall off the boat and swim to Omaha at the Blackbird Bend and open negotiations with them about acquiring some land in the northern part of their territory. In 1863, the Lakota bands were making hit-and-run attacks all along the north and western border of Omaha Territory until they were forced south. The attacks became worse as months passed on. The Omaha agreed to sell the northern part of their land to the Winnebago in 1863. The Omaha chiefs signed an agreement with John Omaha and Little Hog and signed their agreement on a beaded wampum belt. Some of our old beadwork has the agreement, but these artifacts' location is currently unknown. Little Priest was finally wounded outside of Deer Creek Fort in Wyoming by a band of Oglala Lakota and some Northern Cheyenne warriors.

That was in April 1866. He was shot four times, one in the lung. He returned to the newly bought Winnebago Reservation and died on September 12, 1866. A year before, the Winnebago sold their Crow Creek Reservation to the United States Government, where they lost around 680

people.

They paid the Omaha \$50,000.000 for the northern part of their reserve to act as a buffer against the Lakota. This land is now the Winnebago Reservation.

The newly acquired reservation became an executive order reservation in 1865 and was signed into law in 1866. The same year that Chief Grey Wolf asked the council of fourteen village leaders to honor his brother with a celebration for his death in the Sioux Wars and to honor the surviving members of the Company A, Omaha Scouts of the Nebraska Volunteers. Robert Fumas signed his name to the paper authorizing the celebration of the Powwow.

In early 1865, about 75 members of the Winnebago Tribe enlisted in the Nebraska Volunteers. Known as Company "A" Omaha Scouts, the unit actively quelled the Indian uprising of 1865 and 1866. This army service exemplified the Winnebago's desire for peace and good relationships between the Indians and the white settlers.

In the summer of 1866, a homecoming festival was held upon the return of the Winnebago veterans. Shortly after that, Chief Little Priest died of wounds received in army service. An annual memorial celebration is held in remembrance of his sacrifice. The year after his death, Little Priest's service flag was raised to symbolize the tribe's allegiance to their country. This ceremony remains an important part of each celebration. Later the gatherings became known as the Annual Homecoming Celebration Powwow.

The history of the Homecoming celebration dates to September 1866, after the battle between a band of Oglala Lakota. Upon being separated from his group, Chief Little Priest fled from the Lakota warriors. After a hot pursuit, his horse was then shot out from underneath him. Standing between huge rocks, he defended himself and fought them for hours. He was then shot four times in different areas. One

is just above his right lung. Even then, Chief Little Priest managed to kill nine Lakota warriors, including their war chief. The Lakota claimed that he transformed himself into a grizzly bear.

After recovering, the HoChunk warriors brought him home to the Winnebago reservation, where he later died of his wounds on September 12, 1866. Chief Gray Wolf was the brother of Chief Little Priest. He had called a clan council down at Big Bear Hallow and proposed a celebration in honor of his death. They also honored all veterans of Company A, Omaha Scouts, and the Nebraska volunteers.

Today, honoring the Winnebago veterans through traditional song and dance continues 157 years later. So this is a fact that the Winnebago, Ho-Chunks do have the oldest Memorial Celebration. The Harvest Festival of the Omaha Nation is different. They have that celebration to honor the creator for a good harvest. We always had these; they were called Harvest Green Corn Dance. The earliest recorded Harvest Celebration for the Winnebago was in 1634 when Jean Nicollet visited us at Doty Island, Lake Winnebago, Wisconsin. These facts are all told in the Jesuit records.

The oldest Memorial Celebration in written records was our 1634 for our victory over the Potawatomie in the Algonquian Wars from 1620-1630. We are honoring our veterans. Also, in 1634, when Jean Nicollet visited, the whole tribe of 25-30,000 was together to celebrate our harvest dance and honor our veterans from the Beaver War in Canada during 1634. Last weekend we celebrated the 157th annual Homecoming celebration. Today we work to maintain and honor our tribal veterans and be consistently proud and respectful towards our modern-day warrior's society, the Winnebago veterans.



COMMUNITY NEWS

My Fellow Tribal Members,

Greetings to you all. I hope this finds you in good health and good spirit. Today there are some important matters that will be introduced that may cause healthy discussion amongst the membership. As always, it remains my intent to keep you informed on matters such so you may determine for yourselves the impact you wish to see within your life and of those you care for. Let's begin.

RESOLUTION 23-160

At the February 2023 General Counsel (GC) meeting, I introduced discussion regarding the implementation of a landmark act that would involve every tribal member, and our posterity. This action, which I titled "Reservation Reclamation Act" was proposed. I gave notice to the council and the attorneys that I would be forwarding language for a resolution to be passed that would assign responsibility and duty to all land use programs and entities of the Tribe. This duty essentially would be to take all actions necessary to reclaim all areas of our reservation home.

This Act will take generations to fulfill. But until we begin to seriously place effort behind the chatter, the dream to place all lands within the exterior boundaries of our reservation back within the hands of our membership, or the organization, we will never reach that goal.

While Chairing the General Counsel meeting held on June 21st, 2023, the Council passed resolution 23-160 effectuating the "Reservation Reclamation Act". The political will has been given. Now the effort to reclaim what is ours can begin to grow and step forward.

RESOLUTION 23-159

Also at the February 2023 GC Meeting I introduced discussion regarding taking actions that would create passable paved roads connecting the boundaries of our reservation. East to West, North to South, our people need to have safe passageways across our reservation home. This includes our lands in Iowa. I titled this action, "Reservation Crossroads Act".

This Act will create paved access roads or highways connecting the boundaries of our reservation so that our tribal members may access all areas of our reservation with greater safety, and greater ease. Naturally, this process will take significant resources that most likely will only be achieved through the effective partnerships created through our Congressional delegations, our State partnerships, and other local authorities. However, without the will to begin working on the plans needed to fulfill this intent, we will never get there, literally.

Also while Chairing the General Counsel meeting held on June 21st, 2023, the Council passed resolution 23-159 effectuating the "Reservation Crossroads Act". With this political will given, the plan may begin to take shape in any and every way necessary to connect our reservation so that our membership may access all areas

of our homeland, safely and conveniently. This includes connecting to our lands in lowa. Yes that means a bridge crossing the Missouri River.

RESOLUTION 23-158

The February 2023 GC meeting was a productive one and I also introduced discussion regarding widening the existing highway corridor North of Winnebago. I titled this action "Winnebago 75/77 North Highway Act". US Highways 75/77 North connects our town to South/Sioux City which is where most of our people go for shopping, food items, entertainment, and specialized healthcare, among other things. If anyone has ever been on this roadway during the rush times of the day, you know that the congestion is staggering and frustrating. It is also at times highly unsafe due to the amount of traffic that comes to town, or leaves it, namely during reconstruction

The intent of this Act is simple, work to advocate a plan to our Congressional delegation/partners for funds that will widen this roadway. As most of this highway lies north of our borders, connecting the widened road to the four-lane area just South of Dakota City, NE will take more effort that we realize. But it can be done. Look at the road between Blair, NE and North Omaha as an example.

Current NDOT figures place over 10,000 cars on this road every day. By widening the access way, we will ensure safer travel, increase convenience for our membership who use this road, and also provide for greater accessibility for our businesses and healthcare uses. In combination with the other acts, our home could become even more accessible for our people.

Chairing the General Counsel meeting held on June 21st, 2023, the Council passed resolution 23-158 effectuating the "Winnebago 75/77 North Highway Act". Our plan to determine the best way to widen the road includes ideas like the possibility of rerouting the path. This would mean the highways could bypass our town entirely, such as it does today near Wahoo, NE. By thinking about new ways to reach the goal, we make it easier to find ways to get there with the help of all those needed.

Conclusion

Thank you all for your kind attention on these matters. Leadership ought to work for the betterment of everyone, not just a select fortunate few. I hope the efforts I've pushed help achieve this goal. Recently another council member used the term, "the chosen". I identified with that statement because I see all too often how we do indeed cater far too often to those chosen few, while the vast majority goes without and our most vulnerable remain completely ignored. Perhaps one day this will change, who knows?

SUICIDE IN INDIAN COUNTRY PART 31

The time right after your suicide attempt can be the most confusing and emotional part of your entire life. In some ways, it may be even more difficult than the time preceding your attempt. Not only are you still facing the thoughts and feelings that led you to consider suicide, but now you may be struggling to figure out what to do since you survived.

It's likely that your decision to try to kill yourself didn't come out of the blue. It probably developed over time, perhaps from overwhelming feelings that seemed too much to bear. Experiencing these emotions might have been especially difficult if you had to deal with them alone. A variety of stressful situations can lead to suicidal feelings, including the loss of a loved one, relationship issues, financial difficulties, health problems, trauma, depression, or other mental health concerns. It's possible that you were experiencing some of these problems when you started to think about suicide.

While the events that lead to a suicide attempt can vary from person to person, a common theme that many suicide attempt survivors report is the need to feel relief. At desperate moment, when it feels like nothing else is working, suicide may seem like the only way to get relief from unbearable emotional pain.

Just as it took time for the pain that led to your suicide attempt to become unbearable, it may also take some time for it to subside. That's okay. The important thing is that you're still here; you're alive, which means you have time to find healthier and more effective ways to cope with your pain.

Right now, you're probably experiencing many conflicting emotions. You may be thinking:

- Why am I still here? I wish I were dead. I couldn't even do this right."
- [] "I don't know if I can get through this. I don't even have the energy to try."
- "I can't do this alone."

- "How do I tell anyone about this? What do I say to them? What will they think of me?"
- Maybe there is a reason I survived. How do I figure out what that reason is?"

"Maybe someone will pay attention to me now; maybe someone will help me."

Right after a suicide attempt, many survivors have said that the pain that led them to harm themselves was still present. Some felt angry that they survived their attempt. Others felt embarrassed, ashamed, or guilty that they put their family and friends through a difficult situation. Most felt alone and said they had no idea how to go on living. They didn't know what to expect and even questioned whether they had the strength to stay alive. Still others felt that if they survived their attempt, there must be some reason they were still alive, and they wanted to discover why.

DIY: Corsi-Rosenthal Air Cleaner




This map illustrates recent wild fire locations along with air quality levels in North America. Notice that "Horseshoe" shaped column of smoke stretching down from Western Canada through the Midwest arching back up into Eastern Canada. This is a typical wind dispersion pattern, and the reason for most of the smoke and haze we see in our airshed this year.

So what can we do about it? When AQI levels are unhealthy, all you can do is go inside and reduce physical activity. Another solution would be to purchase a portable air cleaner from the store to scrub the indoor air. Or, you can save the money and build one yourself. I am talking about a "Corsi-Rosenthal" air cleaner. You can build one that is less expensive and more effective than most store bought portable air purifiers – and you can build one without any tools! So, even if you're not an expert craftsman, you can still easily make one for your home. Here's how. Start with a 20" box fan, 5x MERV-13 (20" x 20") filters, a roll of duct tape, and 4x wooden 1" dowel rods each (2'-4') long. The wood dowels act as legs, raising the filter off the floor allowing the most cubic feet per meter (cfm) airflow to filter indoor air in the shortest amount of time.

YouTube has lots of videos to build different versions – Type "Corsi-Rosenthal air cleaner" in the search to get step by step instructions on how to make one. Or, you can go to the Tribal website at https://winnebagotribe.com/air-quality/ to make the above version. While you're there, click on the Current Air Quality link to get our current air quality in Winnebago.

When building an air filter remember these things: 1) Ensure air flow arrows of the filter's all point to the inside. 2) Seal any gaps between the box fan and the filters with duct tape forcing all the air through only the filters. 3) You can go higher or lower with the MERV rating but know that if you go really high, like a HEPA filter, the fan motor will have to work harder to pull the air through it and over time possibly damaging the fan motor. Also that fine of filter will clog much faster.



This is an example of a Corsi-Rosenthal air cleaner using 4 filters sitting directly on the floor. There are other versions that use only two, or even, one filter taped directly to the inlet of a 20" box fan. The advantage of using less filters is ease of build and a lower cost. The downside is it reduces air flow which then takes longer to filter the room. The other downside is the filter will clog faster requiring it to be changed out more often. The good news is, whichever design you choose to make, once you build your first air cleaner it's just a matter of replacing the filters to scrub the air inside when you need it.


