Indians Capture Third Straight State Tournament Trophy



The Winnebago Indians boys basketball team last weekend took their game, Rez Ball, back to the State Capitol and the Devaney Sports Center. The Indians first game was against an equally hungry Kearney Catholic team. The Indians though were not playing their game squeaked out the W, 67-63. Day two saw the Indians taking on the Wahoo Warriors at the Pinnacle Bank Arena. Again coming out cold and not playing the style of basketball that got them to the State Tournament, the Indian came up three points short, 55-52. Heartbroken after the loss, the Indians came out Saturday morning against the Columbus Scotus Shamrocks, the team the Indians beat by 15 to get to the State Tournament. In their previous meeting, the Shamrocks played an 'aggressive' game against the Indians, sending both David Wingett and D'Von LaPointe to the locker room with injuries. This game was a continuation of their first meeting, this time though with the Shamrocks staying close on the scoreboard. After regulation time ran out the Indian's Cedric Blackdeers finished off the Shamrocks at the overtime buzzer with a 3 point dream killer, 71-68. The Indians finished their season with their second 3rd place finish at the State Tournament a 3rd place Rating and a 3 year record of 110 wins-9 losses...dang. Congratulations Indians, Go Big Blue!



Indianz.com... Steven Newcomb: The Doctrine of Discovery is still alive and kicking

The United States isn't the only government asserting authority over indigenous peoples. Steven Newcomb

(Shawnee / Lenape) of the Indigenous Law Institute looks at the way Australia has side-stepped its treatment of Aboriginal people:

In 2012, at the UN Permanent Forum on Indigenous Issues, Kate Gumley, then Head of the Australian Delegation, delivered an intervention titled "The Doctrine of Discovery." The first paragraph of the document demonstrates how skillfully the Australian government side-stepped the issue of domination. "The key agenda item for discussion this afternoon," the Australian government's statement began, "is the 'doctrine of discovery', an international public law concept which has received the attention of this forum because it directly addresses the question of lawful conquest during the period of colonisation [sic]." (emphasis added)

of colonisation [sic]." (emphasis added)
The Australian government officials
who drafted the statement failed to identify the question that Indigenous Peoples'
representatives were raising by calling
for a focus on the so-called "doctrine of
discovery." What the state of Australia

framed as "lawful conquest" is, in actuality, nothing other than a claim by state governments to possess a right of domination in relation to our original nations and peoples.

If we had been provided the opportunity, we could have asked the Australian government: Do invaders have the right to dominate other nations on their own lands and in their own territories? On the basis of what frame of reference or standard of judgment might we answer? Are we obligated by some strange loyalty to the invaders and their descendants to answer such questions only from the viewpoint of their invasive mindset or standards of judgment?

Thoughts on Growing Winnebago and Sports... by Lance Morgan



The Winnebago boys basketball team ended a great season with a dramatic last second 3 point shot to take third place in state tournament. This is on top of a third-place finish last year and a first place finish the year before. I don't know the exact records, but over the last 3 years Winnebago is approximately 90-6. That is crazy good and a lot to be proud of for any team.

In the future, people will remember the championship, but I believe that what people should remember is just how good our young men were over a sustained period of time. It is very impressive no matter how you think about it. Just a shot or two more going in and we are talking about 3 straight championships.

Community Growth

Our sports teams and their rise really seems to be tied to the overall rise of our community. The more housing we get, the more people we have in town. The more jobs we have, the more stable our home environments. The better home environments creates better parents and better parents means better students and better students should translate to more success in not just sports, but in educational opportunities. The better home life should mean fewer high school

drop outs and fewer teen pregnancies. All this adds up to a stronger school and stronger sports teams. The whole thing is tied together in a loop. Every time we break a cycle of poverty for a family we create another opportunity.

Our community has grown dramatically in the last 10 years. We have added over 500 people and are right at a population of 2,000. In sports, we have gone from Class D to Class C-2 to Class C-1. It is likely that we will be in C-1 to stay if we continue our growth pattern and who knows maybe in 20 years how big our community can be.

As long as we can build the housing. (Which we are working on!). We will likely grow another 500 people within the next 10 years, making Winnebago by far the largest community in Thurston County. Our growing tribe and resource base will continue to stress our community resources, including the school, but I think that there is real strength in numbers and I suspect the future is very bright for all of our teams going forward.

One Last Thing

My son is 11 years old and is a big Winnebago basketball fan. He was born about a month after my grandfather Harold Big Fire passed away. My Choka Harold was old school and absolutely the toughest guy I ever met. In honor of my grandfather, my son's middle name is Big Fire. Garret Big Fire Morgan--that's a cool name. My son has light brown hair and isn't obviously native in appearance. Last year, at a youth basketball tournament he asked to get a tournament jersey because he could have his name put on the back. When he came back it said Big Fire on his jersey. I was surprised and asked him about it. He said. "I like to use my Winnebago Blood for basketball!" I could not have been prouder of him.

Wrestling with God"

When it comes to how a mother or a father interacts with a toddler there are definite differences. Have you ever seen a mother toss their sixth month old child into the air and then catch him? Have you ever seen a father toss the same child into the air, especially when mom is not around?

A male typically enjoys physical engagement, whereas a female would probably rather have verbal interactions. Two stories from God's Word demonstrate the differences in spiritual encounters between God and a man, or God and a woman.

The first story is about Jacob who after twenty years is about to have a family reunion with his older twin brother Esau. The last time they were together Esau promised to end Jacob's life due to Jacob having deceived their father and receiving the blessing meant for the oldest son. Word reaches Jacob that Esau is on his way to meet Jacob with no less than an army of 400 men.

Jacob sent his two wives, their two maidservants, eleven sons and one daughter, plus all of his livestock and servants across the Jabbok River. He is alone, but not alone. God is right there with him. Jacob wrestles with a man during the night. But this is no ordinary man. It is the pre-incarnate Jesus.

They wrestle throughout the night. They wrestle to a draw. Is Jacob as strong as God? No, but Jacob will not let go. In faith Jacob holds on for dear life! God gives Jacob a new name. 'Jacob' means 'heel' or 'deceiver,' since Jacob had held on to his twin brother's heel when Esau was born. Jacob's new name is 'Israel.' This is because Jacob struggled with God and held on in faith.

Yes, Jacob struggled with God and was blessed to see God face to face, and yet his life was spared. He would go on to meet his brother with the confidence that God was with him and would see him through no matter how bleak or dark the outlook appeared to be.

The other story is about a Canaanite woman's interaction with Jesus. This woman did not wrestle with Jesus or even attempt to embrace him. She cried out "Lord, Son of David, have mercy on me! My daughter is suffering terribly from demon possession."

How does Jesus respond? For a woman, it is probably in the worst possible way. Jesus gives her the silent treatment. His disciples speak up, "Send her away, for she keeps crying after us." His silence did not stop her from crying out. She was probably thinking 'Jesus, say something, anything!

Jesus finally does respond, "I was sent only to the lost sheep of Israel." The response does not stop the woman; rather she has now engaged Jesus. Now she knelt before Jesus and said "Lord, help me."

take the children's bread and toss it to their dogs." A liberated woman would probably take offense at this, since the Jews often considered non-Jews as dogs. Nor would you find many women today who would kneel before a man. Many today might think or say to

Jesus answers, "It is not right to

themselves, "O.K., be that way!" Have you ever thought just that when God did not answer your prayers, promptly or in the manner you expected or even demanded?

Instead she said, "Yes, Lord, but even the dogs eat the crumbs that fall from their master's table." Jesus answered, "Woman, you have great faith! Your request is granted."

God engaged two people, one man and one woman. Both of them were being tested by God. Both of them held on to their God-given faith in God and were blessed. What challenge are you spiritually wrestling with God today? Don't let go of God and His promise for you. Instead hold on to Him for dear life by trusting in Jesus as your Lord and Savior.

This can happen if our students continue to: 1. Work hard in the classroom. 2. Discipline themselves in the kind of lifestyle they lead. 3. Avoid those drugs that are damaging not only to the body but also to the mind and spirit, and 4. Work on improving their God-given abilities. I'm not just addressing the boys basketball team in saying this, but also including the girls basketball teams, the wrestling team, the football team, the track & field team, and any other team activity that may not necessarily be sports-oriented.

In looking ahead, I (as one council member° and I'm sure other members, would be willing to look at the possibility of providing summer sports camps for our youth. I'm not in support of sending our young people to Australia, Europe and other parts of the planet to participate in summer sports camps when we have the resources and facilities right here in Winnebago to develop those who want to excel in whatever they may choose. But I do think we could have a good summer program that would coincide with the youth employment program. And I'm sure this council has some ideas as to where the resources might come from (hint *^%nng *#@!). It might not hurt to contact your favorite council member concerning the above suggestion.

In closing, I would like to acknowledge and thank all the mothers and fathers, aunts and uncles, grandmothers and grandfathers who made (and continue to make) the commitment and sacrifices necessary to insure the success of our young people. I was Henry Ward Beecher who said, "A mothers heart is a child's classroom," that includes the hearts of our aunts and ca-ca's, but I would add to that by saying "a fathers presence is a childs playground,' and that includes the presence of our uncles and choka's. Boys, thanks for another great basketball season, we're already looking forward to the upcoming season.

WHDC APPLICANT & WAITING LIST **AMENDMENTS**

Effective March 8, 2017 these are the changes reviewed & approved by the WHDC Board of Commissioners to the Admissions and Occupancy Policy. Section 9 will have the new sub-section A, and will state;

Waiting list-Applicant at No.1 on the waiting list (appropriate bedroom size) shall be sent a letter informing him/her that 1.) the individual must come to the office to update their application to be sure that they are still eligible for low-income rental housing within two weeks (10 working days).

If the applicant does not respond in person, by mail or by telephone, by the end of the 10th day of the date of their notification, the Occupancy staff will move the applicant to the bottom of the waiting list for ten days. Then Occupancy staff will move on to the next applicant on the waiting list and proceed with the notification to that

(In essence the applicant will have a full 20 working days to establish contact with Occupancy from date of notification letter before being completely removed from the waiting list.)

Another action has been approved by the WHDC Board that affects new applicants. Effective immediately the Security Deposit amount due upon new move-ins will be raised to \$200. This increase is due to the rising costs of supplies needed to restore a unit to near new conditions for the next tenant. As always, the WHDC maintenance staff and admin. staff strive to provide the best housing possible to our service area applicants.

Also, the WHDC Staff apologizes for any inconvenience on Friday, March 17th for the water shut off. Our office was not alerted by the contractors performing the fire hydrant flushes so we weren't able to notify our tenants

Tribe Welcomes New Chief Financial Officer



My Name is Alan Post. I'm the new CFO for the Winnebago Tribe. A few personal facts about me: I am married, have 3 children (son - 30 and 2 daughters - 25 and 19), 2 granddaughters and a grandson that will be born sometime this month (March). I ride a Harley motorcycle and I am involved in a motorcycle ministry called Black Sheep Harley Davidson's for Christ.

I began my tenure here on March 1, 2017 and I am VERY glad to be back. Some may remember me when I was serving as the Controller at WinnaVegas from the end of January 2014 until June 2015. I left WinnaVegas to return to my home in Billings, MT because my youngest daughter was beginning her 1st vear in college at Montana State University in Bozeman, MT. (A side note: I graduated from the University of Montana (GO GRIZZLIES) the cross state rivals of Montana State.) The decision to leave WinnaVegas and return to Montana was not an easy decision but it was what was necessary at that time. For the past 1 1/2 years I was working in a road striping equipment manufacturing company in Billings, MT. I learned many new things there, but my heart was in accounting. The opportunity to return here came up and I came back and as soon as my wife and I can sell our home in Billings, we and our 2 dogs will be relocating to somewhere in

During my tenure there, I lead the team that relocated and built the new casino on a major highway between central Oregon and Portland.

As CFO of the Winnebago Tribe, I am tasked with leading the finance team as well as ensuring the financial internal controls are in place and followed by all. Furthermore, I am responsible to ensure the financial accounts are kept current and financial reports are both relevant and reliable in the information that is being accounted and reported. I look forward to working alongside the team in the finance office and to do my best to make your finance office the best place.

Amazing things to be Planned from the Planning and Development Office

Newly developed for the Tribe is the Planning and Development Office. You may have met the staff already if you were looking for the Enrollment office. They are located at 112 South Bluff Street, previously the Enrollment Office building. Some of the staff are new to the Tribe, others have moved over with their positions from other stations, and most of the names are familiar around Winnebago. The staff includes Joy Johnson, director and planner; Esther Mercer, contract and grants specialist, Pat Medina, grant writer; and A.J. Jones, data and research specialist.

What is new that tribal members or tribal staff should expect from this office? The Tribe has started on a journey to create a long-term strategic plan to increase organizational effectiveness. The planning and development office is leading this charge. Formally, adoption of Tribal Council's strategic plan was set in place in October 2016. Now set in motion, the Council's plan will provides guidance with priorities for the tribal departments.

For tribal members this means building efficiencies, growing jobs, and expanding services with the limited appropriation dollars available. Our tribal departments will be doing some internalization and evaluation including recognizing what they do well. Departmental planning efforts, facilitated by the planning office, will allow each of the departments to establish goals and objectives to increase their efficiencies, effectiveness, and identify areas to build or enhance bridges and/or cooperative endeavors across departments and programs. The results will allow the planning and development office to seek and obtain fiscal resources that will help achieve goals while leveraging tribal appropriation resources to the maximum extent possible.

The data center, now a part of the planning and development office, is serving as a depository of tribal data for all tribal departments and grants. As a repository of all grants and contracts for the Tribe the office serves as the business contact office. These two functions provide the privilege of working with grant staff to highlight and present the outstanding and conscientious work accomplished to our outside funders.

Together through planning and coordinated efforts a vision for a better, stronger, more vibrant Winnebago is about to unfold. Watch for opportunities in the coming year and beyond to become engaged with the various tribal departments and the tribal council as they commence building a new future for generations to come.

HO-CHUNK FARMS - CORN PROJECT

It's mid-August the sun is rising slowly in the East and it looks like it will be another great day to get that corn out on the screens for drying.

I don't know how many of you have ever experienced this exciting feeling in August, I have since I was a young girl growing up here in Winnebago, Nebraska.

For the last 30 some years it has been a project that the Kateri Circle from St. Augustine's has done as a major fundraiser so that members can attend the National Kateri Conference. We also do this to make sure we have our traditional Wa-Sha to provide to the community.

Last August we produced 138 quarts of traditional dried corn. Not the best harvest we have had but as good as we could do for just a few of us doing it, most of who weren't even Winnebago Tribal members. It makes me worried that this may soon be another tradition that could be lost if we don't teach the young ones the entire process.

Ho-Chunk Farms, Aaron LaPointe has decided to plant and process our traditional Wa-sha and use it as a learning tool for young members of the Tribe so that this tradition isn't a thing the Winnebago's used to do a long time ago.

Next month Ho-Chunk Farms will have a tribal elder offer a prayer and tobacco to mother earth before planting a little less than an acre of Indian Corn. The corn will be closely watched for the right time to be harvested another prayer will be offered and the picking process will begin early each morning.

It is Aaron's plan to utilize members of local groups such as, the Winnebago Basketball Team maybe a softball team or two and of course those elders who can teach the process to these young Winnebago Tribal members. This will give these groups an opportunity to not only learn the process but also raise funds for uniforms or travel expenses. Ho-Chunk Farms will also be employing several tribal members during the entirety of the corn project.



We feel we have excellent linemen, both offensively and defensively. It is a group filled with size and great motors."


