Indianz.com... Standing Rock Sioux Tribe celebrates completion of rural water supply system



The Standing Rock Sioux Tribe is celebrating the completion of a new water system that addresses some of the issues raised by the presence of the Dakota Access Pipeline.

The controversial crude oil pipeline has been a major concern because the final portion in North Dakota is located close to the water intake system on the reservation. A spill would contaminate the tribe's water supply within minutes.

The Standing Rock Rural Water Supply System, though, alleviates a little bit of the pressure. The intake is now located further down the Missouri River and it has been placed deeper into Lake Oahe in hopes of avoiding a repeat of a crisis that left 10,000 people on the reservation without water in 2003.

"Construction of the water treatment plant, the new water intake, and many miles of pipe, ensures safe, clean and reliable drinking water for the people of Standing Rock," Chairman Dave Archambault II said in a press release on Monday.

The \$29.2 million project was funded through the American Recovery and Reinvestment Act of 2009. It consists of a new storage reservoir, a system of water pipelines and the new intake and treatment plant that will serve about 10,000 people on the reservation.

"Projects like these demonstrate the benefits of investments in infrastructure to meet the current and future needs of the tribe," said Arden Freitag, an area manager for the Bureau of Reclamation, a federal agency. "This project completes a major effort to stabilize the water supply for the communities on the northern part of the reservation, replacing the Fort Yates intake that failed in 2003 and an aging water treatment plant."

Despite the completion of the system, the threats from Dakota Access remain unresolved. In June, a federal judge ordered the U.S. Army Corps of

Engineers to conduct a more thorough analysis of the final portion because the tribe's concerns about treaty rights, water resources and environmental justice were ignored by the Trump administration.

Two months later, the Army Corps has yet to initiate a formal environmental impact statement on the matter. But attorneys from the Department of Justice are already hinting that a revised decision won't be any different than the one that led to the approval of the final portion of the pipeline.

"There is a serious possibility that the Corps will substantiate its prior decisions, in part because the risk that any oil will spill into Lake Oahe is low," government attorneys wrote in an August 17 brief.

The pipeline became operational on June 1. The tribe has sought to halt operations pending the new review, a request opposed by the Trump administration and the project's wealthy backers.






Thoughts from the Chamber of Commerce...

I have spent the last year as the Chairman of the Siouxland Chamber of Commerce. It was an interesting experience. They have never had a member of a minority group lead the organization, so I feel like I broke a bit of a barrier. To show I was different, I insisted my picture be in color, not like all the previous chairman whose portraits were in black and white.

The main thing I learned is that Sioux City is desperate for blue collar workers. Sioux City already has one of the lowest unemployment rates in the country and is about to open another plant which needs over 1,000 workers and will expand again next year and will need another 1,000 workers. Several other blue collar and construction companies need well over another 1,000 workers. This competition for labor is starting to push up wages in the area. Companies are trying to recruit workers from Texas and Arizona. I think they should try out Winnebago, Walthill and Macy first.

I recently was talking to a local company and he was complaining about not being able to find workers, so I put up his contact info on one of the tribe's informal Facebook sites—the Real Winnebago Tribe group page. A week later he has hired three guys from Winnebago. He apparently was talking

about it with another company and they asked if I would post their jobs on the Facebook page.

At any one time, we will have over 30 jobs posted on Ho-Chunk, Inc.'s website. We simply cannot fill all the jobs locally. I keep encouraging people to apply online and we hold job fairs and continue to advertise.

Something odd is going on. Despite all our efforts, people keep saying they can't get a job in Winnebago. I used to just roll my eyes, because obviously there are jobs available. I have written before how the tribe requires drug testing across the board and how that has locked out both casual and hard-core drug users from the work place. This explains how we have a large number of young men and some women too who don't work in our community. But there is more to the story I believe.

I think our tribal members sometimes act like the only place they can work is for the Tribe, the casino, or Ho-Chunk, Inc. That is just an excuse now because there are so many jobs open in Sioux City that pay fairly well and will even train people. Some of the jobs don't ask too many questions either on the drug testing, which probably helps the casual user. The tribe even has a van that drops people off and picks them up from various spots around Sioux City and I imagine they could add a few places if they needed to.

So I think there really isn't any excuse for not taking care of yourself and your family. We need to push ourselves to be successful. The opportunity is there for people, we just need to embrace it. I used to focus on getting tribal member jobs at Ho-Chunk, Inc. but I don't think everyone will want to work here or can qualify for some of the jobs. So I think we try and measure success by getting as many of our people working as possible. Our population is growing so fast that I really do think we need to expand our notion of what kind of jobs we will do and where we will get them. Happy job hunting.

"Peace, peace, they say when there is no peace"

I have listened attentively, but they do not say what is right. No one repents of his wickedness, saying, "What have I done?" Each pursues his own course like a horse charging into battle. [Jeremiah 8:6 NIV]

These are not my words, but the words of Mauna, Earth Maker. Have you ever rushed headlong into trouble? You know full well what the consequences of your actions will be and yet there seems to be no way for you to resist. Like one who is sliding down a slippery slope. On your own, there is no stopping your downward descent.

Mauna has given you the freedom to walk away from Him and His ways. You know right from wrong since His law is written on your heart. No one is excused for his or her own choices. You can not even blame Mauna. "No temptation has come upon you but what is common to humanity. And God is faithful. He will not let you be tempted beyond what your capacity but will make the temptation also the way out so that you can bear it." [1st Corinthians 10:13] In other words, you are responsible for your actions. With the power of God's Spirit one can and should resist temptation.

Jesus came down from above, sent on a mission by Earth Maker, His heavenly Father. His mission was not to condemn those who rebelled against Mauna but to rescue or save each and every man, woman and child. He came to offer reconciliation and peace. No, they have no shame at all; they do not even know how to blush. So they will fall among the fallen; they will be brought down when they are punished, says Yahweh." [Jeremiah 8:4-12 NIV]

In the days of Jeremiah, the result of the wickedness of the tribe of Israel was banishment. Those who survived the brutal attack of the Babylonians would be led away from their land.



Providing a better life for Winnebago Tribal members

WILL DONATE OVER \$50,000 TO THE WINNEBAGO SENIOR CENTER

Ho-Chunk, Inc. has been working on a special new initiative, Ho-Chunk Way, that will benefit local Winnebago organizations each year. Ho-Chunk Way is an employee donation program developed over the last several months and launched in July of this year.

For its inaugural year, the Ho-Chunk Way committee has designated the Winnebago Senior Center as its donation recipient for 2017-18. Monies are being collected over the next 12 months and pledges along with a Ho-Chunk, Inc. corporate match, currently total over \$50,000. A check for \$26,000 will be paid out at the end of December to the Tribal government on behalf of the Winnebago Senior Center. A second check totaling approximately \$25,000 will be paid out in July 2018.

The Winnebago Senior Center has identified several needs to better serve the Elders of our community.

Ho-Chunk, Inc. employees toured the Senior Center and visited with Senior Center Director Janet Bird this summer to understand what areas needed the most help. A video and brochure were produced that featured the Senior Center and presented to Ho-Chunk, Inc. employees at special presentations in Winnebago, Bellevue and Sioux City, as well as Alexandria, Virginia in June. From those presentations, employees were asked to pledge donations and sign up for payroll deductions that took effect July 1st.

The company is very pleased to announce this special program and donations to a very deserving organization who is dedicated to serving the needs of Winnebago Seniors. The first check will be presented to the Winnebago Tribal Council and Director Janet Bird in December.



"We are very grateful that Ho-Chunk, Inc. employees and the company selected the Winnebago Senior Center this year. We have identified several things that the Senior Center needs for our elders. We have no 4-wheel drive vehicle to deliver meals in the winter to home-bound seniors. The wheel chair lift on our van is broken so we are unable to transport seniors with disabilities. And there are other needs inside the center as basic as broken window shades, chairs and other items to make the center more comfortable. When we receive the first payment in December, we will use the money for the project that has the most need at that time. And then we will able to complete a second project with the money received in July 2018."



Ho-Chunk Way Program

Over the years, several Ho-Chunk, Inc. employees have asked how they can give back to the Winnebago Tribe in some way. With the new Ho-Chunk Way program, employees can designate a specific amount of money to be deducted from their monthly paycheck to be set aside in a special donations fund. In addition, Ho-Chunk, Inc. will match all annual employee donations up to \$25,000 each year.

Each year, a different Winnebago non-profit organization or project will be selected as the beneficiary. Ho-Chunk Way will be reviewing new non-profit applications for funding in July 2018 for funding in 2018-19.

All employee donations and corporate match are deposited with the Ho-Chunk Community Development Corporation (HCCDC). HCCDC will then distribute those funds twice a year to the selected Winnebago non-profit organization for that year.

Aho! Hello everyone. I hope this message finds you all well and in good health. I would like to speak to our Winnebago Tribal membership and publicly announce I will be running for a seat on our Tribal Council in this year's election. I have expressed some deep concerns I have had in the past, concerning some of the social issues we as a Winnebago community are currently experiencing. These issues continue to plague our people, and I would like to see more done to insure our future, and that of future generations to come, so they will be protected from a sickness that continues to destroy our loved ones.

I truly believe for us as a people to have a future, we must first be well. In order for us as a community to get there, we first must admit to ourselves and each other there is a problem and take ownership of it. Once we have done this, we as a community can take responsibility and all move in the direction of total wellness. I believe once we have arrested this sickness of addiction that has been killing us, we can then address the issues of inter-generational trauma perpetrated upon our ancestors. I strongly feel, once we as Nisoc-Ha-Ci people fully envelop ourselves into our Ho-Chunk language, traditions, customs, and beliefs we will then be on our way to healing from these past traumas.

I would like to see more of our resources dedicated to this endeavor. I believe there is a lot more we must do to ensure this takes place. I would like to serve our community and help us to move in that direction. Our children and their future is important and we as a people must stand together to protect that future. It is up to us, not those who do not have a vested interest in our community to help us.

I myself have many questions I would like answered. We have tribal members dying from substances in our community. Why is it, we do not have our own detox at our hospital to help our tribal members? Why isn't our Drug Dependency Unit at the hospital working in collaboration with our Winnebago Treaty Hospital and our Winnebago Alcohol Program along with our Chee-Woy-Na-Zhee Halfway House to ensure that this need is being met with in the Winnebago community?

We have spent roughly \$52 million dollars off our reservation so some non-tribal member will have a place to live. We are investing our resources in purchasing old buildings in Sioux City, Iowa and building a little village in South Sioux City, Nebraska. There is profit sharing being done with the Ho-Chunk name attached to it, but I do not see our poorest people benefiting in any way from it.

There is a disparity and inequality that has been created from a model that does not come from us. This whole

concept and way of thinking comes from others who have oppressed and decimated our cultural beliefs and way of life. These are our resources being funneled out of our community. We should be addressing the issues and immediate needs of our community with our resources. For that amount, we could have built a tremendous facility in Winnebago to address the issue of Substance Abuse, Mental Health, as well as house our tribal member's in a new half-way house.

I have worked in the Human Service field for a number of years. I have worked for our tribe in the past in many different capacities.

2009-2010 Educator-Project Wopks-Pi

2010-2012 Supervisor/Manager Chee-Woy-Na-Zhee Halfway House

2012-2017 Tribal Liaison Iowa Department of Human Services in Woodbury County (helping Native people across this country establish the Indian Child Welfare Act)

Currently Intern-Substance Abuse Counselor Alcohol Program

I currently serve on many boards and committees with in our Winnebago community and outside our community.

Emergency Home Repair Board Police Review Board

Health Board Village Board

Native American Church Board Sioux Land Street Project Committee.

I have also been involved in the past with:

Breakthrough Series Collaborative on the Disproportionality of Minority Children in the Department of Human Services and Juvenile Justice System. (a state-wide effort with seven teams of DHS, JCS in Iowa)

Facilitator of; Race the Power of an Illusion (a state-wide group in Iowa who provide day long presentations based on the differences in outcomes of groups, in society based on skin color)

Facilitator of Fatherhood Is Sacred in Sioux City

Based on my passion to help our Tribal members I have obtained an education and am willing to dedicate the rest of my life in improving our community. I have an Associate's Degree from Little Priest Tribal Collage, A Bachelor's of Arts Degree in Human Service Counseling from Wayne State Collage and a Master's Degree of Science and Education in Clinical Mental Health from Wayne State Collage as well. I have put my best foot forward and worked hard to get to this point in my life. I have been married for twenty-five years and continue to do my best to bring up my children to teach them about our Creator, our language, traditions, customs and beliefs as a Ho-Chunk Nisoc-Ha-Ci person. As a Nisoc-Ha-Ci man, I have sat down with our relatives several times and spoke to Mauna on their behalf on different occasions and continue to do so.

I strongly believe we still have a ways

to go and we are definitely not where we need to be as a community. A lot of our relatives are still in great need of services and must first receive these services before we can move on to loftier endeavors. We cannot afford to leave anyone behind. Everything we can do to help our people get well counts! Ai-Ki-Ruti Woshka, this means; "The way we brace each other up." At some point, we have all fallen down and we all needed someone to help brace us up. We cannot do it alone, it's going to take all of us to get down this road of life together. We are Native people. Let us not forget who we are and where we come from, as well as what we have had to endure, to get to where we are today.

My primary focus would be to make sure enrolled Winnebago Tribal Members get the support they need as they move forward, and to protect our resources by insuring tribal member's immediate needs are being met in our community. I promise I will put my best foot forward and work hard for you, the people of our tribe, not only by advocating for you but to keep elevating the level of awareness as the issues arise with in our community. I humbly ask for your support.

Thank you for your indulgence and the time it took you to read this announcement. May Mauna keep blessing you and watching over your loved ones as we move forward to a brighter and healthier future for our generations yet to come.





Greetings Winnebago Tribal Members!

My name is Sunshine Thomas-Bear, my biological parents are Louise Thomas and Wilbur Wolfe. I was adopted when I was very young by Charles and Eva Bear. I have eight amazing children that help me move forward. My children and my grandchildren are what drive me to be the person I am today; they provide me with hope for the future.

Many people have asked me why I am running for the Tribal Council? Have you thought this through? Yes I have. There are more reasons than one but one reason stands out more than the rest. I have been on both sides of alcohol and drug use. I am no better than anyone else. We all have a past and issues we have all had to overcome. We have also seen the direction our community has shifted toward. I remember being young, people helped each other. Families worked together. We weren't rich by any means but we had each other. I seen my Dad work long hours to care for me and my mom. My mom taught at Headstart, many remember her and the caring woman she was then and still is today.

When did things take this dramatic turn that you see happening here in Winnebago today? Has historical trauma caused us to enable our family members and friends? Perhaps. But we all know that whatever it is that is happening in our community, it is happening more and more. We all know of the break ins, assaults and deaths that happen. Usually these are related to what?

We all know the answer. Though some of us don't want to accept it at times, who wants to? Whatever it is that is happening and our reaction to what is happening to our community, it isn't helping. Our people, our children, don't have time to wait any longer. We need to change, not just me and not just you, we as a people and as a community need to work together to build a better place to live.

Drug addiction and alcoholism is taking our people each year. It even seems that the victims to this are getting younger. We are losing our children. Parents are going through what no parent should ever have to go through. The pain and sorrow our community faces because of what? The drugs and alcohol in our community. What it turns our people into, we have all seen many things on social media about this. What is being done about this? It is taking our family members and friends and it is only getting worse. No family has been untouched by the effects of these substances. Continuing to be silent will only worsen the damages to our people, our homes and our community.

How can we stop this? I have thought about my own struggle with addiction and alcoholism, so many people more than willing to look down on me. But only a few were willing to help me. I have had to deal with the same things that many of our people have to deal with, it was a struggle and it was hard work but the result is something I am proud of. I am passionate and dedicated to my people. I want to help our people, our children and bring change to our community for our future generations.

Educating our children, teaching them and giving them the tools to be successful adults. By education I am not only referring to what is being taught in school but what we as a people need to pass on to ensure our culture remains intact long after we are gone. Being positive role models for them. Making sure their schools are giving them the education they deserve and a safe place to learn. Preparing them for higher education so that they have more opportunities in their lives than we have had in ours. This is what all parents, grandparent and families want for their children and grandchildren, a future better than their own. I feel that I can help all our community members achieve this goal.

Thinking of what our community looked like when I was younger and the dramatic change it has gone through since then, I believe by working together and helping make not only our community look better but being better as a people. Willing to help each other, work together and think of our future, our most precious gifts, our children. Tough decisions need to be made to put us in the right direction for all our people. To protect ourselves. To protect our children.

Our culture and language are slowly fading, with only a few fluent speakers. Our ways are not being passed down and shared as much as they could be. Our enrollment numbers will begin to decline with the blood quantum. Education about the future of our tribe and where it is headed if our language and culture ceases where will we be without it? What will our children have to pass on to their children?

All these issues and more are the reason I am running for Tribal Council. To serve you, our Tribe and our future generations. I have shown through actions that I am a hard worker for my people, our children and community through the dedication I show to different organizations I am a part of. I may not speak all the time about my passions but I show my dedication through my actions. I believe this is what we need, someone who is willing to truly serve the people. I am humbly asking for your vote.

Instructional Time Extended

In an attempt to address unexcused absences and tardies more effectively, Winnebago Public School has implemented a new program for the 2017-2018 school year. The program is called Instructional Time Extended (ITE). This program replaces Attendance Recovery, which was previously held on Saturdays at the end of each semester.

Instructional Time Extended (ITE) serves as a more immediate response to unexcused absences and tardies. Students in grades 5-12 with unexcused absences and/or unexcused tardies in any class period throughout the day will be required to stay after school that night. Once the students have served ITE, their attendance will be adjusted; the absences and/or tardies will be marked as excused. However, if the student does not stay, the absences/tardies will remain unexcused and will not be allowed to be made up at a later time.

Students in grades 5-8 will call a parent/guardian between 3:00 – 3:30 to inform them how long they will need to stay.

From 3:30-3:45, students will be expected to meet with their teachers and gather missing assignments.

ITE will run daily, Monday through Friday, from 3:45-4:45. Students will be required to make up time as follows:

30 minutes for each unexcused absence

15 minutes for each unexcused tardy

Parents/Guardians must notify the attendance clerk at the school, Mrs. Norene Stromberg, the day of a student's absence/tardy to have it excused: 402-878-2224, Ext. 422

If the daily absence receives a phone call or note from parent/guardian, the absence will be excused (EX)

If the daily unexcused absence is not made up that day, the absence will be left as unexcused (UN)

If the daily unexcused absence is made up, the absence will be changed to ITE (activity)

More than 12 unexcused absences per semester may result in retention or a promotion contract to be fulfilled

Notification letters/parent meetings will be completed per school board policy

Students that have ITE will need to call home last period to notify parents. 7th and 8th grade will go to the focus room to call home. 5th and 6th will make the call from their home rooms.

5th and 6th will need to get their make-up work before leaving their room at 3:30. They will need to be in the designated classroom by 3:45.

7th and 8th grade will stay in the focus room until 3:30. After 3:30 they will go to the class they missed, to get their make-up work. They will need to be in the designated classroom by 3:45.

A list will be announced and emailed to the teachers by 3pm

Unable to contact a parent/guardian student will be sent home and the absent will be unexcused.

Grades 9-12:

3:45-4:45

Unexcused absences for the day

Will be held in designated classroom.

Unexcused Tardy is first 15 min of class

Unexcused Absent after 16+ min

30 min will make up 1 unexcused absence

15 min will make up 1 unexcused tardy



In July, Ho-Chunk, Inc. commissioned a survey of community members to determine the community's current perceptions of Ho-Chunk, Inc. and to make a comparison of the results with a previous survey conducted in 2015. Comparisons are shown when the same questions were asked in both surveys.

This year, Ho-Chunk, Inc. Summer Interns went door-to-door in the town of Winnebago to ask residents to a complete short survey. We did this to increase the number of responses previously received for other surveys. Additionally, we surveyed Tribal members at Pow-Wow to get responses from both residents and non-residents. We were extremely pleased to have received a total of 385 completed surveys. This is a much larger sample than previous years.

The completed sample yields a +/- 2.3% standard error factor with 95% confidence. This means that survey responses compiled are either 2.3% below the actual community response if the entire community had been surveyed; or 2.3% above the actual community response. And the results give us 95% confidence that survey responses are accurate within that 2.3% range.
