

Winnebago Tribal Court Engages Nebraska Supreme Court on Discussion of State-Tribal Relations

The Winnebago Tribal Court, under the leadership of Court Administrator Jennifer Berridge and Chief Judge Patrick Runge, opened its doors on August 16, 2023, to the Nebraska Supreme Court Summer Tour group for a dialogue centered on the dynamics between state and tribal courts.

Chief Judge Runge discussed the complexities of overlapping jurisdiction with state courts, particularly those within Thurston County. With insight and expertise, he and Berridge guided the visiting group through the court building, while discussing the influence of native culture on the court proceedings, offering a unique perspective on justice.

Carmelita Parker, overseeing Adult Probation, and Matthew Cleveland III, responsible for Juvenile Probation, took the floor to present a comprehensive overview of the intersections, challenges, and future interactions of tribal probation programming. The event also welcomed area state probation officers, fostering an environment for mutual learning and brainstorming for potential collaborations.

As the morning advanced, the justices and their travel group visited the Winnebago Youth Crisis Intervention Center (YCIC), led by Daryl LaPointe.

This state-licensed 24-hour emergency and temporary housing facility caters to youths up to 19 years old. Distinguished by its commitment to stability, and cultural respect, the facility offers a safe place for children who are temporarily separated from their homes.

The location shifted midday as Winnebago Tribal Council members and Vice-chairman Brian Chamberlain extended a warm invitation to all participants for lunch at the Ho-Chunk Center. The tribal members greeted the guests with a traditional song, accompanied by drummers, several of whom had also been involved in earlier presentations. The lunch featured a main dish crafted from ancient corn grown through the youth facility's agricultural program.

Attorney Andrea Snowball initiated the afternoon discussion with a review of the recent U.S. Supreme Court ruling on the Indian Child Welfare Act. Her presentation prompted an exchange of ideas and insights, contributing to a deeper understanding of the intersection of state and tribal courts.

The Winnebago Tribal Court's engagement with the Nebraska Supreme Court Summer Tour group marks another

milestone in fostering collaboration, understanding, and shared progress between state and tribal judiciaries.

Purpose of Nebraska Supreme Court Summer Tours:

According to Chief Justice Mike Heavican, summer visits are not only an opportunity to express the Court's appreciation to community leaders for their support but also to gain valuable insights into the implementation of policies throughout the state. The Supreme Court and Chief Justice pay particular attention to the effectiveness of various court processes and use the visits to identify areas where assistance is requested, especially in terms of technology and services.

All state courts operate under the administrative direction of the Supreme Court

Shortly after Heavican was named Chief Justice in 2006, he established the goal of visiting every one of the 93 courthouses and communities in Nebraska. Having accomplished that goal, he has continued to visit courthouses across the state, often accompanied by his fellow institute.

WCHS X-Ray Room Installs State-of-the-Art Equipment Upgrades

Winnebago, NE – The Winnebago Comprehensive Healthcare System (WCHS) recently upgraded its x-ray equipment to improve patient diagnostic capabilities. In May of 2023, the Radiology Department installed GE Healthcare Definium 646 HD Digital X-ray room. The Definium 646 HD powered by Helix 2.0 provides enhanced capabilities while positioning WCHS for future upgrades.

When a patient goes to receive an X-ray, a tablet-like cassette is placed behind the area of concern. This cassette holds the digital film negative that will be exposed to

the X-rays. When the X-ray enters the body, it passes through air and lung tissue, which don't absorb the energy of the X-ray. This non-absorbed energy reaches the digital film, creating the darker portions of the film. Soft tissues, like muscle, organs, and fat allow some of the X-ray through, resulting in shades of gray on the film. The dense portions of the body, like bones and teeth, or metal, will absorb all or most of the X-ray energy preventing it from reaching the film making the white components of the image. To begin understanding the complexities of breaks, fractures, and calcifications, contrast and clarity are critical to creating accurate X-ray images for providers to read when diagnosing and recommending treatments to patients. At WCHS, the Radiology Team of Registered Technologists specializes in understanding both the equipment and the human body to know what positions and techniques are used to create the best X-rays and CTs for our provider team around the clock.

"In its simplest form, a Medical X-ray is a high-powered camera that uses x-rays - instead of light exposure - to create an image," says Radiology Interim Manager, Elmasue Zylberberg. Zylberberg and her team have been using the new system for a couple of

months now and were quick to share positive comments. This new equipment has more flexibility allowing standing x-rays. The cassette is 17 by 17 inches allowing larger and better-quality images. The table can support nearly twice the amount of weight. The machine includes tracks, accessibility bars, and auto-adjusting tubes that allow medical professionals the flexibility to easily move both the machine and patients around to capture the angles. "We all agree - this machine is built smarter."







SUICIDE IN INDIAN COUNTRY PART 33

Taking the first steps:

Making big changes right now might be out of the question for you. You may not even know where to begin. That's okay. Recovery is a process, and it's important that you move at your own pace. There are a few things you might want to do to ease your transition back to everyday life. Some important steps that others have found helpful are:

First, it might be less stressful to decide in advance how to deal with others' questions about your suicide attempt. The people around you may be surprised by your suicide attempt and have questions or comments about what happened. Thinking about what you might say in advance can help you prepare for their reactions.

Secondly, re-establishing connections may help you feel better. Often, the stress or depression that leads to a suicide attempt can cause people to disconnect from others who care about them or the things they used to enjoy doing. Reconnecting with the people and things you love or loved can help instill hope.

Third, because suicidal thoughts might return, you'll want to be prepared with a plan to stay safe. A safety plan is a tool that can help you identify triggers (like events or experiences) that lead to suicidal thoughts and can help you cope if the pain that led to your suicide attempt returns.

Fourth, finding and working with a counselor can help you start to recover. Unlike friends or family, a counselor is an unbiased listener who won't be personally affected by your suicide attempt. The counselor's role is to help you sort through your feelings and find ways to feel better. You may find it helpful to begin discussing with your counselor your experiences and feelings about your suicide attempt. A counselor can be a peer supporter, psychiatrist, social worker, psychologist, or other skilled person. If counseling isn't possible, there are also ways you can help yourself, but please remember that you don't have to go through this alone.

"After my attempt I needed to be able to talk and be heard – not counseled, not encouraged – to really be listened to, like what I had to say was the most important thing in the world at that moment, for someone to connect to my pain without losing control of themselves."

(After my attempt) "I felt exhausted. I felt empty; What now? I soon felt angry. As I told a therapist, staying alive means that now I have to rationalize being a loser, a failure. That is the way you can think sometimes."

"There are a lot of things that happen in your life that you have no choice over. But the one thing that can never be taken away from you is your ability to choose how to respond."

"The hospital was the first place where I felt like I could acknowledge my illness, to myself and to others. Even knowing I had depression, they still saw me as a human with great potential. That led me to understand that seeking help would not lead to me becoming defined by my depression, as I had feared. It inspired me with the most basic conviction that I was inherently worthy of health and happiness, regardless of what others thought of me."

"When I woke up in the hospital, I didn't feel positive about life. But I watched TV a lot and saw stories about people who went through worse than I had. It inspired me to stop focusing on what I couldn't do and start focusing on what I could do."



Revised Qualifications for Emergency Grant are as follows:

QUALIFICATIONS OF APPLICATION FOR EMERGENCY GRANT:

Only one (1) may be paid to any immediate family member*, per 12-month period. *family member defined as: Spouse, child, parent, sibling, grandparent, grandchild, aunt, uncle, first cousin, or adoptive child. With priority given to same house

hold family members. Grants are awarded only if the applicant is an ENROLLED MEMBER OF THE WINNEBAGO TRIBE OF NEBRASKA. The individual for whom the emergency grant is requested can only be used once per 12-month period. The enrolled Winnebago Tribal Member can request the Tribal Council consider their circumstance outside this Policy.

Grants may be awarded only in documented cases of death or serious/critical illness, who is an immediate family member of the applicant.

Grants may be awarded to assist with transportation costs associated with situations as mentioned above, but only once per immediate family, per 12-month period, per individual for which they are being requested, per 12-month period.

One grant may be awarded up to and

shall not exceed \$250.00 (two-hundred fifty dollars).

Grants that may not require the full \$250.00, shall be paid according to direct costs needed only. (Mileage calculated at current travel allowance GSA rate).



Hanac Hinikaragiwi, I greet you all with good thoughts and feelings. My name is Eugene DeCora and I am a candidate for the upcoming Winnebago Tribe of Nebraska Tribal Council elections.

My grandparents Gaga Virginia Priest, and Gaga Juanita Maney Neff are direct descendants of our last great war chief, Chief Little Priest. I am also the grandson of my Choka Eugene N. Cultural activities involving preservation



Enrollment - I support the evolving tribal enrollment discussion and ways to meet the needs of the kids.

Housing – I support creating pathways to housing stability. We need quality housing that suits the need of the family and not profit margins. There are alternative things we could do like tiny home, double wide trailers, etc. Housing stability looks different for all of us. There's no right way to build a home.

Healthcare - I support the growth and transition of the Winnebago Comprehensive Healthcare System. The tribe took over a broken hospital and continues to dig out. Proof of that hard work is evident by the recent CMS accreditation achieved for 12 Clans Unity Hospital.

Education – I support creating further mechanisms to financially support students. Job Opportunities – I support creating a day labor force to offer work to those that want

Behavioral Health - I support expanding behavioral health services throughout the

community and tribal organization. I support destigmatizing services and breaking generational cycles of trauma.


Economic Development - I support challenging profit generating entities to reduce spending and stream lining additional financial resources to the tribe.

This is how our people operated. It was good and it was working. Nowadays money and power, like the white man is growing strong in our

Well it takes education and the wiliness to learn.

When I talk to individuals, I talk of what I know how things used to be, I was raised around old people and listened. I remember the old ones names, of long ago, I know their stories. I enjoy so much in speaking of them. This is what I am always willing to share with anyone who

community, we need to get back to our old ways of thinking and living. How do we do that?

We claim we are sovereign. But are we really? I have to say not. We rely on the government for many things. We need to be self-sufficient and do for our WHOLE tribal membership. We need to direct any monies we get, to that self-sufficiency and not WASTE the money we get on nonsense. I see the community of Winnebago doing well, better than other reservations. So many thanks to those who made good decisions for our tribe. We need to collaborate on issues and tackle it together in order to make a change. That's leads me to mention, that back in the 1700-1800s our tribe was huge and we had around 13 villages scattered, and each had a chief and I think if at that time, all the 13 villages stuck together and collaborated and fought as ONE, things would been a lot better for us, at that them villages made different decisions, now here we are today, but my point is that we work together and we will be that much stronger and Things will be better for our tribe as a whole. I want the best for our tribe and I think a lot about our tribal members who live off the reservation, they need to be included in these decisions also. I also think of those who have addictions, we need to lift them up and support them in their recovery,

they are part of us, I don't want them over looked and forgotten about. Another thing is to know your relatives. If you need assistance I can help. We are all related.


It's your right to vote, make your vote count for our Tribe. Not just because it's your relative or friend, but what is needed at the table. A lot is common sense but also requires life experience and
