Keep your eyes open in the "School Zone, in the morning and after school hours, these new crossing lights will alert you to slow down.





Los Angeles cancels Columbus Day

Columbus Day is no more in the nation's second-largest city.

The Los Angeles City Council voted 14-1 last Wednesday to officially mark the second Monday in October as Indigenous Peoples Day on the city's calendar — a day to commemorate "indigenous, aboriginal and native people." The day will remain a paid holiday for city employees, the Los Angeles Times reported.

The vote followed a contentious hearing, during which some Italian-Americans said the switch would eradicate a key portion of their history, while others argued that city lawmakers needed to "dismantle a state-sponsored celebration of genocide of indigenous peoples" and dismissed the idea of celebrating Indigenous Peoples Day on a different date altogether.

"To make us celebrate on any other day would be a further injustice," said Chrissie Castro, vice chairwoman of the Los Angeles City-County Native American Indian Commission.

Councilman Mitch O'Farrell, a member of Oklahoma's Wyandotte Nation tribe, had pushed for the change, saying Wednesday that the move would provide "restorative justice." In a blog post prior to the vote earlier this week, O'Farrell said the "historical record is unambiguous in documenting the horrors" Christopher Columbus and his men imposed on the native people in present-day Haiti and the Dominican Republic.

Removing Columbus Day and replacing it with Indigenous Peoples Day is the appropriate action for this city to take," O'Farrell wrote. "We must send a signal to Washington D.C. that there is no better day to honor our original inhabitants while highlighting the

absurdity of celebrating a historical figure responsible for such profound suffering, still felt by generations of Indigenous People everywhere. This is more than symbolic. It is spiritually and morally necessary."

Councilman Joe Buscaino, a first-generation Italian-American, suggested replacing Columbus Day with a new name to celebrate "all of the diverse cultures in the city" before being the lone city lawmaker to oppose the switch, asking fellow councilors not to "cure one offense with another."

With the change, Los Angeles joins a growing list of places that have already replaced Columbus Day — first recognized as a federal holiday in 1937 — with Indigenous Peoples Day, including Alaska, Vermont, Seattle, Albuquerque, San Francisco and Denver. Most recently, the Bangor City Council in Maine voted to rename the holiday, the Bangor Daily News reports.

they are asking the court for permission to reopen.

"The commission's decision in this case is so blatantly in violation of the statutes," attorney Andrew Snyder told the court on Tuesday morning, when arguments took place, The Omaha World-Herald reported.

Since the shutdown in the town, liquor sales have picked up in towns further from the reservation border, The Lincoln Journal Star reported earlier this month. The paper published an extensive report, Beyond Whiteclay, which looked at the impact of the closure on the Pine Ridge community, where alcohol abuse has contributed to social and law enforcement problems.

A decision in Kozal v. Nebraska Liquor Control Commission isn't expected for at least six weeks, The World-Herald

reported. Audio and video of the argument will be posted on supremecourt.nebraska.gov.

Thoughts from a Personality Test... *By Lance Morgan*



It must be election time because in the last two editions of the WIN, I have had people take a little shot at me or Ho-Chunk, Inc. One said the Tribal Council gave me personally the last two per capita payments meant for tribal members. It also said that a per capita payment was a right—a right, not an extra thing. The second one made a general comment about our real estate projects in Sioux City and questioned why would we do that when we need housing in Winnebago.

I have heard versions of both before and frankly such comments bug me, but I figured I would offer some additional insight. First, of course no one gave me your per capita payment. In fact, over the last 3 years Ho-Chunk, Inc. has contributed about \$200,000 per month to the tribe in dividends and taxes. This doesn't take into account all the other good deeds we do in the community. So saying the guy working hard to put money into the tribal bank account is taking your per capita payment is in fact annoying to me. For the record, Ho-Chunk, Inc. gives out pay checks, not per capita checks.

However, the tribe did allow Ho-Chunk, Inc. to retain 30 percent of its dividend, to build 100 houses and the infrastructure for 100 more. Ho-Chunk, Inc. has built or purchased over 150 housing units in the last 15 years. In the last two years, we have built 50 housing units. This is the fastest pace of growth in housing in our modern history, which leads me to the second critique about building

stuff in Sioux City.

It is a simple criticism to tie what we do in Sioux City to Winnebago, but it really isn't a fair comparison. We are building those projects purely to make money and charge market level rents designed to maximize income to the tribe. In Winnebago, we use the profits made in Sioux City to fund purchasing land to expand our town, fund down payment assistance for tribal members, and supplement the construction of new apartments and townhouses so people can have affordable housing.

Maybe I am too close to it, but do people really just think a magic wand is waived and new high quality housing magically appears. It takes years of work and lots of time and effort in planning, getting the funding and getting them built. The housing problems are real in our community, but so is the progress we have been making and criticizing the hard work on the people trying to make it happen is counter-productive.

I took a personality test a few years ago and it said I craved acknowledgement or getting credit for things. I said at the time then I am working in the wrong place! But I realize that I do get credit for things all the time. However, it is just for things I didn't actually do like taking per capita payments, plotting to hurt tribal housing, being mean to children, not liking dogs, jay walking, elder abuse, being stingy, stealing money, only hiring non-Indians, and any other thing you can imagine.

I get it. I am a public figure in our community and put myself out there all the time and expect some push back. I usually ignore it, but that makes me an easy target too, especially around election time. I understand that poverty leads to anger and frustration, but getting out of it is hard work and it won't be done by complaining.

I am an optimist or I wouldn't be working here and I keep thinking that at some point, our people will all be so successful that the problems of poverty will begin to fade. I think we are well on that path. I know I need to focus on the long-term plan, but it is tough in the short term to get credit for so many things, I don't actually do. Football Season is here. Go Bago and Go Big Red!

"Live by the Spirit"

Have you ever taken the time to stop and think why you do the things that you do? Do you ever wonder if you allowed the Holy Spirit to lead you what a difference this would make? Do you even think that it is possible for you to let go and let God's Spirit be in the driver's seat?

You have been tricked into thinking that you have freedom when you let go and live life doing whatever comes to mind. You allow your tongue to say whatever comes to mind. You curse, you lie, you slander, you gossip, you make fun of others and in reality you have lost control. Even when you attempt to curb some of your words you simply can't help yourself.

If you reason that you can live life your way and still have a place reserved for you in the new heavens on the new earth then you have been deceived. The truth is that you can not live like hell and still expect heaven too.

The apostle Paul wrote to the Christian churches of Galatia these words: 'I say, walk by the Spirit and you will certainly not satisfy the desire of the flesh. For the flesh desires what is contrary to the Spirit, and the Spirit desires what is contrary to the flesh; for these are in opposition to one another in order that you do not do the things you want. But if you are led by the Spirit, you are not under the Law.' [Galatians 5:16-18]

What a mystery it is to have freedom from the Law by walking with or living guided by the Spirit. The Law of God, His demands can never be met by you, not even close, no matter how hard you try. The Law of God can only let you know that you have once again failed.

You are not holy. You are not sacred by your own actions. Your sinful flesh, your sinful nature opposes the Spirit of God. Paul goes on to give examples of the ways of one's sinful nature: 'Now the works of the flesh are obvious, which are sexual immorality, impurity, indecency, idolatry, sorcery, enmities, strife, jealousy, rage, selfishness,

dissensions, factions, envy, drunkenness, carousing, and such things as these, concerning which I am warning you, just as I said before, that those who do such things will not inherit the kingdom of God.' [Galatians 5:19-21]

You are guilty of doing such things. The danger is that if you continue to live life according to the freedom of your sinful nature you will not live with God forever and ever. Lord have mercy!

But the good news is that there is another way. By the grace of God, you allow God's Spirit to enter into your heart. You allow God's Spirit to speak to you through His Sacred Word. You allow the Spirit that Jesus promised to send, to bring you to trust in the suffering, death and resurrection in Jesus. You allow Jesus to take your place on the cross in order to set you free from your sinful nature. You allow the Spirit of God to assist you in crucifying your self-centered ways.

Once again we turn to what Paul wrote to the churches of Galatia: 'The fruit of the Spirit, however, is love, joy, peace, forbearance, kindness, goodness, faithfulness, gentleness, and self-control. The Law is not opposed to such things. Now those of Christ [Jesus] crucified the flesh with its passions and desires. If we live by the Spirit, then by the Spirit let us also walk. Let us not become conceited, provoking one another, envying one another.' [Galatians 5:22-26]

The life of one who lives by the Spirit is a blessing to that person as well as to all those around him or her. What a difference the power of God's Spirit is, in this life and in the one to come!

"To Show Law on Per Cap by IRS"

Per Capita payments from trust funds held by the Department of the Interior.

The Department of the Treasury and IRS issued final guidance regarding Per Capita distributions made two members of Indian tribes from funds held in trust by the Secretary of the Interior. In response to feedback from tribal nations, the guidance clarifies that, generally, these Per Capita payments will not be subject to federal income tax.

The final guidance provides an exception to the general rule where taxable income is mischaracterized as non-taxable income.

From the desk of the Winnebago Air Quality Program

ASTHMA TRIGGERS

As I conduct outreach in our community, talking to people about air quality issues, one of the surprising things I've learned, is that we have allot of people, young and old, who are dealing with asthma. In my own family, I started paying attention to asthma, when one of my own sons was diagnosed with it, and I had to make some important changes in our life, to reduce the "triggers" that cause an asthma attack.

First, let's define what "triggers" are. Certain things cause asthma "attacks" or make asthma worse. These are called triggers. Some common triggers are

Things you might be allergic to. These are called allergens. (Most people with asthma have allergies, and allergies are a major cause of asthma symptoms)

House dust mites

Animal dander

Cockroaches

Mold

Pollens

Infections of the airways

Viral infections of the nose and throat

Other infections, such as pneumonia or sinus infections

Irritants in the environment (outside or indoor air you breathe)

Cigarette and other smoke

Air pollution

Cold air, dry air

Odors, fragrances, volatile organic compounds in sprays, and cleaning products

Exercise (about 80% of people with asthma develop wheezing, coughing, and a tight feeling in the chest when they exercise)

Stress

It's important to check all the environments you live in, such as home, work, school, day care, relatives' homes etc. for exposure to these environments.

Avoiding Triggers

Here are some things you can do to reduce your exposure to triggers.

Do not smoke in your home or car.

Reduce exposure to dust mites. The most effective things to do are to cover your mattress and pillow with allergy-proof encasings. Wash

bedding in hot water every week, and vacuum and dust frequently.

Reduce humidity in the home with a dehumidifier or remove carpeting. Bedrooms in basements should not be carpeted.

If allergic to furry pets, remove them from your home.

Reduce cockroach infestation by setting roach traps, repairing holes in walls and entry points, and avoid leaving food or garbage exposed. Be careful about bringing in cardboard boxes of food from food pantry's. Remove cans and food items outside, and throw away the box, s. Cockroaches like to hide in the seams of the cardboard boxes.

Mold in homes is often due to excessive moisture, leaky roofs, leaking pipes or excessive humidity. Control indoor humidity by using fans in the bathroom and kitchen, and adding a dehumidifier in areas with high humidity.

Pollen exposure can be reduced by using an air conditioner in your home, and keeping doors and windows closed during high pollen times.

Check air quality reports in weather forecasts or on the internet. When air quality is poor, try to stay indoors and follow your doctor's recommendations.

Asthma can reduce the quality of life, and prevent people from enjoying normal activities. By making even small changes, it can have a huge impact on sufferers. The Winnebago Environmental Protection Department Air Quality Program is here to help the community with indoor and outdoor air quality issues.
