Little Priest Tribal College continues working toward solutions for their students' success

Little Priest Tribal College has been busy this year, recently projects have begun & ended, short-term and long-term goals have been planned and accomplished. President of LPTC, Manoj Patil states "Little Priest is making tremendous stride in progressing the mission of the college: "Be strong and educate my children" by Chief Little Priest.

More Recently, Manoj Patil has worked with the United States Department of Agriculture and The Bureau of Indian Education to secure half a million dollars to fund LPTC's new parking lot. The USDA provides economic opportunity by helping rural America to thrive. BIE funds collaborating schools with culturally relevant, high-quality education. Ho-Chunk Inc., Construction Group worked with the college to demolish and pour the new lot. The rebuild of this parking lot has the same layout but was necessary due to the poor drainage of water and developing potholes, the new lot came just in time for winter sleet/ice. Construction began July 12th 2023 and ended September 8th 2023. The unveiling was celebrated with a ribbon cutting followed by news of a Science Building!

During the ribbon cutting and ground breaking ceremony President Manoj Patil shared exciting news of the \$6 million dollar Science building! The Sherwood Foundation donated 6 million towards Little Priest Tribal Colleges new endeavor. The Sherwood Foundation promotes grants for equity though social justice initiatives enhancing the quality of life in Nebraska through community invest-

ments. Ho-Chunk Inc,. Construction is building the structure. The process to get this going began in March 2022, which was later approved in November 2022. This is just one small step of the college's 10 year plan. The creation of this building will create more jobs in Winnebago as well as expand the higher education opportunities available to community members.

Speaking of the 10 year plan, in July 2020 Tribal Council agreed to give Little Priest 10 Acres of land to expand the campus East after President Patil and staff presented their plans. The future campus will have a CTE Program building, Wellness center, event center, dormitories, daycare and renovation of current buildings starting with the Elk Building Auditorium. The auditorium renovation funds have already been granted by the USDA, and is expected to be done by July 2024.

Back to the updates, in August 2023 LPTC had a record-breaking amount of students at orientation, a total of 138 present! The previous record was 81 students in 2019. The significant rise of student attendance is a reflection of all the efforts of the schools work on retaining students. Loretta Broberg, Vice President of Teaching & Learning, shares her perspective since working at the college for 4 plus years: "Longer standing colleges have been surpassed by LPTC's effort in caring for the students' needs and obstacles in gaining their college education." Loretta spoke about the college providing solutions to those without childcare, transportation and funding issues solved with programs provided like Hi-Flex, the CTE Program and free tuition. "The college tries to do everything possible for the students

to be successful. On top of free tuition, scholarships awarded and Pell grants going directly to the student. Compared to other colleges previously worked at, LPTC takes care of their students."

Different perspectives from staff members to students confirm the positive impact of LPTC's growth throughout the years. Stephenie Shirley of the Navajo Tribe, who is currently attending her 2nd year at Little Priest, affirms Brobergs claims of LPTC: "Attending College here is really helpful because I didn't think I would be going back to school, the resources available such as housing, the CTE Program, free tuition and a computer ease most obstacles. Instructors are flexible with real-life situations. Having smaller class sizes gives us opportunity to get more instructor time for help & understanding, it's individualized."

On top of celebrating their 25th anniversary, the college received a 1.7 million dollar grant from the US Department of Education to start a Native American Language Resource Center! The new "Midwest Native Language Resource Center" at LPTC will be the only tribal college in the USA to receive this funding. Besides tribal colleges, LPTC is one of four colleges in the country to receive this grant. The funding is expected to last 5 years. This resource will not only preserve our HoChunk Language but the Omaha, Lakota and Dakota languages as well. Although this e-learning platform is in the early production stages, language preservation will soon be another resource added to LPTC's list of accomplishments in 2023.


for parents of young children.



SUICIDE IN INDIAN COUNTRY PART 36

It's likely that the overwhelming life events, stress, and depression that led to your suicide attempt affected your ability to enjoy life. Struggling with suicidal thoughts can be exhausting and leave you with little energy to do the things you once loved. It also can put stress on your relationships with friends and family. The irony of depression and suicidal thinking is that they may cause you to give up the things that help you feel better, just when you need them the most.

Even up until the moment of their attempts, many suicide attempt survivors report that there was an internal struggle going on inside them. One side argued that suicide was the best way to end the pain they were experiencing. The other side struggled to find another way to feel better. To put it another way, most people with suicidal thoughts had reasons for dying AND reasons for living.

Before your suicide attempt, you might have lost connections to your reasons for living, but it's important to re-establish those connections because they can help instill hope. They can remind you about the things you love in life. Personalizing this can help remind you of where you were before you started to feel suicidal and where you would like to be again.

Who are the important people in my life?

What are my plans for the future? What things have I always wanted to do in life?

What have I come to believe about suicide?

What are the things I cherish in life?

What things do I enjoy doing? What did I used to enjoy?

What gives me a sense of purpose in life?

What are my other reasons for living?

You might still have thoughts of suicide after your attempt, even if you've decided that you want to stay alive. Perhaps the pain that led to your suicide attempt is still there. It's okay to have suicidal thoughts. Everyone needs to feel relief from unbearable pain, and suicidal thoughts may be one of the ways you've learned to cope. What's important is that you don't act on those thoughts and that you try to find other, safer ways to ease your pain. A safety plan can help you do this.

What is a safety plan?

In times of trouble, you may not see that you have options other than harming yourself. A safety plan is a written list of coping strategies and resources to help you survive a suicidal crisis. A safety plan can help you discover other ways to ease your pain so you don't feel tempted to act on suicidal thoughts you may experience.

Your plan will be a personalized list of strategies to help you cope. You can use these strategies before or during a suicidal crisis. By writing them down, you'll always know what they are, even if you're upset or not thinking clearly.

You can complete your plan by yourself or with the help of a counselor, peer,

family member, or friend.

Pursuant to NDEE Title 118 - Ground Water Quality Standards and Use Classification, public notification and opportunity for comment is hereby given of the following:

- 1. On or about August 4, 1998, a petroleum release was identified originating from a storage tank system located at 202 Osborne Avenue, Winnebago. An approximate legal location is SE1/4, NE1/4, SW1/4, Section 12, Township 26N, Range 08E, Thurston County.
- 2. Follow-up investigation identified the effects of the release and led to the remedial actions proposed by NDEE. The investigation resulted in a determination that this ground water contamination event is defined as remedial action class one.
- 3. The source of the release has been removed. A Risk-Based Corrective Action (RBCA) 1 assessment was conducted. The assessment indicated the presence of dissolved petroleum compounds in ground water. The contaminant concentrations found were below the numerical levels used by the RBCA process to establish a need for further investigation or remediation. Based on the current site conditions and property use, the NDEE has determined that no further remedial action is necessary due to the lack of threat to human health or safety.
