## Fischer Introduces Bill to Return Improperly Seized Army Corps of Engineers Land Back to Nebraska's Winnebago Tribe

WASHINGTON, D.C. – This week, U.S. Senator Deb Fischer (R-Neb.) led the introduction of the Winnebago Land Transfer Act. The legislation would transfer approximately 1,600 acres of land back to the Winnebago Tribe of Nebraska that were illegally seized in the 1970s by the U.S. Army Corps of Engineers for a proposed recreation project that was never started.

In addition to Senator Fischer, the legislation is cosponsored by U.S. Senators Pete Ricketts (R-Neb.), Chuck Grassley (R-Iowa), and Joni Ernst (R-Iowa).

"The U.S. Army Corps of Engineers was wrong to seize this land through eminent domain in the 1970s. After decades of inaction, it's time for us to make this right. My legislation will return this land to the Winnebago Tribe of Nebraska, and I look forward to getting this bill to the President's desk," said Senator Fischer.

"The Army Corps of Engineers' decision to condemn and seize land from the Winnebago Tribe of Nebraska was a classic case of government overreach. My colleagues in the Nebraska and Iowa delegations and I want to see this wrong corrected, and the land returned

to the Winnebago people," said Senator Ricketts.

"The introduction of the Winnebago Land Transfer Act by Senators Fischer, Ricketts, Grassley, and Ernst is a historic and beautiful moment for the Winnebago people. We have been waiting for this wrong to be made right, and we are grateful for the leadership demonstrated by our congressional delegation. We look forward to the passage of this important legislation," said Winnebago Tribal Chairwoman Victoria Kitcheyan.

### Background:

The Treaty of 1865 established the Winnebago Reservation in northeastern Nebraska along the Missouri River. Due to westward shifts in the river, portions of the reservation are now in Iowa.

In 1970, the U.S. Army Corps of Engineers (Corps) was performing stabilization efforts on the Missouri River's banks and condemned land on both the Nebraska and Iowa sides of the river for a proposed recreation project. The condemned land included tracts of reservation land in Iowa. The Corps filed eminent domain proceedings to acquire the land, triggering years of legal

challenges.

Ultimately, the Nebraska tract of land was returned to the Tribe. However, both tracts of land in Iowa that were illegally taken remain under the Corps' jurisdiction today and are maintained by the Iowa Department of Natural Resources (DNR). Neither the Iowa DNR nor the Corps has objection to the Tribe regaining control of the land. The latest renewal agreement of the license between the Iowa DNR and the Corps includes a provision that anticipates the return of the land to the Tribe.

Senator Fischer's Winnebago Land Transfer Act would transfer administrative jurisdiction of the approximately 1,600 acres from the Army Corps of Engineers to the Bureau of Indian Affairs to hold in trust for the Winnebago Tribe of Nebraska.

U.S. Representative Randy Feenstra (R-Iowa) introduced the House version of this legislation in February. In addition to Congressman Feenstra, the legislation is cosponsored by U.S. Representatives Mike Flood (R-Neb.), Adrian Smith (R-Neb.), Don Bacon (R-Neb.), Zachary Nunn (R-Iowa), Sharice Davids (D-Kan.), Mariannette Miller-Meeks (R-Iowa), and Ashley Hinson (R-Iowa)

## WCHS Offers Eye Care Screening

Winnebago, NE –Winnebago Comprehensive Healthcare System is proud to announce our Joslin Vision Network (JVN) screening services in partnership with Phoenix Indian Medical Center Ophthalmology. JVN is an innovative retinal imaging device designed to detect these vision problems early on.

Diabetes occurs when the body's pancreas cannot make enough insulin or doesn't use it as well as it should. Insulin helps the body convert sugar into energy. When a diabetic person consumes sugars, and this process is not functioning correctly it causes too much blood sugar to stay in the bloodstream. When mismanaged over time, diabetes causes damage to blood vessels in the heart, eyes, kidneys, and nerves that can lead to serious health problems leading to everything from stroke, amputation, and kidney failure to permanent vision loss or blind-

ness. This makes regular retinal imaging and monitoring of vision changes even more critical for diabetes and prediabetes patients.

"We are always looking to find new innovative ways to help support and find early interventions for our relatives. This JVN machine allows our staff to take a look into our relative's eyes and it could be said that this is a window into what could be happening in their kidneys. This will allow us to help our relatives sooner and that is what we are all about; prevention and intervention." says Dr. Mona Zuffante, Chief Public Health Officer.

WCHS sought out solutions to providing additional retina screening services that could be available Monday-Friday 8:00 – 4:30 PM and help increase access to care in our community. By using this new JVN specialized camera in collaboration with Optometrists at Phoenix Indian Medical Center Ophthalmology, we are able to better support members

of our Wa I pi nagu Program, which is Ho-Chunk for "the Path to Good Blood" Program. When patients come to WCHS for their appointment, our trained technician will guide them through the process of getting a photo of their retina, attaching it to their electronic health record to transmit it to Phoenix Indian Medical Center, and then working to communicate with the provider results, send patient letters, and schedule/coordinate any recommended follow-up appointments.

"The process is simple, easy, and painless. We have already offered 50 screenings and we are not stopping there." Wa I pi nagu Program nurse, Michele Smith, "The Indigenous people we serve are at the heart of everything that our team does. At the end of the day, it is always about what is best for our people and how can we elevate our programs in order to meet the needs."

## JESUS OUR SAVIOR LUTHERAN OUTREACH

*"A better person"*

'Knowing him made you a better person.' That is what I said at the funeral service of James Louis 'Louie' LaRose. Louie certainly made me a better person. He taught me many things including how the Ho-Chunks enjoy teasing. I was on the receiving more often than not with him.

Louie was what I call a visionary. He knew the past but did not dwell in the past or use it as an excuse for one's fate or lot in life. Rather he made plans to move forward toward goals that became realities for a better future for him, his family and his tribe. One example was his vision in having the Ho-Chunk tribe take over higher education and establishing Little Priest Tribal College.

Louie also taught me how his people relate to the bison in so many ways. Mauna made the bison as a strong animal which survived many hardships over the centuries. These powerful animals with their herd mentality have specific role for each bison of the herd, male and female.

Louie would come with his 'bison box' and share with our preschool children each year about all of the blessings that came from the bison. He told me of a time when he went to harvest one of the buffalos; it might be one he named 'soup.' This bison came and stood alone while Louie said a prayer to Mauna. Then with one shot the bison went down. The rest of the herd came by and attempted to nudge the fallen bison back to life, but to no avail. This bison had offered up his life for the good of others.

This natural cycle of life story has a parallel with the life of Jesus. Jesus was willing to offer his life on behalf of

mankind. As the hide of the buffalo was made into a robe so too Jesus offered others a robe of his righteousness to cover the sin and the shame of us sinners. However, there is one major difference - Jesus rose from the dead to offer forgiveness, life and salvation to those who believe in him.

Knowing Jesus makes you a better person! First, by the grace of God, one who knows Jesus (having faith in him) then has peace with Mauna, having had his sin paid in full. Such a person humbly extends forgiveness to others. Louie's life had been transformed by the grace of God and he was able to extend this kindness to his family and to others that he met along life's way.

I close with the words from God's Sacred Word that I read at Louie's funeral:

'Therefore, since we have been justified by faith, we have peace with God through our Lord Jesus Christ. Through him we have also obtained access by faith into this grace in which we stand, and we rejoice in hope of the glory of God. Not only that, but we rejoice in our sufferings, knowing that suffering produces endurance, and endurance produces character, and character produces hope, and hope does not put us to shame, because God's love has been poured into our hearts through the Holy Spirit who has been given to us. For while we were still weak, at the right time Christ died for the ungodly' [Romans 5:1-6 ESV].

Louie knew Jesus - he had been baptized in the name of the Father, and of the Son, and of the Holy Spirit. Louie knew the love of Jesus. Some of my last words to Louie were "Jesus loves you and he promised to be with you always!"

### JAMES LOUIS LAROSE

James "Louis" LaRose passed away November 7, 2023 at Mercy Hospital in Sioux City, Iowa. He was 81 years old. Louis was a member of the Winnebago Tribe of Nebraska and the Bear Clan. His Winnebago name was Xatap Horajega "Travels in Bush."

Louis was born January 25, 1942 in Winnebago, NE to Anna Bess Mallory LaRose.

He moved to the Ute Reservation in Fort Duchesne, Utah when he was 1½ years old. He returned to the Winnebago Reservation at age 15 and graduated from Winnebago High School in 1960. He graduated from Phoenix Junior College and Cook Christian Indian Training School. In 1968 Louis graduated from Bethel College in North Newton, Kansas with a bachelor's degree in education.

Louis returned to the Winnebago Reservation after graduating from college at age 26 and was elected to the Winnebago Tribal Council. He then became Tribal Chairman at age 28. Louis returned to the Tribal Council in the early 1990s, was appointed in 2015 and elected to Tribal Council again in 2019.

While Louis was Chairman the Army Corps of Engineers seized land from the Winnebago Reservation in Iowa and Nebraska for a proposed recreation project. The Tribe successfully challenged the Corps eminent domain proceedings and the federal courts held the Corps could not take the land in light of the Tribe's treaty rights. The case went to the Supreme Court, and the Tribe prevailed. However, the Tribe continues to fight for the return of the land, and Louis worked on lobbying for a bill that was recently introduced in Congress, the Winnebago Land Transfer Act of 2023, to return the land to the Tribe.

Louis then worked on two bills in the Nebraska Legislature requiring repatriation of Native remains and burial goods and retroceding state Public Law 280 jurisdiction over the Winnebago Reservation. Louis worked with Robert Peregoy and James Botsford on both bills and with Walter "Bunky" EchoHawk on the repatriation bill.

Louis' interest then turned to restoration of the bison to the Winnebago Reservation. He brought a herd of bison to the Reservation and established the Tribal Bison Program. He served for a number of years as Chairman of the Intertribal Bison Cooperative, now known as the Intertribal Buffalo Council, a national organization that advocates on behalf of and provides

support to tribal bison programs, including facilitating the donation and transport of bison to tribal bison programs.

In the early 1990s Louis helped develop and operate WinnaVegas, the Tribe's gaming operation in Iowa, which has become an important source of revenue and employment for the Tribe.

In the 1990s at the request of the Native American Rights Fund Louis became one of the named plaintiffs in the Cobell litigation challenging the Bureau of Indian Affairs administration of individual Indian money accounts. After many years, the litigation was successful, and Congress enacted a bill settling the litigation in 2010.

Louis believed education was an important means for Indian people to improve their lives and communities. He helped establish the Nebraska Indian Community College in the 1970's on the Winnebago and Omaha Reservations. The Winnebago campus later became Little Priest Tribal College, and Louis served as President of Nebraska Indian Community College and Little Priest Tribal College. Along with other tribal college presidents, Louis successfully lobbied for a congressional bill providing funding for tribal colleges. He was a founding member and served as Vice-Chairman of the American Indian Higher Education Consortium, which advocates for tribal colleges.

Louis served on the steering committee of the Native American Rights Fund for six years. He served as a mediator and on the Dispute Resolution Council with the Office of Dispute Resolution of the Nebraska Court System. In the 1970s Louis served as Chairman of the Nebraska Indian Commission. In 2013 Louis received the Chief Standing Bear Humanitarian Award from the Nebraska Commission on Indian Affairs.

Louis is survived by his wife Anita, daughters Carla, Peggy and Vanessa, several grandchildren and great-grandchildren, his brother Kenny and sister Kathy and numerous nieces and nephews.

Louis was grateful to his mentors, Sterling Snake and Felix White Sr., who provided guidance on tribal issues.

Louis liked to spend time with his family, attend to his children and grandchildren's games and events, hunt, grill, garden, read, watch the news and sports, crossword puzzles and do presentations on the buffalo.

My Ho-Chunk name is Hakikóx Walu Piga—"makes his way." I am Bear Clan, my parents are Marc and Elizabeth Mallory, and my Choka is Kenny and Twila Mallory.

On November 7, 2023, the Winnebago people suffered a tremendous loss. No words can capture the depth of pain, the shattered pieces of a broken heart, or the unbearable sorrow that comes from death. Everything falls flat.

His is a colossal loss. For us, for the Winnebago tribe, and for Indian Country at large.

My Dega Louie was a wonder. He was a Choka, Jaji, Dega, husband, brother, and friend. A natural leader who spoke truth and walked with integrity. His humour disarmed his foes and his grace transformed his friends.

One memory I hold particularly dear is from an afternoon in July when I was studying for the bar examination. I was stressed and overwhelmed and I needed a calm and steady voice. Dega Louie was that voice.

He sat down with me in his kitchen and we recorded over four hours of his stories. I remember being in awe of his wit, his acumen, and his grace. His acknowledgement of our traumas but also our resilience as Native people.

I will miss so much about him. I'll miss hearing him call me chunshkeh whenever I was home for powwow. I'll miss hearing him tell stories at a slow and perfect pace. I'll miss the twinkle in his eye whenever he cracked a joke.

When my Jaji died... people only ever spoke to me about his death in an indirect way. It may have been the circumstances or the general phobia surrounding death. But all I ever wanted was for someone to say that they were sorry for what had happened to us.

So to you, Aunt Nita, Peggy, Nessa, and Carla, and to my beloved cousins, I'm so sorry. I'm sorry for a crushing and unspeakable loss. I'm sorry for questions that have no answers and pain that has no end.

I hope you'll find a small measure of peace knowing his legacy of love will live on in you and in your children and in your children's children.

We love you, Dega Louie. I know we will never stop missing you, and that you will never stop loving us.

May you forever run with the buffalo—uninhibited and free.

### OMAHA PUBLIC POWER DISTRICT (OPPD) NOTICE TO CONTROL VEGETATION AND PERFORM TRANSMISSION LINE MAINTENANCE ON WINNEBAGO/OMAHA TRIBE ALLOTMENTS DECEMBER 2023 THROUGH APRIL 2024

Omaha Public Power District (OPPD) is committed to maintaining the safe and reliable operation of its electric transmission system which includes controlling vegetation growth. Federal, regional and electric industry regulations and standards require continuous maintenance and minimum safety clearances to ensure vegetation does not touch high-voltage overhead transmission lines. If vegetation located in a transmission right-of-way is not compatible with the safe operation of the system, it can result in widespread electric power outages and/or unsafe conditions for the public.

OPPD and/or its partnered contractors will be accessing transmission line right-of-way to perform the necessary vegetation management including, but not limited to, trimming and removing trees, mowing, applying herbicide, and eliminating hazardous tree/power line conditions. Herbicides used are tailored to land use and vegetation in the area, and will not harm other vegetation or nearby crops. OPPD may also trim trees adjacent to the right-of-way to eliminate trees that could potentially fall within 15 feet of power lines. Right-of-way widths in the area depend mainly on the size of the power line and typically range from 80 to 150 feet.

As part of this work, OPPD and/or its contractor/s will be accessing transmission line right-of-way to perform necessary maintenance work including various repairs, structure replacements and inspections. Inspections include assessment of the condition of poles, wires, insulators and hardware. This work allows OPPD to continue to provide safe and reliable power.

Work is scheduled for December 2023 through April 2024.

## Winnebago Domestic Violence Program News:

Hello, my name is Dorcee Kearnes, I am the new Culture Planner DV/SA Advocate for the Winnebago Tribe Domestic Violence program under WCHS. According to Statistics from Women against Crimes, domestic violence increases over the holidays, for several possible reasons:

Stress from holiday shopping, finances, and planning can aggravate volatile personalities.

Abusers are more likely to partake of alcohol or drugs when they don't have to work. Abusers are home alone with their victims more than other times of the year.

Recognize the warning signs of abuse

Physical:

Bruises or cuts that are worse than their explanations.

Wearing inappropriate or unusual clothing to cover up.

Emotional:

Being unusually quiet, withdrawn, or even fearful.

Anxiety or apprehension, especially when away from the abuser.

Depression or discussion of suicidal thoughts.

Development of a drug or alcohol problem.

Changes in activity:

Being late or canceling last minute more often than usual.

Needing to "ask permission" to go or communicate with friends.

Avoiding parties or other activities they used to enjoy, especially with friends and family.

Lack of money or access to resources because partner has control of it.

The abuser's behavior may be the biggest red flag for you that your friend or family member is in danger. Keep an eye out for these red flags from survivors:

Excusing abusive behaviors as "moody" or "needy"

Minimizing the abusers use of drugs or alcohol.

Jealousy or accusations of infidelity from partner.

Constant "checking in" via texts or phone calls from partners.

Partners accompanying survivor to events unnecessarily.
