BLIZZARD!

The week of January 7th, 2024, saw a tremendous amount of winter activity. Following a two-day blast early in the week on Monday and Tuesday, on Thursday, January 11th, 2024, a fierce round of severe weather began which held Winnebago in its grip for several more days.

The National Weather Service issued a Severe Winter Weather Warning for the local region as snow began to fall by late afternoon on Thursday 1/11. Winnebago officials called off worksite attendance at 1:30 p.m. in anticipation of the impending blizzard activity. The move may have saved many from facing the rapidly deteriorating road conditions that arrived late on that day.

After barely coming out from the winter storm which ravaged the region earlier in the week, this second round of storms

completely covered in ice and snow. With deadly winds accompanying the storm, the blizzard created white-out conditions on all local roadways bringing all travel to a complete halt. Both Friday 1/12 and Saturday 1/13 saw the storm refuse to let up. Nebraska roads crews were pulled from all East / West corridors as the winds and drifting was just too treacherous. Local Highway 35, for example, was closed while travel became impossible along that route.

Shuttering the tribal operation for yet another round of days, this major storm also wreaked havoc on the tribe's casinos. WinnaVegas was forced to close over the weekend due to the blizzard conditions, and Iron Horse Casino in Emerson was closed as well. Both properties were inaccessible for days while road crews worked to catch up to the devastating snow, drifting snow & ice that covered the area.

Accompanying this storm were dangerously low temperatures. Bottoming out at -21* below zero, with wind chills made sure anything left out would be approaching -50* below zero, the winter needed.

storm also carried with it a life-threatening blast which lasted over the entire weekend and into the following Monday. Local road clearing kept going, however, as all crews in and around Winnebago worked extended hours despite the extreme conditions.

"I'm extremely grateful for all who worked to keep us mobile." said one local tribal member. The Winnebago Tribal Council held a special meeting on Monday, January 15th, 2024, to update the community on the plans for helping the membership deal with the relentless cold, even though the snow had finally stopped. Heating options were contemplated for all tribal operations, and a warming shelter was also established at the Whirling Thunder Wellness Gymnasium for those finding themselves in need.

2 DAY STORM SHUTTERS WINNEBAGO

A powerful winter storm blasted Winnebago and the surrounding area beginning early Monday morning (1-8-2024) causing the Winnebago tribal organization to close its doors over the 2-day stretch. Packing quite a wallop, the storm lasted for nearly 48-hours, dumping as much as 14" inches of snow across the region. The National Weather Service (NWS) predicted the severity of this storm as being the greatest potential snow fall seen in over a year.

Coming in several waves, the snow fell in substantial amounts during the entirety of the two-day period. Monday saw the first round of this frosty precipitation, leaving around 6" inches on the ground. Yet the storm continued after a brief pause and dumped another 8" inches by the end of the day on Tuesday (1-9-2024). Temperatures held around just below freezing, allowing more snow to accumulate. The winds which normally accompany such storms were largely held at bay until late Tuesday.

Tribal roads personnel and local snow removal crews began working early in the morning on Monday to keep up with the falling snow. Travel was not advised as the highways were nearly impassable. However, by sundown on the 8th, accessways in and around Winnebago were cleared enough to allow some travel to begin. "This is the most snow we've seen in a while!" said one


member of the clearing crew. Local socialite, Wm. "Bill D" DeCora, offered a suggestion during the midst of the storm via his social media. Commenting on the dedication of the crews, his idea was to supply a warm meal to those working out in the cold. By resolving some logistical issues, the idea could be a promising one to follow up with. Regardless, the dedication of the Winnebago snow removal crews does not go unnoticed, and our appreciation for the demanding work is much appreciated.

Winter 2024 has arrived. The NWS predicts even more snow and below zero temperatures in the coming days.

Her lengthy career also saw activity with the Winnebago Public School, HCCDC, and the NE Center for Rural Affairs. The Winnebago Tribe of Nebraska Sues U.S. Army for Return of Remains of Children from Infamous Carlisle Boarding School

[Alexandria, Virginia]—January 17, 2024—Today the Winnebago Tribe of Nebraska sued the U.S. Army in federal court seeking repatriation of the remains of two children who died at the infamous Carlisle Boarding School. Carlisle provided the blueprint for more than 400 other schools designed for cultural genocide by stripping Native children of their Indigenous culture under abusive conditions that led to the deaths of thousands of children and subsequent maltreatment of their remains.

The lawsuit focuses on the Army's refusal to follow the federal Native American Graves Protection and Repatriation Act ("NAGPRA"). Congress passed the law in 1990 to end the dehumanizing robbery, desecration, and general exploitation of Native American burial sites and human remains by museums and federal agencies, including the Army. The Army's one-time official policy encouraging digging up Native American burial sites for study was a central cause behind the law. Instead of following NAGPRA to repatriate remains from Carlisle, the Army has been forcing Tribal Nations to follow a toothless process of the Army's own design, which contains none of the rights and protections for Tribal Nations granted by Congress.

In September 1895, Army officials removed Samuel Gilbert and Edward Hensley from their home in Nebraska and sent them to Carlisle. Like so many other Native children forcibly sent to federal Indian boarding schools, Samuel and Edward would never return home. Samuel died merely forty-seven days after arrival. Edward died four years later. The school kept news of the boys' deaths and burials from the families and Winnebago. According to Winnebago's traditional beliefs Samuel's and Edward's spirits will remain lost until they are returned home and laid to rest in accordance with Winnebago's customs.

"As a mother and grandmother, I stand for Samuel and Edward, knowing that their parents and grandparents were never able to properly bury them and send them on their final journey," said Sunshine Thomas-Bear, NAGPRA representative and Tribal Historic Preservation Officer for Winnebago.

At least 177 other children died and were buried at Carlisle before the United States government shut down its school because of the children's deaths, reports of extensive physical and emotional abuse, and rampant financial corruption. Thereafter, the Army completely neglected the cemetery, only returning its attention to dig up and remove the children's remains to make room for base expansion. The hasty removal resulted in the loss and degradation of many remains. Today, the Army uses the collection of remains and the cemetery as a tourist attraction.

Victoria Kitcheyan, Chairwoman of Winnebago, stated: "The traditional name for the Winnebago people is 'Ho-Chunk,' which translates to 'the big voice.' As we have always done, we will use our voice to hold our federal partners accountable for undermining NAGPRA and diluting the protections it guarantees to all Tribal Nations. Many leaders before us fought for that law and we will carry the battle forward."

Federal Indian boarding schools, some of which operated as recently as 1969, were aggressive in their mission to sever familial, cultural, and traditional ties between Native youth and their tribal communities. The cultural genocide has inflicted incalculable intergenerational trauma and continues to pose immense challenges to the welfare of Tribal Nations' communities, cultures, governments, and economies.

Winnebago has filed suit in the U.S. District Court for the Eastern District of Virginia. Winnebago is represented by its general counsel at Big Fire Law & Policy Group LLP, and by legal counsel at the Native American Rights Fund (NARF) and Cultural Heritage Partners, PLLC (CHP).



Did you know that one famous HoChunk veteran had an airport named after him? January 19th marks the 105th birthday of Joshua Decorah Sanford. Born in 1919 to his parents, Herbert Sanford and Maude Decorah Sanford grew up in Wisconsin, attended Viroqua High School, and later studied at the University of Wisconsin.

He later joined the Army Air Corps serving during World War II. In the war Sandford flew as a combat pilot in Asia in the China-Burma-Indian theater with the 75th Fighter Squadron, 23rd Fighter Group, 14th Air Force. Credited with 102 combat missions, he was shot down or ditched 12 times, and was wounded twice. Reaching the rank of Captain during his service, Sanford led other airmen, even serving as unit commanding officer. For his heroism and service, he was decorated with two Distinguished Flying Crosses, two Air Medals, the Purple Heart, five campaign ribbons, along with presidential and unit citations. After the war he finished his education and worked as an electronics engineer in Chicago, later returning to Wisconsin and opening his own business. He married and had two children with Rosemary Bertz. He would later manage an airport, serve as a factory representative, and serve as Southwest Wisconsin's Civil Defense Director. He would pass away in 1962, from apparent complications from war wounds. In 1993 the town of Hillsboro, WI named their airport in Sanford's honor. He was also inducted into the Wisconsin Aviation Hall of Fame in 2018.

"Birth of Jesus from devil's perspective"

Have you ever wondered what the devil thought about the birth of Jesus?

Where can one turn to learn of the devil's perspective regarding the birth of God's Son? It is not recorded by any one of the four Gospel writers. Instead we turn to the twelfth chapter of the revelation of Jesus Christ:

'And a great sign appeared in heaven: a woman clothed with the sun, with the moon under her feet, and on her head a crown of twelve stars. She was pregnant and was crying out in birth pains and the agony of giving birth. And another sign appeared in heaven: behold, a great red dragon, with seven heads and ten horns, and on his heads seven diadems. His tail swept down a third of the stars of heaven and cast them to the earth. And the dragon stood before the woman who was about to give birth, so that when she bore her child he might devour it' [Revelation 12:1-4) ESV].

Jesus revealed to John, one of his beloved disciples, this vision of the dragon - identified later, in verse nine, as the devil and Satan. The devil was an angel who had rebelled against God and led Adam and Eve into eating the forbidden fruit in the garden of Eden. Satan is another name for the devil which means 'adversary.'

The dragon tried his utmost to destroy his enemy, that is, the Christ child when the woman gave birth. The dragon, that is the devil did not immediately attack baby Jesus at his birth, but would seek an opportunity to end the life of the Christ child.

Months later that opportunity came. The devil incited King Herod the Great into action, following the visit of the Magi. Due to his jealousy at the birth of the Christ child, King Herod sent his soldiers to kill the infant boys in Bethlehem under the age of three. But Joseph, Jesus' step-father, had been warned in a dream and led his family to safety in Egypt.

The devil hated the Christ child who would ultimately crush his wicked head. The birth of God's Son was the beginning of the end of the devil's earthly reign. Throughout Jesus' life the devil looked for opportunities to tempt Jesus to sin, but time and time again the devil failed.

The devil's attack on Christ sending Jesus to the cross would lead to the devil's own demise, for through Jesus' death and resurrection the devil was crushed and defeated. Today the devil does his worst to downplay the birth of Jesus - undermining God's greatest Christmas gift.

The devil cannot harm Jesus who sits at the right hand of our Creator. However, the devil attacks those who take on the name of Jesus Christ. SUICIDE IN INDIAN COUNTRY PART 38

What should you do with your plan?

Your plan is for your use, but it's a good idea to share it with a few other people. Your support person and backup person can do a better job in times of crisis if they have your most recent copy. If you're using a paper safety plan, you may want to keep multiple copies in various places so it's nearby whenever you need it. Your safety plan may change over time. You can add information to it in the future as you identify more triggers or want to change the names of contacts. You wouldn't want to search around for information in a crisis situation, so it's a good idea to keep contact information up-to-date.

There's one more thing about your safety plan that's very important—you have to actually use it! It's important to think about ways you can use it when you're afraid your suicidal thoughts might escalate to suicidal actions. For this reason, it should contain items and ideas that work for you, not things you feel others are forcing you to do. If you don't like the options or you feel they're unrealistic, say so. If you can't find options that are right for you, this may indicate that you need more support until you feel comfortable that you can stay safe. You may want to ask yourself:

How likely am I to use this plan when I'm feeling unsafe? What might keep me from sing it? Is there anything about the plan that makes me uncomfortable?

With whom might I share my safety plan? Where will I keep my safety plan to make sure it's nearby when I need it?

What can I do to make it more likely that I'll use the strategies in my plan to stay safe? Examples include: keeping multiple copies close by, sharing it with others who will encourage you to use it, ensuring that you're comfortable with the contents, practicing using it, and talking with someone about how practicing went.

Suicide attempt survivors and researchers who study suicide recommend professional help as your best bet for finding long-term strategies to ease the emotional pain that led to your attempt. And, of course, if you're in less pain, you're much more likely to experience joy and be motivated to keep yourself safe.

Making a decision to go to therapy can be intimidating. You might worry that it will be uncomfortable or that it could lead to hospitalization, but most people who give it a try find it really helps. When looking for a counselor, it might be difficult to know where to start. It's always smart to ask others which counselors in your area have good reputations. Your doctor or the people that helped you in the emergency room might have suggestions.

Call the National Suicide Prevention Lifeline (1-800-273-TALK (8255). Lifeline crisis workers know their local communities and may help be able to refer you to a counselor or support group in your area. Crisis workers are also available to talk with you about your suicidal thoughts until you find other sources of support.

MOVIE REVIEW: SELF RELIANCE

"Self Reliance in a HULU World"

Streaming media has long since entered the fray of distributing Hollywood hits and HULU is certainly in the mix. A recent release on the streaming platform, a project titled Self Reliance gives us our first chance to review films watched primarily at home. As shown now on HULU, the still growing media presence has much to offer and there will be many more to come.

Self Reliance, our first movie reviewed, premiered in March of 2023 at the famed South by Southwest (SXSW) festival, according to Wikipedia. In the director's chair is character actor, Jake Johnson. Most famously known for his roles in television shows like New Girl (2011-2018) and blockbuster movies such as Spiderman: Into the Spider-Verse, the Midwest born 45 year-old directs a gem of a movie, and stars as its main character as well.

Tommy, (Johnson) is our protagonist who finds himself living a life not too noteworthy of anything special. Approached by SNL alum, Andy Samberg, who also plays himself, an offer is made that Tommy just cannot refuse. Samberg's classic comedic detachment gives his scenes their own feel. Tommy is given the choice to play a game that could win him \$1 Million dollars, or could kill him. Bored with his life, Tommy takes the chance to play and the story ensues.

Playing the love interest of sorts, Maddy, Anna Kendrick (Twilight/Scott Pilgrim/ Pitch Perfect) finds herself in the game as well. The duo explores their way across the 30 days allowed to try to stay alive, opening the storyline to many moments both light and dark. Kendrick's performance is one that has become a hallmark of her movies, giving a deepened aspect played against the mania of Johnson's Tommy. I enjoyed watching her character develop alongside Tommy's.

Featuring cameo appearances by Wayne Brady, NBA player Boban Marjanovic, & Hollywood legend Christopher Lloyd, Self Reliance moves at a good pace. Accompanied by a soundtrack contributed by Dan Romer (Luca [Pixar] / Far Cry 5 [UbiSoft]) the story has few low points. Also written by Johnson, the character mix finds the balance between typical relationship dynamics, and the absurdity related to playing the game.

In the end the story reaches its goal as our characters portray their performances in ways that have you cheering for all involved, knowing some happy endings came to pass – including a dental mishap being corrected. Johnson's first time in the Director's chair is a good one. His ability to lead the cast and to capture their meaningful performances depicts a growing talent sure to lead to more.



Winnebago Tribe of Nebraska Request for Proposal (RFP) for a Tribal Hazard Mitigation Plan

Background Information

The Winnebago Tribe of Nebraska ("Tribe") is announcing a request for proposal ("RFP") for creation of the Tribal Hazard Mitigation Plan.

The Tribe is seeking a qualified consultant ("Consultant") with expertise in creation of Tribal Hazard Mitigation Plan who has completed similar work in the past (See Scope of work for details). Consultant will work collaboratively with Tribal Emergency Management Coordinator.

The Tribe is federally recognized and organized under the 1934 Indian Reorganization Act. The Winnebago Indian Reservation is primarily located in Thurston County, Nebraska in Northeast Nebraska with Tribal offices located in Winnebago, Nebraska.

Scope of Work

The proposed planning project will consist of developing a Natural Hazards Mitigation Plan encompassing the entire Winnebago Tribe of Nebraska's Tribal lands. The development of a Tribal Natural Hazards Mitigation Plan is essential to the Tribes' efforts towards improving the overall emergency Hazard Mitigation Plan - preparedness and

identifying ways to mitigate the impacts of future natural hazards. The following scope of work provides details on all proposed tasks associated with the development of a new Trial hazard mitigation plan for the Winnebago Tribe of Nebraska. The plan will also integrate FEMA's Community Rating System (CRS) requirements for floodplain management planning (CRS Activity 510) in order to maximize potential future credit points for the Tribe, per the 2013 CRS Coordinator's Manual. An HAZUS analysis of all local natural disasters will be required as part of the plan. The consultant shall be responsible for developing the Plan with the Emergency Management Coordinator. The Plan shall incorporate input from the public and stakeholders, including the Local Planning Team (LPT) that the Tribe will formulate at the beginning of the project, collected during public outreach conducted by the Tribe in collaboration with the consultant.

Contents of Proposal
