Indianz.com... More tribes join effort to halt completion of Dakota Access Pipeline

The fight over the Dakota Access Pipeline is entering a crucial phase as tribes and their citizens place their faith in a system of justice that hasn't always addressed their concerns.

In a brief highlighting the federal government's long history of troubled dealings with the first Americans, the 16 tribes of North Dakota, South Dakota and Nebraxska urged a federal judge to halt construction on the final portion of the pipeline. The Great Plains Tribal Chairman's Association said completion of the controversial project will cause "irreparable harm" to the rights promised in treaties that are regarded in the U.S. Constitution as the "supreme law of the land.'

"The approval of DAPL without fully involving the affected tribes and seeking their free, prior, and informed consent, and without considering treaty hunting, fishing, protectorate, and water rights is another in a long line of actions that place the interests of non-Indians above the interests of Native peoples of the Great Plains to the detriment of the tribes," the brief, which was submitted on behalf of the 16 tribes by the Native American Rights Fund on Friday, stated.

The filing wasn't the only one lodged on Friday. The Standing Rock Sioux Tribe formally joined the Cheyenne River Sioux Tribe in seeking an order that would block the final portion of the pipeline pending further consideration of treaties, sacred sites, water resources and other issues that so far have been ministration.

or hydropower – it has always been the tribe that has borne the heavy burdens, through the loss of our lands and harm to our way of life," Chairman Dave Archambault II said in a sworn declaration. While so much has been taken away by the misdeeds of the federal government, the tribe has survived, and we have an obligation to protect what remains for the

good of our children." And now that the Trump administration has approved the pipeline, both tribes are seeking to amend their original complaints to account for the latest developments. They argue that the decision by the U.S. Army Corps of Engineers to grant the easement for Dakota Access, along with the decision by the Department of the Army to cancel an environmental review of the final portion, constitute new actions that can be challenged in court.

We must take positive steps to see that our rights are not ignored by the federal government," Archambault stated in his declaration. "That is why we have stressed the importance of meaningful consultation regarding the Dakota Access pipeline. We must see that the federal government, which has solemn obligations under our treaties and under the trust responsibility, hears our voices, and protects our reservation and our way of life. As Chairman of the tribe, I have done all I can to advance these principles.'

Standing Rock is also supporting the addition of a new party to the lawsuit. Steve Vance, the historic preservation officer for Cheyenne River, filed papers on Saturday seeking to join the case on

religious freedom grounds. Mr. Vance is a sincere practitioner of the traditional Lakota faith," his atOahe will desecrate the waters such that they will be rendered unsuitable for use in the sacraments required by his religious faith, in particular the Inipi ceremony," they added, in reference to sweat lodge activities that depend on clean water from the Missouri River. Thanks to Republican President Donald Trump, who ordered an "expedited" review of Dakota Access just four days after taking office, the pipeline is set to cross the Missouri, or more specifically, go under the river. The wealthy backers of the project intend to start filling it with crude in 60 days and oil could be flowing along the entire 1,172-mile route in less

than 90 days. That is, unless Judge James E. Boasberg takes action on Indian Country's requests. So far in the litigation, he has twice refused to halt construction but that was before the Army Corps granted an easement for work in North Dakota and before the Army terminated the environmental impact statement, or EIS, that was ordered only two days before Trump was sworn in as the 45th president of the United States.

Boasberg is hearing arguments on Monday afternoon and could issue a decision at any time. If he refuses to halt construction, something he did last September, an appeal is possible.

The case already made one trip to the D.C. Circuit Court of Appeals but construction resumed without a full resolution of an injunction sought by Standing Rock. This time, both Cheyenne River and Standing Rock are pushing for action so presumably both would participate in an appeal.

On the other hand, if Boasberg grants some form of a restraining order or injunction, Dakota Access is vowing a challenge. The firm already missed a January 1 target date to start transport-

ing oil from North Dakota to Illinois.

"Dakota Access is not willing to agree with a further delay," attorney David Debold said during a February 6 hear-

Debold also offered a preview of the argument Dakota Access will make against attempts to halt construction. He contends the tribes are not harmed by drilling under the Missouri, or even the installation of pipe under the river, but by the movement of oil along that pipe. Since shipments aren't expected until 83 days at the earliest, he believes there would be no need for a restraining order or injunction at a sooner date.

"We don't agree that the drilling of the pipeline, the construction of the pipeline is harmless," countered Jan Hasselman, an attorney for Standing Rock.

The Army Corps, as the defendant in the lawsuit, has not yet disclosed its legal strategy going forward. But the Department of Justice is now under new leadership -- former Sen. Jeff Sessions (R-Alabama), Trump's pick for Attorney General, was sworn into office last week after being confirmed by the Senate on a vote that fell largely along party lines.

Monday's hearing takes place at 2pm Eastern in Courtroom 19 of the federal courthouse in D.C. It occurs as hundreds of tribal leaders and tribal

citizens are in the nation's capital for the winter session of the National Congress of American Indians.

Treaties are the supreme law of the land," NCAI President Brian Cladoosby said in a statement last week objecting to the approval of the pipeline. "To suddenly change the decision and issue the easement after already starting the legal process of preparing an environmental impact statement is arbitrary and capri-

Just hours before the critical hearing, Cladoosby is delivering the first State of Indian Nations of the Trump era. The event takes place at the Newseum, a private facility steps away from the federal courthouse.

"As we continue to stand together as indigenous people ... we can change our world thoughts, we can change what's happening to our water, our land and our people," LaDonna Brave Bull Allard, a Standing Rock citizen who founded the Sacred Stone Camp, the original #NoDAPL prayer site, said on Sunday from Minnesota where she was taking part in an inter-tribal water conference that drew allies from the U.S. and Canada.



Thoughts from the News... by Lance Morgan



I watch the news all the time now. Since Donald Trump has been elected the whole news has become a sort of giant reality TV show. I keep wondering what will happen next and who will be the winners and losers as his presidency plays out.

I am concerned about Indian Country. I wrote right after he won the election that the Dakota Access Pipeline would be approved as soon as he got around to it. He signed an executive order ordering the permits be issued within the first week of being in office. This was hardly a surprise, but it is telling how casually he dismissed the tribal people's concerns in favor of big business.

I think his favoring big business will be his guiding principle when it comes to tribal interests. I don't necessarily think he has any real negatives social thoughts on tribal people. In fact, I think he gives us very little thought at all. His only public comments were 20 years ago, when the tribal casinos in Connecticut were hurting his Atlantic City casinos. He went after the tribes making several negative and insensitive comments, but even this was likely

more motivated by his business interests than any overt dislike of natives.

I think we will likely be ignored on a few different levels. I used to call it benign neglect under President George W. Bush. Strangely under George W., the neglect was helpful in some ways. It allowed us to get into multiple internet businesses that were controversial. President Bush just didn't care enough to bother to stop Indian Country and his anything goes attitude towards business allowed a sort of free for all in some areas.

President Obama was open and caring on the social issues, but he was pretty harsh on tribal economic issues, targeting the online lending and tobacco businesses that had emerged under President Bush.

Under President Trump, I think the social issues might get a little lip service, but likely not much overall attention. It will be a little like benign neglect under President Bush. However, I think it will have a different twist. If a large company has an economic interest in the outcome, I think we should assume that tribal concerns and interests will not matter much in the scheme of things. We should assume protesting will not work. I suspect a large number of lawsuits will be filed over the next four years by tribes trying to get their voice heard.

Overall President Trump will be good for lawyers, indifferent on social issues and will favor large companies against tribal concerns. I think the best way to deal with it is to cultivate both Democratic and Republican members of congress to fight for our small share of the pie. My guess is that if our congressional representatives care enough then they can influence the process enough to at least help on the social issues and maybe balance the big economic ones.

In the meantime, Ho-Chunk, Inc. intends to keep growing and keep diversifying so that we have the ability to survive and thrive in any type of political environment.

"Anger Management"

There once was a warrior named David who made various raids on the enemies of his tribe. This warrior protected Nabal, one of his tribal members who was very wealthy and owned countless sheep. It was the time of shearing the sheep, in other words a very profitable time of year.

The warrior was responsible for feeding of his men and sent some of his men to make a humble request. They were to say: "Long life to you! Good health to you and your household! And good health to all that is yours!" They went on to request that Nabal please give your servants whatever you can find for them.

Nabal's answered David's servants. "Who is this David? Why should I take my bread and water, and the meat I have slaughtered for my shearers, and give it to meat coming from who knows where?"

Such a disrespectful response to one who had not mistreated him, but rather protected this wealthly man without any cost to him infuriated David. He thought that it was his right to take matters into his own hands. What David really needed was to calm down and allow God to handle this.

Paul wrote these words to those in Rome who were called to be saints: Repay no one evil for evil, but give thought to do what is honorable in the sight of all. If possible, so far as it depends on you, live peaceably with all. Beloved, never avenge yourselves, but leave it to the wrath of God, for it is written, Vengeance is mine, I will repay, says the Lord." FROM THE DESK OF; Dawn Snake, Office Associate

A new year is upon us, already looking at February. Down here at the WHDC offices everyone is diligently working on bringing all our tenant's records up to date. We try hard to help tenants stay in compliance with the Lease Agreement that is signed by Head Of Household on the date of move-ins.

Letters go out for Recertification for each tenant every two (2) years. That includes adding or removing any persons living with the tenant. Children are born, or grow up and move out. Maybe a marriage occurs or maybe a divorce. Maybe a tenant got a new job, or lost one. There are all kinds of situations that may change and this is one opportunity the WHDC gives you to bring in your documentation. (any time your financial situation changes the tenant is required to inform the WHDC).

We do our best to remain courteous at all times while preforming our duties and we understand that everyone works hard to get bills paid, appointments met and the household taken care of. Day-to-day life can be a struggle, but it is our duty to stay in compliance with H.U.D. as well as N.A.H.A.S.D.A. regulations, to provide our service area with safe affordable housing. So if we have to try to make contact several times, through letters and phone calls it's because we are required to do so and are trying to help the tenant stay in compliance.

Under our Program Management &

Occupancy Policy; Requirements:

14. The WHDC shall verify information provided including earned income to be verified through employers or other appropriate forms of obtaining such information at the time of admission into a program AND upon any recertification.

15. All Participants shall provide a release of information form which will allow the WHDC to verify any and all information required for a Participant to participant in the program.

16. Failure for a Participant to provide or allow the WHDC to obtain the necessary information will prevent the Participant from participating in a program until such time as the necessary documentation is provided and can even cause the Participant to be disqualified.

Under the DWELLING LEASE: 3. Payments due under the lease.

The amount of rent is subject to change as determined by WHDC in accordance with federal regulations during the term of the Lease.

Rent for the period beginning __.Thereafter, monthly rent in

the amount of \$_____, will be due on or before the first day of each month. Payments made, as rent will be applied to any outstanding balances, which may include rent, utilities, maintenance, or any other balances owed. This shall not be construed to require acceptance by the WHDC of rent payments tendered for a period subsequent to the expiration of a notice to terminate.

Resident shall make all rental payments in full .Payment or receipt of a rental payment of less than the amount stated in the lease shall be deemed to be nothing more than partial payment of that month's account. Under no circumstance shall the WHDC's acceptance of a partial payment constitute accord and satisfaction. Nor will the WHDC's acceptance of a partial payment forfeit the WHDC's right to collect the balance due on the account, despite any endorsement ,stipulation, or other statement on any check.

Any modification to this lease must be made in a letter signed by the WHDC, in which the WHDC states and agrees to the modification. The WHDC may accept any partial payment check with any conditional endorsement without prejudice to his/her right to recover the balance remaining due, or to pursue any other remedy available under this lease.

If the WHDC files summary ejectment papers for nonpayment of rent against the R esident three (3) months in succession, it shall be considered a serious and repeated violation of this lease agreement, a condition under which the WHDC may immediately issue a notice of termination in accordance with Section 12 (B) herein.

Applications will be available beginning February 28, 2017 at the school. Applications will be due on March 31, 2017. Notification of the selected candidates will be made no later than May 1, 2017.

There will be an Academy information night for interested students and their parents/guardians to attend and find out more details. The information night will be on Tuesday, February 28, 2017. Please join us in the library at 5:30 p.m.

How are students selected for the Academy?

The selection criteria are based on the following:

- 1. Grade point average
- 2. Test scores
- 3. Attendance
- 4. Behavior
- 5. Teacher referral
- 6. Essay
- 7. Completed application packet turned in by due date

Each of the criteria is awarded points. The students will be ranked according to the total points they receive. The top 12-15 students will be accepted into the Academy. All other students will be placed on a waiting list.

What is the Academy?

The Academy is a project-based classroom where students start working on advanced level coursework in the 7th grade. Students who remain in the Academy from 7th-10th grades will have the ability to work on dual enrollment courses during their 11th & 12th grades through Little Priest Tribal

College. Students in the Winnebago Academy will also have the opportunity to attend The University of Nebraska-Lincoln on a full ride scholarship (free tuition, fees, room, board and textbooks) as long as they maintain a 3.25 GPA and meet other requirements.


