WTN Hosts Nebraska Senators

[Lincoln, NE] On Thursday, February 8th, 2024, the Winnebago Tribe hosted the Senators of the Nebraska Unicameral during its annual luncheon here. For 34 years this yearly luncheon has been a part

of the on-going effort of the tribe to bring awareness to the capitol about the tribe, and garner support within the legislature of our state for the important items set before the Unicameral.

Tribal Council members Aric Armell and Kenny Mallory were in attendance of the long-held event, as was the WIN and representatives from 12 Clans Unity


Hospital, and office of General Counsel. Mr. Mallory opened the luncheon with a prayer as is customary for all tribal events and delivered welcoming comments. Mallory and Armell both spoke on behalf of the tribe throughout the occasion. The Senators were

await the approval of the U.S. Senate, which has its own processes to follow.

On February 8th, 2024, Chairwoman Kitcheyan gave live testimony before the Senate committee responsible for pushing the companion bill forward. S. 3230 as introduced by Nebraska Senator Deb Fischer (R), is co-sponsored by Senator Ricketts of Nebraska (R) and both Senators Grassley (R) and Ernst (R) of Iowa.

During lively debate of several other indigenous matters, Senator Fischer eloquently stated, "The U.S. Army Corps of Engineers was wrong to seize this land through eminent domain in the 1970s. After decades of inaction, it's time for us to make this right. My legislation will return this land to the Winnebago Tribe of Nebraska, and I look forward to getting this bill to the President's desk,"

Nebraska Senator Pete Ricketts also added, "The Army Corps of Engineers' decision to condemn and seize land from the Winnebago Tribe of Nebraska was a classic case of government overreach. My colleagues in the Nebraska and Iowa delegations and I want to see this wrong corrected, and the land returned to the Winnebago people,"

In our continuing coverage of this story, the Winnebago Indian News will work to keep all tribal members apprised of the actions as they come about. One tribal member who watched the historic testimony and debate said, "This fight... over 50 years in the making, is nowhere near over, but we can see the pathway forward. I'm so proud of our people! I hope one day, all our land will once again be held in tribal hands." The WIN could not agree more. Stay tuned.

treated to lunch and as much information as could be offered into the brief period of the day. A video short was played that contained up to the minute information as leadership for the tribe was also in Washington D.C. the same day.

In this legislative session the WTN is hopeful support for LB 1288 and LB 1131 remains in place as both measures are extremely vital to our people. LB 1288 authorizes state support for tribally issued EPC orders, as there is no protocol in place currently. LB 1131 seeks support for clean drinking water efforts. Both bills are from previous sessions that expired.

Senator Jen Day - Chair of the State-Tribal Relations Committee, helped facilitate introduction of the issues as well. The discussion is always driven and succinct due to the always hectic schedule of the Unicameral during live session debate. We have much appreciation for those in attendance and hold high hopes for the bills as they move through the process still pending approval. This WIN will report further on our bills once further action has been taken.



Faith is a gift of the Holy Spirit, less anyone should boast. The faith that God's Sacred Word speaks of is faith in Jesus Christ, the Son of God and His anointed One. Such a faith is assured. It is assured since Jesus paid the FULL price for the sin of the world.

SUICIDE IN INDIAN COUNTRY PART 40

Moving Toward a Hopeful Future

After you've taken your first steps back into daily life, it might be time to consider taking on a few more challenges. You've already made it through the toughest part. Now it's time to think about doing some things that can give you a greater sense of wellbeing and happiness.

Many survivors talk about a "second chance", or slowly coming to value what would have been lost if their attempt had resulted in their death. Over time, they begin to reclaim a sense of purpose in their lives, a new sense of identity, and real reasons for hope.

Maintaining Hope

When you made your suicide attempt, you felt as if suicide was a way to end your pain. At that moment, in your mind, your reasons for dying outweighed your reasons for living. As you've learned, reconnecting with your reasons for living can help you build hope. Some survivors recommend putting together a "hope box" that can serve as a physical reminder of the things in your life that bring you joy. When you begin to feel bad about yourself or your life and feel depressed, the contents of your hope box can help lift your spirits. It also is a good place to keep your safety plan.

Staying in Control of Being Organized

Dealing with stress or emotional pain can feel overwhelming and lead you to neglect day-to-day tasks and responsibilities. Feeling like life is out of control can make anyone feel anxious. It might help to make a list of the things you have to do each day. That way, you won't forget important events or get distracted and not complete things you need to get done.

Checking items off a to-do list can also help you feel a sense of accomplishment. Keep it simple and short to begin with; you can always add more when you have more energy. Keeping a calendar and using a daily planner are great ways to help yourself stay organized and maintain a sense of control over your life.

Creating a Hope Box

Your hope box can contain anything that might help you put aside painful thoughts or negative emotions and instead remind you of things in life that you enjoy. Decorating the box can be fun, as well. Here are some ideas for things to include:

Photos or letters from people you care about.

Poems, books, or scripture passages that lift you up.

Movies or music you like.

Note cards with uplifting words or thoughts, things that have kept you going in the past, or memories of happy times.

Special trinkets or mementos that help you feel grounded.

Your safety plan.


Your box can contain actual objects or be a collection of links or digital files on your computer, cell phone, e-reader, or other device. Getting in Touch With Your Spirituality

Some suicide attempt survivors find comfort in spirituality. Spirituality can mean different things to different people, and for some it can provide a feeling of being connected to something larger than themselves. Some may experience this by attending churches, temples, synagogues, mosques, and other places of worship. Others discover deeper meanings in nature, philosophy, or music. Would getting in touch with your spirituality bring you comfort and peace? Only you can answer that, but it does help some people.



TEEN DATING VIOLENCE AWARENESS

Some teens are at greater risk than others. Female students experience higher rates of physical and sexual dating violence then male students. Students who identified as lesbian, Gay, bisexual, transgender, or queer (LGBTQ) or those who were unsure of their gender identity experienced higher rates of physical and sexual dating violence compared to students who identified as heterosexual.

1 in 12 high school students experienced physical dating violence and 1 in 12 high school students experienced sexual dating violence. Unhealthy abuse, or violent relationships can have short- and long-term negative effects, including severe consequences, on developing teens. Youth who are victims of teen dating violence are more likely to:

Experience depression and anxiety symptoms.

Engage in unhealthy behaviors, like using tobacco, drugs, and alcohol.

Exhibit antisocial behaviors, like lying, theft, bullying or hitting.

Think about suicide.

Supporting healthy, nonviolent relationships could reduce TDV and prevent its harmful, long-lasting effects on individuals, families, and their communities. During the pre-teen and teen years, it is critical for youth to learn skills to create and maintain relationships, including managing feelings and communicating in a healthy way. Research also highlights the need for prevention efforts that address the uniqueness of teens who are at greater risk of experiencing teen dating violence.

I will be collaborating with the Boys and Girls club trying to set up a presentation on the subject at the end of the month in February and getting information for the teens of Winnebago and their families. Winnebago Tribe Expands Air Monitoring Efforts to Safeguard Community Health

The Winnebago Tribe of Nebraska is actively working to improve its air monitoring capabilities to protect the air quality within our community. With the support of the Clean Air Act and funding from the American Rescue Plan, the Tribe is expanding its resources to monitor and comprehend the conditions in our airshed.

One key initiative is the monitoring of local mercury levels. Recognizing the toxic nature of mercury and its harmful impact on living organisms, including us humans, the Tribe has joined the National Atmospheric Deposition Program (NADP) and the Mercury Deposition Network (MDN). These programs play a vital role in collecting data on mercury deposition from across the United States.

Since September 2022, Winnebago has been an active participant in the mercury deposition network. Under this program, weekly samples are collected and subjected to a mass spectroscopy analysis to determine the levels of mercury (Hg) present in our rain and snowfall.

Mercury, a hazardous heavy metal, poses significant health risks as it accumulates in the environment. The contamination of ecosystems and aquatic life can result in elevated mercury levels within the food chain as larger organisms consume smaller ones.

Mercury enters the atmosphere both by human activities and naturally. In nature mercury emissions happen through volcanic eruptions and forest fires. Human activities, such as burning fossil fuels and waste incineration (such as municipal trash, medical waste, tires, and batteries), also contribute to atmospheric mercury levels. These global activities, including heavy industrial activity, economic growth, and warfare, have an impact on mercury levels in the atmosphere.

To address these concerns, the Environmental Protection Agency (EPA) has implemented various programs and regulations aimed at reducing mercury emissions from industrial sources, power plants, and other sectors. These efforts include the Mercury and Air Toxics Standards (MATS) for power plants and the Clean Air Mercury Rule (CAMR).

Through our partnership with the NADP, the Winnebago Tribe has compiled and analyzed monitoring data to raise community awareness about the air quality situation. By actively monitoring and understanding the levels of mercury deposition, we are taking crucial steps to safeguard the health and well-being of our community.

WCHS Receives CMS Certification Number

Winnebago, NE – The Winnebago Comprehensive Healthcare System is celebrating a huge milestone in their organizations progress - they have officially received their CMS Certification Number.

A CMS Certification Number comes from the Centers for Medicare and Medicaid Services. They are a federal agency the runs the Medicare, Medicaid, and Children's Health Insurance Programs. State Survey Agencies conduct initial surveys and periodic resurveys, including complaint surveys, to determine if healthcare providers and suppliers meet the necessary standards for participating in Medicare and/or Medicaid programs. These surveys evaluate the quality of care provided and ensure compliance with regulations found in the 42 Code of Federal Regulations. They also assess efforts to prevent environmental hazards and confirm that responsible personnel are effectively protecting health and safety.

"We have done so much preparation over the last 5 years to be ready for the moment for this actually happened. And when the time finally came for the

surveyors to come in April, we were ready," states WCHS CEO David Edwards. "I'm so proud of this team. They have done so much work – even before I was ever here. It is really something to celebrate."

What a CMS Certification means for WCHS, is that they can now receive funding from these government programs, furthering their progress in creating a safe place for the Winnebago Tribe and surrounding areas to access quality healthcare. It also means that they adhere to the federal standards that every hospital should follow, assuring the community that they can have confidence in the care they will receive.

"There is a fire lit underneath the WCHS team," says Jim Rixner, WCHS Board Chairman. "It is obvious that their relentless efforts to grow and prove the past wrong will only continue to pay off. This organization has taken charge of healthcare in Winnebago, something the community has deserved for a long time. This is a huge step for building trust in the future of WCHS."

EDITOR'S MOVIE REVIEW:

GRISELDA – Godmother & Queen Pin

A hot new release via Netflix has been garnering significant buzz in the entertainment world. Simply titled, "Griselda," the well-known streaming platform has another hit on its hands. Debuting around the globe at the number one spot in 89 countries following its January 25th release, this generously adapted retelling follows the real-life history of Griselda Blanco – infamous drug cartel leader of the 1970s and 80s. A 6-part mini-series that packs a wallop, holds its audience captive from beginning to end.

Griselda, (Unrated [Rated R]) loosely follows the rise and fall of the eponymous storyline anti-heroine taking the viewer into the depths of life inside one of the most torrential underworld stories ever told. Violence abounds within each segment, but do not expect the ferocity in the life of the crime boss to be the only focus here. The story is rich with nomination worthy performances in the cast of characters that shines in every role.

Directed by fellow Colombian Andres Baiz (Satanas/The Hidden Face/ Narcos) and spoken nearly all in Spanish, the story created truly draws the best from each member of the well-chosen cast. Starring in the lead role, Colombian-born star Sofia Vergara (Modern Family/Machete Kills/AGT) also produced the mini-series along with Eric Newman. Vergara as the main character never fades into the background; quite to the contrary. Baiz's grip on the story is masterful, developing not only the growing madness within Vergara's character portrayal, but also the defining characteristics within each actor of this ensemble cast.

Vergara taking on this rare dramatic lead, gives an award caliber effort throughout. From the onset, her command of the screen is undeniable and raw. Truly visceral, captivating, her ability to embody one of the world's most notorious figures shows her incredible range; a side of her acting potential never before seen. Vergara's ascent from placated and exploited wife to skyrocketing drug lord, I would not be surprised in the least to see her name atop acting awards lists next year.

The supporting cast is just as dynamic. Alberto Guerra (Narcos: Mexico/ Vale todo/Crime Diaries: The Candidate) shines as Dario, Griselda's enemy, turned bodyguard, turned third husband. The chemistry between the pair is palpable. Martin Rodriguez as Rivi adds even more power to the powder keg waiting to explode. His character gives the most surprising twists and turns while the light fades in Griselda's shadowy underworld.

The entire cast is stellar from top to bottom. Each character gives the story a richness and depth that creates times in the story where you are almost rooting for the bloody queen of cocaine, while watching the world she lives in fall down around her. Intelligent, smart, sexy, desperate, and even lucky, Griselda's life made for one incredible spree of Netflix entertainment.

The binge worthy hours I spent watching Griselda were very well spent. I heard good things prior to viewing it and was not disappointed. Feeling engrossed by the mini-series, I could not stop watching. It is rare that any video story captures the page ripping feeling of an excellent book, but Griselda as directed by Baiz does just that. Noteworthy costume design all throughout and a well-used production design budget takes us back to this era with incredible accuracy. A well-appointed soundtrack also accompanies the mini-series. On our HaazZatt rating for this Netflix thriller: 4 of 5. Incredible story telling.
