only attended by council and a handful of Winnebago staff due to the pandemic, however a live stream was broadcast over the tribe's YouTube and Facebook Page. His term will be until the next general election which will be held in October of this year. Councilman Mallory thanked those who tuned in virtu-

ally to express his gratitude for voting for him. He mentioned that "I hope you can count on me, along with the help of this generous council to fulfil those promises I made during my campaign."

## Winnebago boys capture second straight conference title with win over Laurel-Concord-Coleridge

WAYNE, Neb. — Shane Lantz *Champions, once again.*

The Winnebago High School boys' basketball team ran onto the floor in celebration, at the conclusion of its 48-44 victory on Monday over Laurel-Concord-Coleridge in the Lewis and Clark Conference Championship game.

The victory took place at Wayne State College, and clinched the second straight conference title for the Indians, who won last year's crown with a championship game win over Osmond.

This year's game went down to the wire, as a two-point bucket and subsequent free throw from LCC senior Evan Haisch pulled the Bears within a point, 45-44, with 1:06 remaining in the game. The score stayed there until the 22.1 second mark, when Winnebago junior Dyami Berridge was fouled. He then sank both of his free throws to make it a three-point game.

The next LCC possession ended without a score after a 3-point try from LCC senior Evan Haisch clanged off the back rim. The Indians got the ball back, Berridge was fouled again with six seconds on the clock. He made his first free throw to effectively seal the game and

clinched back-to-back conference titles.

For the Indians, the 2022 title win feels even more special than their 2021 triumph.

The team has been through a lot this season, but pulled together when it mattered most.

"It's a little bit more special," Winnebago coach Jeffrey Berridge said. "I'm not going to lie, these past couple of seasons have been rough on all the coaches. We've kind of had some battles with some teammates, and tonight it was just more special because we were down. We only brought eight guys; we had a guy get hurt today playing ball outside because it was nice. Being short-handed, everybody stepped up."

Dyami Berridge was the biggest difference maker on the court for the Indians, with 22 points on the night. With his big shots and excited reactions in big moments, Berridge kept the Winnebago crowd on its feet throughout the game.

At one point early in the game, Berridge made a 3-pointer and emphasized the score by pointing toward the LCC student section. Berridge smiled after the game when remembering the moment.

"All the student sections at every

game come at me," Dyami Berridge said. "It's just fun to engage with them, talk to them and stuff."

Monday's win was Winnebago's revenge for a pair of losses to the Bears earlier this season. LCC took down Winnebago, 64-59, back on Dec. 30, and then beat them again on Jan. 7, 46-44. The Indians came into this game eager for a new result.

"We were just hungry," Dyami Berridge said. "It's hard to beat a team three times, I'm always hearing that. We got it back tonight."

Along with Berridge, senior Javon Price had a solid night with 10 points, while Zaiden Bernie and Timothy LaPointe scored seven and six points, respectively.

Jake Rath led the Bears with 15 points, while Lucas Rasmussen and Haisch each scored seven.

For LCC head coach Todd Erwin, the toughest things about facing Winnebago were their size, and tough 1-3-1 zone defense. Additionally, Erwin thought that the championship game stage may have gotten into the heads

ASIST teaches participants to recognize when someone may have thoughts of suicide and work with them to create a plan that will support their immediate safety. Although ASIST is widely used by healthcare providers, participants do not need any formal training to attend the workshop—anyone 16 or older can learn and use the ASIST model.

Over the course of their two-day workshop, ASIST participants learn to:

- Understand the ways that personal and societal attitudes affect views on suicide and interventions
- Provide guidance and suicide first aid to a person at risk in ways that meet their individual safety needs
- Identify the key elements of an effective suicide safety plan and the actions required to implement it
- Appreciate the value of improving and integrating suicide prevention resources in the community at large
  - Recognize other important aspects of suicide prevention including life-promotion and self-care

## Winnebago Tribe of Nebraska Request of Proposal for Logo Creation and Evaluator

### Background Information

The Winnebago Tribe of Nebraska "Tribe" is announcing a request for proposal for logo creation and an Evaluator for the Winnebago Career and Technical Education "CTE" project under the Education Department. The CTE goal is that low-income, Native Americans in the Winnebago Community will access and complete appropriate education and skill building STEM-related education/career tracks necessary to obtain credentials and quality employment within five (5) years.

The Tribe is seeking a qualified service provider possessing the professional skill making them suitable for creating a digital signage that represents the CTE project or evaluating and analyzing data and creating annual reports on progress within the project and its participants. The evaluator service provider will remain in close communication with staff as well as assist CTE Director with other requests.

### Contents of Proposal

In its proposal, Bidder shall submit, at minimum, Bidder's credentials and qualifications-a brief summary of any prior experiences which makes Bidder qualified to perform the scope work requested.

### Timeline

of his players.

"The atmosphere, all the championship game or something just really kind of had our kids thinking, instead of playing," Erwin said. "That'd be the biggest thing. The kids worked hard, but they just made it tougher than what they needed to, and obviously, we'd say 'We didn't play our best game,' and we're down two or four, to a very good team."

Of Dyami Berridge's 22 points, 10 of them came on free throws, of which he went 10-for-12.

According to his head, Berridge's leadership is a crucial component to

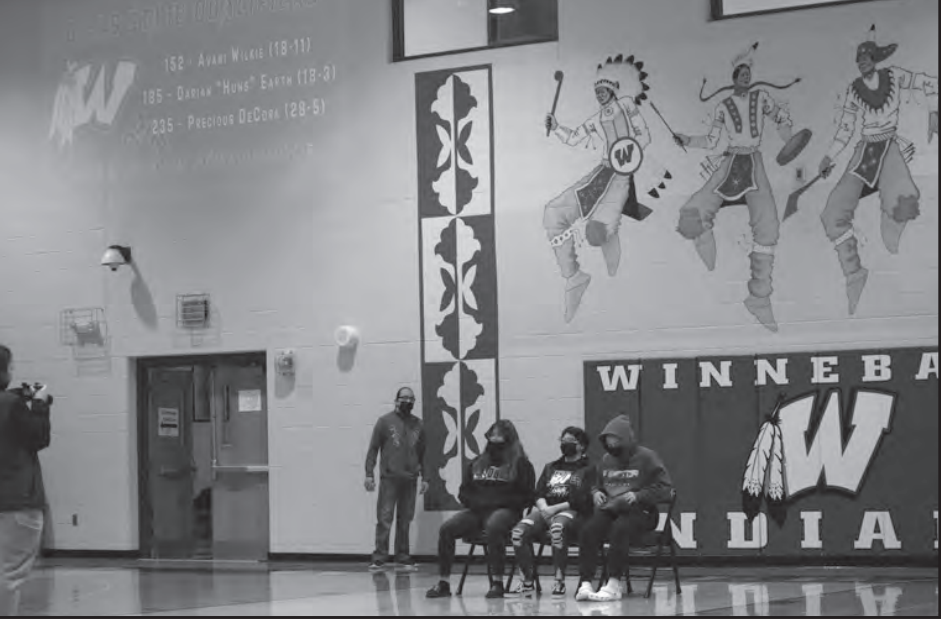
the team's success over the past two seasons.

"He's a great kid," coach Berridge said. "He's always a fearless leader out there, and he's a guy who is always pushing the boys to be their best. He showed that tonight, not only scoring the points and making the big free throws at the end, he is always trying to encourage his teammates to be better and work hard. Tonight, it showed."

The win improves Winnebago's record to 13-8 on the season, while Laurel-Concord-Coleridge is 16-5. The Bears next game is Thursday at Wisner-Pilger, while Winnebago played Tuesday after the Journal's deadline, at Wakefield.

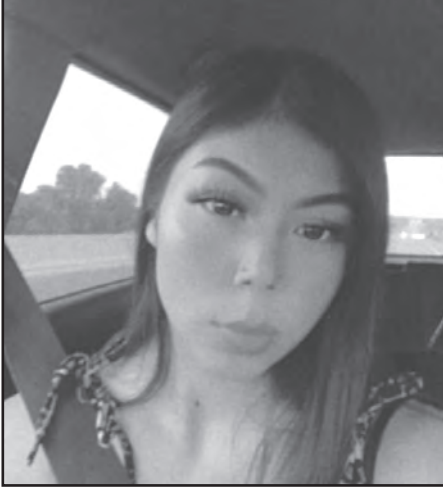

## Nebraska lawmakers officially recognize survivors, descendants of Genoa Indian School

State lawmakers have officially recognized the survivors and descendants of Nebraska's federal Indian Boarding School.

Introduced by State Sen. Patty Pansing Brooks of Lincoln, the resolution approved by the Legislature on Monday acknowledges survivors of the school, their descendants and impacted communities. It also establishes Feb. 20 as an annual day of remembrance.

The recognition comes nearly 88 years after the Genoa U.S. Indian Industrial School closed. Judi gaiashkibos, executive director of the Nebraska Commission on Indian Affairs, said the measure is "one more step in the process of remembrance, understanding and now healing."

"I am deeply grateful to Sen. Pansing Brooks and all the co-sponsors for introducing this resolution," gaiashkibos said. "We have finally reached our day of reckoning in confronting this dark, hidden history."

The fourth federal boarding school to be built in the U.S., the Genoa school operated from 1884 to 1934. It was one of the largest in a system of 25 federal Indian boarding schools. At its peak in 1932, the school's 640-acre campus housed 599 students, who ranged in age from 4 to 22 years old and came from more than 40 tribes.

The resolution also officially acknowledges the physical and emotional abuse students were subjected to at the school.

In drafting the resolution, Pansing Brooks said she felt it was important to tell the story of the Genoa Indian School.

When discussing the resolution with senators before it was introduced, Pansing Brooks said, many had never heard of the boarding school.

"I think it's important we understand the trauma First Peoples went through," Pansing Brooks said. "These children were taken away from their communities, often involuntarily. As a mother I can't imagine my children being ripped from my arms."

Nebraska researchers believe that all who attended the Genoa school are now deceased. But a local and national push to understand the full scope of the U.S. Indian Boarding Schools that were built across the country in the late 19th and early 20th centuries has brought new attention to their stories.

A massive effort by a group of Nebraska researchers has uncovered 86 names of children who died at the school. The true count of students who died there is likely much higher. The World-Herald previously reported that 102 possible names had been discovered by groups of researchers. After rooting out duplicated names, researchers with the University of Nebraska-Lincoln have confirmed 86.

A corresponding effort is underway to find the school's lost cemetery. That search is led by the Nebraska State Archaeology Office and gaiashkibos, a citizen of the Ponca Tribe whose mother attended the school.

"After so many years, through the efforts of many, this story, the whole story, has been brought into the light," gaiashkibos said. "Our lost children can now be remembered and hopefully found."

## JESUS OUR SAVIOR LUTHERAN OUTREACH



**"You of little faith, why are you so afraid"**

What is one of the worst things that you could say to a teenage boy?

You call him a coward. What father is proud of a son who is timid? Or what military officer picks those who are afraid of their own shadow to go on a mission. Or what soldier on a mission would like to have a coward at his side?

Young teenage girls are urged to be strong! Girl power! Yes, a female is brought up with an attitude to stand up for her rights! In God's Sacred Word, both young men and young women are encouraged to have a strong and courageous faith!

Matthew records a story when the disciples of Jesus became overwhelmed with fear. Jesus and his twelve disciples got into a boat. Jesus laid down and went to sleep. Without warning a furious storm came up on the lake. The disciples went and woke Jesus, saying, "Lord, save us! We're going to drown!"

You might wonder how could Jesus sleep during a storm? Two reasons, first as a man he needed his sleep. And, second he had full confidence that His Heavenly Father was watching over him.

Do you know how Jesus responded when he was rudely awakened from his sleep? Jesus replied, "You of little faith, why are you so afraid?" The greek word for 'afraid' is 'deiloy' and can also be translated as 'cowardly' or 'timid.' This word is used only three times in the Greek New Testament. Twice in reference to this story (Matthew and Mark both use it).

The only other time that 'deiloy' is used is by John in the Revelation of Jesus Christ. John writes: 'But the cowardly, the unbelieving, the vile, the murderers, the sexually immoral, those who practice magic arts, the

idolaters and all liars—their place will be in the fiery lake of burning sulfur. This is the second death' [Revelation 21:8].

The cowards of this world are also the unbelieving. Oh, the cowards may come across as powerful - as their wicked ways lead them to bully and force their ways on others. But like most bullies, when confronted by one more powerful; or when they are disarmed; they cower away.

Jesus was no coward. Jesus was indeed strong and courageous. Later Jesus would be confronted with an even greater storm. He would be put to the ultimate test of His faith and He places His trust in His Heavenly Father. Jesus weathered the storm of God's powerful wrath.

Jesus did not open His mouth - he held his tongue and did not call His angels to come to His rescue. The greatest courage of Jesus took place as darkness came over the earth during the middle of the day: Jesus cried out in a loud voice, "Eloi, Eloi, lama sabachthani?"—which means, "My God, my God, why have you forsaken me?" [Matthew 27:46] Jesus paid with His blood the punishment that we all should have to endure - forever and ever.

Both males and females of all ages are encouraged in God's Sacred Word to be strong and courageous! Jesus in love warned His followers not to lose their faith, but rather to place their trust in Him. Jesus has complete and total power over sin, death and the devil.

There is absolutely nothing, with the exception of God, that one should fear. Fear has to do with punishment, perfect love casts out all fear! Perfect love trumps fear; the unconditional love of God that is!

## SUICIDE IN INDIAN COUNTRY FINAL

Helping your child to develop resilience:

For toddlers watch when they can-  
make good judgments (by herself) on whether or not she needs to run to you;  
stop her own crying and get back to what she was doing;  
let other children distract her from her distress;  
attentively watch you when you show her how to calm down and get back to herself.

For the four-to seven-year-old watch-  
does she freely tell you about things that have happened that made her feel bad? Is she open to a two-way discussion about it? Can she follow a simple plan to handle the situation the next time it happens?

when he gets mad or upset, can he calm himself: If he's upset and needs your help, can he ask for it?

when she has questions, is she interested in your answer? If you don't know the answer but suggest a way to find out, does she follow through?

when he fails to succeed at something he's trying to do, does he see what he needs to change and then try again?

does she feel capable around the house? Does she ask how to do more things to help?

For the eight-to-twelve-year-old watch for-  
recognizes the difference between little troubles that will pass and more serious problems that she may need help resolving;

recognizes her own feelings of loss, worry, anger, etc., and can identify why she's feeling that way;

uses her "people" resources (you, a sibling, a friend, a mentor) to help her solve her problem;

expresses her feelings after a very upsetting episode and gradually returns to her usual self.

For the adolescence watch when they-  
steers clear of the big risks: drugs, alcohol, early and/or unsafe sex, unreasonably risky activities;

does not adopt troubling behaviors that may have been a part of his household;  
can talk about goals and the steps he needs to take to reach them;

in hard times, goes to his sources of solace: family, friends, exercise, hobbies;  
is most comfortable with others who have positive goals and who help each other achieve them;

faces setbacks with the confidence that he will work his way through them.

Some children have to deal with really serious problems that no child is prepared for: birth defects, traumatic accidents or violence, the early loss of a parent, for example. These children need resilience more than anyone. Fortunately, there are ways for such a child to develop it.

First, do all the things you've learned: model an optimistic, resilient attitude yourself; keep communication open, simple, and encouraging; teach your child how to find healthy ways to make herself feel better; help her to find company in kids who have the same problem.

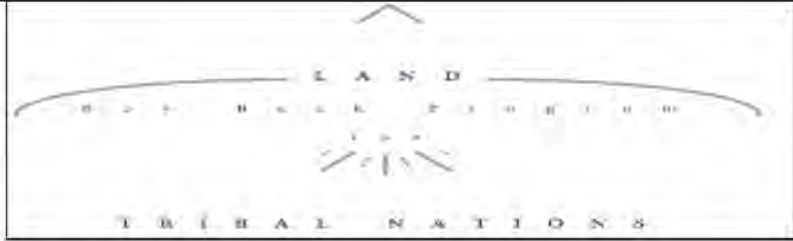
Every hospital and social services agency has resources that will help your child develop confidence, self-esteem, and a belief in his own future. Use every one of these resources. And if you are put on a waiting list or it seems that things are going awfully slowly, do be the squeaky wheel: call, and call again, and again, until you get the response you need.

The world is full of resilient children.....

....who have faced and learned to live with extreme misfortune. They do it with the help and encouragement of caring adults and other children, and they absorb those feelings of confidence and self-esteem into their own personalities.

Researchers have described the resilient child as one who works well, plays well, loves well, and expects well. With that goal in mind, every child can develop resilience, and the first person to get the ball rolling is you. Your desire and motivation will help you do a great job.
