

March 3rd at 9:30am in the Winnebago tribe's tribal council chambers, a Nebraska Medal of Honor Community project special presentation was held.

This event was sponsored by The Winnebago Tribe of Nebraska in honor of Corporal Mitchell Red Cloud Jr. and Sargent John Rice.

The event began with introductions & Isaac Smith, Garan Coons & Craig Cleveland singing the Flag song followed by a reading from the Angel DeCora Museums very own, Sunshine Bear,

& Mitchell Red Cloud Jr's Biographies. U.S. Army Veteran and Winnebago Tribes Veteran's Service Officer, Gordon Rave, presented a check of \$5,500 to

Daryl Harrison, President of the Nebraska Medal of Honor Foundation. The Foundation reached out to WTN to fund a highway community sign in honor of Ho-Chunk Warrior, Mitchell Red Cloud Jr. Then resulting in the Council fully funding the project in honor of Winnebago Veterans Mitchell Red Cloud Jr. & John Raymond Rice. With the funding the project will place 24"x24"

signboards on the town's population signs where Nebraska Medal of Honor recipients were born/ buried or where the communities were heavily involved in the project.

Thoughtful words from Arik Armell, Isaac Smith, Coly Brown & Brian Chamberlain were said followed by a closing Red Cloud Honor song sung by Garan Coons & Craig Cleveland.

Thank you to Tribal Council & WTN for supporting these efforts to acknowledge & inform those of our Veterans.





My name is Tyler Snake, Winnebago Indian News office manager. I have had the opportunity to create more content and handle projects within the WIN office since August 2021. My goal is to inform our subscribers of the various events that happen around Winnebago.

Currently we have worked on obtaining funding from the ARPA, American Rescue Plan Act of 2021. The ARPA fund has helped state and local governments like us to provide different types of relief to keep businesses as well as their employees safe.

The Winnebago Indian News team is happy to inform our tribal member subscribers that thru ARPA funding we are able to have the HOH member's subscription paid for. This includes the printing, postage, shipment & newly added to our production process; labeling! The mission of working with ARPA is to be able to provide and inform our subscribers of important content dealing with ARPA, COVID-19, & record Winnebago's history.

Thank you to the Tribal Council & WTN's Enrollment Department for working with us to get the Head of household list so we can begin setting this plan into action as soon as possible!

One responder from the survey asks: "What is a safe cleaner to use on surfaces that doesn't cause skin irritation?"

Thank you for the great question!

According to The Center for Children's Environmental Health, the Dept. of Allergy, Asthma, and Immunology, and the Children's Mercy Hospital in Kansas City Missouri here are some very simple, economical and safe all-purpose surface cleaner tips to try.

Baking Soda - Use baking soda on a damp cloth or sponge to clean and deodorize kitchen and bathroom surfaces.

Vinegar and Salt. - Mix ½ cup of white vinegar to 1tsp of table salt to make a good surface cleaner. For really tough stains use equal parts of Borax, Salt and Vinegar.

Furniture Polish - Mix equal parts of virgin olive oil with vinegar and apply with a soft clean soft cloth.

Laundry Soap - 1oz. liquid Castile soap, 1 cup washing soda (available in the laundry isle in most supermarkets), 1 cup of baking soda, and 1 cup of white vinegar makes a safe laundry soap.

Deodorizers - To remove that smoke smell from your clothes fill your bathtub with hot water and add 1 cup of vinegar to it. The steam will remove that smoky smell.

Ovens and Microwaves - Pour equal parts of distilled water and white vinegar into a heat-safe-bowl. Place into your microwave or oven and heat it long enough to bring it to a boil. Let it cool down a bit before you open the door. Odors will be eliminated and spattered food will be loosened and easy to wipe away.

Glass Cleaners - Mix together equal parts of distilled water, rubbing alcohol and white vinegar into a spray bottle. This solution works great on glass, mirrors, ceramic tiles and chrome finishes. Spray and wipe off with news paper, paper towel or microfiber cloth.

Based on your personality, which animal would you say you are and why?





People may not show any signs of the intent to kill themselves before they die by suicide. Learn to recognize the warning signs:

Hopelessness; feeling like there is no way out

Anxiety, agitation, sleeplessness, or mood swings

Rage or anger

Engaging in risky activities

Increasing alcohol or drug abuse

Withdrawing from family and friends

The presence of any of the following signs requires immediate attention:

Thinking about hurting or killing themselves

Looking for ways to die

Garden Update

Tree Diversity

With Earth Day and Arbor Day coming up next month, it is a good time to talk about trees, aptly called "the lungs of the earth" for the carbon dioxide they take in and oxygen they exhale, but also for the air pollutants they mitigate. As people plan to add trees to their landscape this year, there are some important steps to ensure successful establishment and that trees planted now survive. It is estimated it takes one to two decades before costs associated with planting new trees is recouped in savings from the benefits of shade, windbreaks, and rainwater mitigation. This is a compelling reason to make sure trees have every chance to grow and survive. Too often, attempts to push tree growth results in dead trees. Some short-sighted attempts are planting large trees, fertilizing them, adding mulch volcanos, and watering too much.

What are the best management practices when it comes to planning for a new tree? Let the site be the first consideration as the presence of power lines, paved surfaces, property lines, slopes, and the size of the space dictate what tree to plant. At a minimum, trees should be planted 3-4 feet away from a paved surface to prevent expanding roots from buckling the pavement. Consideration must be given to the foundations of homes, outbuildings, and other structures to make sure roots don't cause damage and branches do not scrape siding. When determining the distance to plant from foundations, a simple rule of thumb is to divide a tree's full-grown canopy by

two, and then add 2-3 feet. Make sure trees are planted well away from utilities as sudden changes to root zones, like trenching, cause tree decline.

Tree selection plays a huge role in tree diversity. Communities and regions with a wide range of trees have greater resiliency to insect pest infestations, plant pathogens, and weather changes. Worldwide, the most common trees of a region comprise 24% of a tree population. John Ball of South Dakota State University advises following a 5-20-30 rule for tree diversity—no more than 5% of an urban forest is made up of just one species; no more than 20% belong to the same genus; and no more than 30% belong to the same plant family. Planting too many trees of the same species/genus/plant family can be likened to the adage about placing all of your eggs in a single basket—too many of the same trees dominating a space increases the likelihood that an emerging problem will destroy them, leaving towns, villages, and neighborhoods lacking tree cover.

Considering the investment of time that goes in to growing a tree, it makes sense to do your homework when choosing a tree to plant. Just because one tree dominates the inventory of local garden centers doesn't mean it is the one to plant in your yard. Check what trees are planted in your neighborhood—and then plant something else. THE OFFICIAL WINNEBAGO TRIBAL FLAG

Peace, protect and preserve. The Winnebago flag was created on a field of blue to represent water. From the Great Lakes area of the Lake Michigan to the rivers of the Missouri and the Mississippi, the Winnebago people through history have been a peaceful group of fisherman and woodlands people. History tells about tribal migration, relocations, wars, and escape from bondage. During the period of the relocation, the Winnebago traveled on the water to their new homeland in Nebraska after their escape from Crow Creek Reservation in South Dakota. The Winnebago people relied on the water and the woods for food, clothing and housing. The items on the flag represent peace, protection and preservation. The white circle that lies on the blue field represents the sun and moon. The sun and moon play an important role in our HoChunk way of life. It also represents unity. Two arrows and a bow together represent the two bands of the Winnebago (HoChunk) Nation. One band is the Wisconsin band, the other the Nebraska band. Although separated by distance, both are the identical and of the same nation.

According to Winnebago traditional beliefs, in the beginning of creation people were naked without clothes but the bow and arrow was the first tools providing a way to hunt for game which provided the means for clothing and housing. The bow and arrow being the first tools used to hunt food and protect the Winnebago people. The peace pipe, axe and beaded pouch decorated with buffalo tracks being a ceremonial tool to remember our creator for peace, protection and preservation of the Winnebago people. The pipe representing prayers to the creator for life, the axe a tool used for cutting trees and making canoes and the beaded pouch telling the story about buffalo migrations and tribal buffalo preservation. This flag and its images are used as remembrance of peace, protection and preservation of the proud

Winnebago (HoChunk) People.
