





### First Death Related to COVID-19 Confirmed in Winnebago

WINNEBAGO, NE – The Winnebago Comprehensive Healthcare System, which is comprised of the Winnebago Public Health Department (WPHD) and Twelve Clans Unity Hospital (TCUH), announced last Thursday (May 21st, 2020) that the first COVID-19 related death has occurred in Winnebago.

"Our thoughts and prayers are with all who mourn the loss of their loved one. This is a very difficult time for our community as our tribal culture dictates that we should be together, especially when a relative passes away. We must continue to do everything we can to protect our community from further spread of COVID-19, while paying respects to the family," said Danelle Smith, Winnebago Comprehensive Healthcare System CEO.

COVID-19 is a respiratory illness with no known cure or vaccine. Winnebago community members experiencing shortness of breath, sore throat, runny nose, and cough are urged to call the COVID-19 Hotline at (402) 922-

1508. Per Center for Disease Control and Prevention (CDC) guidelines, it is recommended that individuals stay home except to get necessary medical care. Individuals with underlying conditions, such as diabetes or those with compromised immune systems are the most high-risk for contracting the virus.

Prevention measures include washing your hands often with soap and water for at least twenty seconds each time and routinely cleaning frequently touched surfaces. Other recommendations include social distancing, wearing a mask in public, and remaining at least 6 feet away from each other with groups of no more than 10 people.

Winnebago Comprehensive Healthcare System has been taking many important steps to further protect the health and safety of the community. These steps, among others, have included implementing a no visitor policy within the hospital, increasing the frequency of cleaning facilities, making certain services available remotely,

implementing a drive-thru pharmacy, and placing staff on telework status when possible.

Winnebago Comprehensive Healthcare System is operated by the Winnebago Tribe of Nebraska and consists of two divisions. Twelve Clans Unity Hospital is a 13-bed state-of-the-art healthcare facility that serves an estimated 10,000 Native Americans who live on the Winnebago Reservation and in the surrounding region. Health care services provided by the hospital include an ambulatory care clinic, in-patient care, express care clinic, pharmacy, radiology, emergency care, medical laboratory, physical therapy, social services, and more. The Winnebago Public Health Department strives to create and maintain a healthy community by providing a wide range of total health and wellness programs. These programs include physical, mental, safety, and social services that benefit the Winnebago community.

### CARES Act Funding received by the Winnebago Tribe of Nebraska

The Coronavirus Aid, Relief, and Economic Security Act, also known as the CARES Act, is a law meant to address the economic fallout of the COVID-19 pandemic in the United States.

The original bill proposal included \$500 billion in direct payments to Americans, \$208 billion in loans to major industry, and \$300 billion in Small Business Administration loans. As a result of bipartisan negotiations, the bill grew to \$2 trillion in the version unanimously passed by the Senate on March 25, 2020. The next day, it was passed in the House via voice vote and signed into law by President Donald Trump on March 27.

Unprecedented in size and scope, the legislation was the largest-ever economic stimulus package in U.S. history. The bill is referred to by lawmakers as "Phase 3" of Congress's coronavirus response. The first phase "was an \$8.3 billion bill spurring coronavirus vaccine research and development" (the Coronavirus Preparedness and Response Supplemental Appropriations Act, 2020), which was signed into law on March 6, 2020. The second phase was "an approximately \$104 billion package largely focused on paid sick leave and unemployment benefits for workers and families" (the Families First Coronavirus Response Act), which had been enacted March 18, 2020.

As part of the CARES Act, the Winnebago Tribe of Nebraska has received funding for the "prevention, preparedness, and response" to the COVID-19 virus. The Tribe has received \$1,500,382, distributed through the P.L. 93-638 process, as part of the \$453 million allocated to the BIA. The Tribal Council

approved the budget for these funds that covered a wide array of projects including community mask making, hardware and software to assist with tele-distance work and community needs for IT related needs, purchase of PPE masks, hand sanitizer and other sanitizing supplies, food security with a potential greenhouse and equipment and rent relief for tribal housing.


The Tribe also received \$58,399 in funding to assist with burial assistance and general assistance through the Tribe's P.L. 102-477 Human services program.

On May 22, 2020, the Tribal Council approved the budget for the first round (Round 1) of funding the Tribe received from the U.S. Department of Treasury. Round 1 funding totaled \$6,236,031.04. this is the Tribe's allocation from the Treasury's distribution of 60% of the \$8 billion funding that was made available to all the Tribes. The second round should be made known sometime after June 5, 2020. The budget for the Round 1 funding was completed with collaboration between the Winnebago Tribal Council and staff, Tribe's Pandemic Taskforce, and the various subcommittees formed to help address this unprecedented pandemic we are currently facing. The subcommittees were formed to work on different areas of need within the Tribe and the Winnebago community. The areas covered by the subcommittees are food security, communications, utilities, security, and education as well as the needs of the tribal departments. The budget areas approved covered items such as funding to cover the food pantry through an agreement between the Tribe and the ATLAS program to help provide food and delivery to the com-

munity, needs for facilities for the Youth Shelter and Tribal Court as well as additional storage for the Wildlife and Parks department as well as a few other needs for tribal employees. Other items in the budget provide funding to purchase trees, minor equipment, canning supplies and soil for the food security initiative. Funding for IT equipment for the community to assist with tele-health, equipment for the hospital to help fight the pandemic, funding to improve roadway access for our first responders to residents and improved WIFI access for the community. The budget also included funding to improve patrol/response ability for the Tribe's law enforcement officers. There was also funding for the Tribe's enterprises to help pay for increased cleaning and sanitization products needed to keep the customers and employees safe during this time. And lastly (but not the least) we were able to provide funding to the community schools for PPE and cleaning supplies they requested as well as laptops that were requested by the public school.

Currently the Tribe's finance department is entering the budgets and project information into the accounting system to ensure that the funds received are being spent following all procurement and internal control policies. These funds are being treated with the same care and due diligence that all Tribal funds and federal or state grants. The Tribe's departments have and will continue to be diligent in our use of these funds for the proper purpose, supported by proper documentation and the due care that is expected.

### WTN Tribal entities PPP Loan Report



#### WCHS

WCHS received \$2,373,700 from the PPP. They plan to use this money to pay for salaries and benefits for our direct-hire WCHS employees. If there are any funds left over, the funds will be applied to utility costs (electricity, telephone, natural gas, water) and rent/lease costs.

There are some salaries that are currently budgeted in other funding sources (tribal health grants), so we will make sure that we are not double-dipping into any of those funds. WCHS is reaching

out to the grantor agencies to inquire if some salary costs can be reallocated to other costs within the grant.

#### LPTC

LPTC ended up getting \$478,000 from the PPP program. They are reviewing the eight-week period of evaluation. LPTC has received guidance on the Title III salaries and will be returning the portion of the PPP loan associated with those salaries. The forgivable PPP loan will be reduced by approximately \$200,000 for Title III funded salaries.

#### HCI

33 applications for just over \$21.4 million/approved. They are reviewing the evaluation period and plan on using funds as allowed under the program. HCI estimates that approximately 4 million will not be eligible for usage under the PPP rules and will have to be repaid.

#### WinnaVegas

WV received \$2,515,100 from PPP. They are reviewing the evaluation period and plan on using funds as allowed under the program.

#### WGDC

\$185,800/approved. They are reviewing the evaluation period and plan on using funds as allowed under the program.

#### WTC

The Winnebago Tribe of Nebraska was not eligible for the PPP program.

#### HCCDC

\$79K/approved. They are reviewing the evaluation period and plan on using funds as allowed under the program.







## Statement on incident at Heritage Food Town in Walthill

There was an unfortunate incident at Heritage Food Town in Walthill involving customers contaminating some areas of the store. Fortunately, they did not come into direct contact with our employees.

The police were immediately notified, and the store was completely disinfected. All of our stores remain open.

We value the safety of our employees and customers and out of an abundance of caution, we have an FDA Approved fogging disinfection process scheduled. This process is environmentally friendly and food safe.

Out of concern, for both the Winnebago and Omaha communities, this deep cleaning fogging process is scheduled at all local stores including Winnebago, Walthill, Macy, Rosalie and South Sioux City. Any additional updates will be posted at the individual store locations.

With this matter, there is an ongoing investigation with the Omaha Tribal Police. We intend to prosecute to the fullest extent of the law.

Early on, we implemented a number of ongoing health and safety measures at our Pony Express stores including frequent cleanings, daily employee health screenings, professional disinfecting, plexiglass barriers, social distancing and limiting the number of customers in the stores. We also hired additional staff to perform frequent cleanings throughout the day.

At the Pony Market, in Winnebago, Foodtown, Emerson, Sloan and Atokad, we have dedicated cleaning staff and are working to hire at the remaining locations.

Ho-Chunk, Inc. continues to participate in the Winnebago Pandemic Task Force work including all sub-committees and the main Task Force. We are proud of the collaboration and leadership that is occurring across the entire Tribe.

## Our graduates are proud “ALUMNI” of the Little Priest Tribal College....

WINNEBAGO—Like many colleges and universities, Little Priest Tribal College (LPTC) has been significantly impacted by the CO-VID 19 pandemic. LPTC got a temporary waiver from the Higher Learning Commission (HLC) to offer the remaining of Spring semester (after March 16th) completely online. Full-time and adjunct faculty had to move all the instruction online in a span of few days. As expected, some students did not adapt well to the online modality and the college gave three options to complete the course, including an Incomplete grade.

Additionally, graduation was also impacted by the CO-VID 19 pandemic. Colleges and universities had to decide on how to deliver the commencement and were advised to work with local public health officials to decide the format of the ceremony, while following CDC guidelines and social distancing protocols.

Little Priest Tribal College's graduation date was originally set for May 9, 2020. LPTC is anticipating a virtual

ceremony in the last week of July or early August. LPTC is also planning to place yard signs at the graduate's residence to appreciate all the hard work and successes they had during their stay at LPTC.

As the pandemic continues, LPTC decided to continue with online instruction in summer as well. LPTC is offering summer courses for free to maintain continuity of the education for our community and our students.

Manoj Patil the Little Priest Tribal College President stated, "Dear students—Congratulations on your graduation and to be a proud of Alumni of Little Priest Tribal College. You are graduating at a point no one has ever seen before, but hurdles are part of life! Consider this as a challenge and conquer it, and spring forward to success. Let nothing hold you back, let your determination erase all the troubles and negativities to be the best citizen/professional you can be. On behalf of the college and Winnebago Tribe of Nebraska, I wish OUR graduates the best in life. We are here for you. LPTC welcomes you back as an Alumnus!"

## USDA to Provide \$1 Billion in Loan Guarantees for Rural Businesses and Ag Producers

WASHINGTON, D.C., May 21, 2020

—U.S. Secretary of Agriculture Sonny Perdue today announced that the Department is making available up to \$1 billion in loan guarantees to help rural businesses meet their working capital needs during the coronavirus pandemic. Additionally, agricultural producers that are not eligible for USDA Farm Service Agency loans may receive funding under USDA Business & Industry (B&I) CARES Act Program provisions included in the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

"Under the leadership of President Trump, USDA is committed to being a strong partner to rural businesses and agricultural producers and being a strong supporter of all aspects of the rural economy," Secretary Perdue said. "Ensuring more rural agricultural producers are able to gain access to much-needed capital in these unprecedented times is a cornerstone of that commitment."

In addition to expanding eligibility to certain agricultural producers, the changes Secretary Perdue announced today allow USDA to:

Provide 90 percent guarantees on B&I CARES Act Program loans;

Set the application and guarantee fee at two percent of the loan;

Accept appraisals completed within two years of the loan application date;

Not require discounting of collateral for working capital loans, and

Extend the maximum term for working capital loans to 10 years.

B&I CARES Act Program loans must be used as working capital to prevent, prepare for or respond to the effects of

the coronavirus pandemic. The loans may be used only to support rural businesses, including agricultural producers, that were in operation on Feb. 15, 2020.

USDA intends to consider applications in the order they are received. However, the Department may assign priority points to projects if the demand for funds exceeds availability.

USDA announced the expanded B&I CARES Act Program authorities in a notice published in the May 21 Federal Register. Program funding expires Sept. 30, 2021.

## Ho-Chunk, Inc. uses PPP funds to maintain employment

Ho-Chunk, Inc. was one of several entities in Winnebago that applied for and received support under the Payment Protection Program. Ho-Chunk, Inc. and its subsidiaries have received 33 loans totaling \$21.4 million under the PPP, a forgivable loan program designed to help small businesses deal with financial fallout during the COVID-19 crisis.


The loan amounts will be forgiven as long as: (1) The loan proceeds are used to cover payroll costs, and most commercial mortgage interest, rent and utility costs over the eight-week period after the loan is made; and (2) Employee headcounts and compensation levels are maintained.

Simply, PPP loan funds cover payroll expenses so that Ho-Chunk, Inc. can keep the business staffed. Documentation supporting loan forgiveness to be submitted to the lender, and will be retained by the company as recommended for the SBA audit period.

Ho-Chunk, Inc. was fortunate to receive this funding. The program's initial \$349 billion ran out in 13 days. Thanks to quick action taken by the business operations team, Ho-Chunk, Inc. is in a strong financial position moving forward and hundreds of employees' jobs are secure.

Postmaster Send Address Changes To Winnebago Indian News P.O. Box 687 Winnebago, Nebraska 68071

The Winnebago Indian News (WIN), founded in January 1972, is published bi-weekly for the Winnebago Tribe of Nebraska.

### **"Be strong and very courageous"**

Let me tell you about an old warrior who was nearing the end of his life. At one time he had been asked to serve as a scout for his tribe. Twelve brave young men, one from each of the twelve clans of his tribe, scouted the land of their enemies for forty days.

Forty years later this seasoned warrior had been chosen by YAHWEH, his Creator, to lead his tribe into this same land. This tribal leader had been encouraged by His Creator with these words, "Be strong and very courageous, being careful to act in accordance with the entire Torah (The first five books of Sacred Scripture), which Moses my servant commanded you, not turning from it to the right or to the left, so that you may succeed in all wherever you go. This Book of the Torah must never depart from your mouth, and you shall mediate on it day and night so that you will be careful to act in accordance with all that is written in it" (Joshua 1:7-8a).

Now this elderly warrior chief knew that on this very day he would be going in the way of all the earth. He had some final words of wisdom from above to speak to the whole tribe of Israel. He said, "Thus says YAHWEH, the God of Israel: In the area across the River dwelt your fathers from ancient times-- Terah, the father of Abraham and the father of Nahor-- and they served other gods. But I took your father Abraham from across the River (Euphrates), and I caused him to walk through all the land of Canaan. . . (Joshua 24:1-3a).

land. But I and my house--we shall serve YAHWEH!" (Joshua 24:14-15).

# COMMUNITY NEWS

## Senator Joni Albrecht WEEKLY UPDATE May 22, 2020

As promised, here are the Directed Health Measures (DHM) effective June 1 to June 30, 2020. There are differences between guidelines applicable to Dakota versus Thurston and Wayne Counties.

DAKOTA COUNTY will move into Phase I of the state's re-opening plan on June 1. Starting June 1, Dakota County will be subject to the following guidelines:

**GATHERINGS:** Gatherings of more than ten (10) people (excluding staff at businesses) are prohibited;

-venues such as fitness centers/clubs, gyms, health clubs, and health spas, shall also limit to ten (10) people or less AND ensure that a minimum distance of six (6) feet be maintained between all patrons.

**BARS & RESTAURANTS:**

Liquor, beer, and wine sales are restricted to carry-out sales and delivery only, to the extent permitted by law. No onsite consumption is permitted.

Food and beverage sales at restaurants, bars, taverns, private clubs, and any dine-in establishments are restricted to carry-out, drive-through, and delivery only.

Self-service buffets and self-service food bars are prohibited. Lines for carry-out and drive-through establishments must maintain social distancing guidelines.

**SCHOOLS:**

- All elementary and secondary schools-public, private, and parochial must continue to cease all in-person instruction, and all extra-curricular activities except for: remote learning, child care services, meal distribution, distribution of educational materials and supplies, general building or physical plant operations and maintenance, and residential services may be continued as needed or necessary.

**BEAUTY/NAIL SALONS/BARBER-SM MASSAGE/BODY ART FACILITIES**

- Beauty/nail salons, barber shops, massage therapy services, tattoo parlors/studios may open, but must use masks, or other item to cover an individual's mouth and nose, for all staff, practitioners and patrons.

**DAYCARE AND CHILD CARE FACILITIES:** may not exceed the lesser of the current license limit or 15 children per room/space. Statutory and regulatory staff-to-child ratio requirements are still applicable and enforceable.

THURSTON & WAYNE COUNTIES move into Phase 2 on June 1, 2020:

**BARS & RESTAURANTS**

- Restaurants remain open for dine-in and Bars, Bottle Clubs, and Gentlemen's Clubs can reopen.

-Patrons will be required to be seated while on premise unless they are placing an order or using the restroom.

-Limited to 50% of rated occupancy maximum at a time.

-Six (6) feet separation between seating of different parties.

-Six (6) feet of separation between entertainers, performers, dancers, and patrons.

-Maximum of six (6) individuals in a party (groups larger than six (6) will need to split into multiple tables).

-Food may not be consumed at bar seating.

-Games such as pool, darts, arcade games, etc. are prohibited.

- Self-service buffets and self-service food bars are prohibited. Lines for carry-out and drive-through establishments must maintain social distancing guidelines;

**CHILD CARE FACILITIES**

- Will remain at not more than 15 children per room/space.

- All other state provisions, statutes, and regulations, including child to staff ratios, still apply.

**GATHERINGS**

- Limited to the greater of 25 people (excluding staff) or 25% of rated occupancy (not to exceed 3,000) for gatherings held at Indoor or Outdoor Arenas, Indoor or Outdoor Auctions, Stadiums, Tracks, Fairgrounds, Festivals, Zoos, Auditoriums, Large Event Conference Rooms, Meeting Halls, Indoor Theaters, Libraries, Swimming Pools, or any other confined indoor or outdoor space.

-Groups shall be no larger than six (6) individuals and each group separated by six (6) feet

-Parades, carnivals, midways, dances and street dances, and beer gardens are prohibited through June 30 and may be extended.

-Parades where patrons remain in their vehicles and the public does not line the streets are permitted.

-Dance recitals are permitted but must follow the gathering requirements.

-Drive-in movie theaters may open at full capacity as long as patrons remain in/on their vehicles while

viewing the movie and congregating at concession and restroom areas are not permitted.

-Plans for reopening must be submitted to the local health departments and approved for all indoor and outdoor locations/venues that hold 500 or more individuals. The reopening plan must contain planned number of guests, how the location will meet social distancing guidelines, and sanitation guidelines.

**GYMS, FITNESS CENTERS/CLUBS, HEALTH CLUBS & HEALTH SPAS:**

- Will be limited to the greater of 25 people (excluding staff) or 50% of rated occupancy.

-Must ensure a minimum distance of six (6) feet be maintained between all patrons.

**SALONS, BARBER SHOPS, MASSAGE/TATTOO/BODY ART FACILITIES:**

- Will be limited to the greater of 25 people (excluding staff) or 50% of rated occupancy.

- Chairs/stations must remain at least six (6) feet apart.

- Both workers and patrons are still required in the Directed Health Measure (DHM) to wear masks at all times.

- An exception will be made for services provided by estheticians. Patrons will be permitted to remove their mask while receiving services directly. The mask must be worn by the patron at all other times while on the premise.

**WEDDING & FUNERAL RECEPTION VENUES:**

-Limited to the greater of 25 people (excluding staff) or 50% of rated occupancy.

- Six (6) feet separation between seating of different parties.

- Maximum of six (6) individuals in a party (groups larger than six (6) will need to split into multiple tables).

- Self-serve buffets and salad bars are prohibited. Venue staff must serve food directly to all individuals.

- No dances or other social events that require guests to gather outside of their respective tables are permitted.

**STATEWIDE:**

**TRAVEL QUARANTINE:** All individuals returning from international travel only will be required to quarantine upon returning to Nebraska for 14 days. The restriction will not apply to individuals traveling in connection with military service or in connection with employment at a health care facility.

**SPORTS:** Team sports have been categorized by contact level (contact, limited-contact, non-contact) based on guidance from the April 2008 American Academy of Pediatrics Classification of Sports According to Contact. These categories will be used for determining the opening of different team sports

- Limited and Non-contact team sports including baseball, softball, and volleyball practices may begin June 1.

- Limited and Non-contact team sports including baseball, softball, and volleyball games may begin June 18.

- Rodeo events may also begin starting June 1.

- Rodeos are permitted to follow Gatherings DHM requirements.

- Contact sports like basketball, tackle football, soccer, wrestling, etc. remain prohibited.

**SCHOOLS:** School gyms and weight rooms are permitted to follow gyms, fitness centers/clubs, health clubs, and health spas DHM requirements.

**FAIRS & LIFESTOCK SHOWS/ EVENTS**

Guideline documents have been created for county fair officials and livestock show managers to use as they work to determine what 2020 events might look like. Guidelines can be found at the Nebraska Department of Agriculture site [www.nda.nebraska.gov/COVID-19](http://www.nda.nebraska.gov/COVID-19).

**ASSISTANCE**

On Monday, May 18, President Trump announced \$16 billion in direct payments to farmers and ranchers to mitigate damages including depopulation through the Coronavirus Food Assistance Program (CFAP). Eligible Ag producers may start to sign up for the payments on May 26, 2020. ## Three Additional COVID-19 Cases Confirmed in Winnebago

WINNEBAGO, NE – The Winnebago Comprehensive Healthcare System, which is comprised of the Winnebago Public Health Department (WPHD) and Twelve Clans Unity Hospital (TCUH), have confirmed three more cases of COVID-19 in Winnebago. The Winnebago Reservation now has had a total of nineteen positive cases of COVID-19. Of those nineteen cases, eight individuals have recovered.

The three patients that tested positive are in good condition and are recovering at home in isolation. The WPHD continues to monitor and notify any potential contacts of all positive cases. To protect the privacy of the all, no other details will be released at this time.

COVID-19 is a respiratory illness with no known cure or vaccine. Winnebago community members experiencing shortness of breath, sore throat, runny nose, and cough are urged to call the COVID-19 Hotline at (402) 922-1508. Per Center for Disease Control and Prevention (CDC) guidelines, it is recommended that individuals stay home except to get necessary medical care. Individuals with underlying conditions, such as diabetes or those with compromised immune systems are the most high-risk for contracting the virus.

Prevention measures include washing your hands often with soap and water for at least twenty seconds each time and routinely cleaning frequently touches surfaces. Other recommendations include

social distancing, wearing a mask in public, and remaining at least 6 feet away from each other with groups of no more than 10 people.

Winnebago Comprehensive Healthcare System has been taking many important steps to further protect the health and safety of the community. These steps, among others, have included implementing a no visitor policy within the hospital, increasing the frequency of cleaning facilities, making certain services available remotely, implementing a drive-thru pharmacy, and placing staff on telework status when possible.

Winnebago Comprehensive Healthcare System is operated by the Winnebago Tribe of Nebraska and consists of two divisions. Twelve Clans Unity Hospital is a 13-bed state-of-the-art healthcare facility that serves an estimated 10,000 Native Americans who live on the Winnebago Reservation and in the surrounding region. Health care services provided by the hospital include an ambulatory care clinic, inpatient care, express care clinic, pharmacy, radiology, emergency care, medical laboratory, physical therapy, social services, and more. The Winnebago Public Health Department strives to create and maintain a healthy community by providing a wide range of total health and wellness programs. These programs include physical, mental, safety, and social services that benefit the Winnebago community.






