LaMere Family Honors Winnebago Tribal Member killed in Action in Vietnam

South Sioux City, NE—On July 3rd, the LaMere family organized a 50th Memorial Ceremony for Anthony John LaMere, the only Winnebago Tribe member killed in Action in Vietnam on July 1st, 1971.

50 years later, LaMere's legacy continues to impact the lives of many. This was evident during the ceremony at Siouxland Freedom Park in South Sioux City, NE. The memory of LaMere was celebrated with a ceremony, songs and a meal.

"It was a great day for the LaMere family. It was an emotional day, starting with the view looking over the top of the Vietnam Veterans Wall and seeing friends and relatives coming into the park. Some old, some young, but

all came to honor this fallen Winnebago Warrior, SP4 Anthony J. LaMere, 50 years after his passing. His sacrifice will always be remembered with the etching on the wall and speaking his name. It was a perfect day with the drum group singing the LaMere song and concluding with the 21 Gun Salute and Taps. We made all our relatives proud and smile on the other side of Maunas creation" said Tony Wood the nephew of LaMere.

The Winnebago Veterans Association Honor guard opened the ceremony with posting of the Colors and New Breed Drum Group singing the Flag song. John Blackhawk was the Master of Ceremonies (MC).

If you met him, you would remember him. His magnetic personality, his leadership, and his love for the rhythm and blues.

On July 3rd, a tribute to the talented harmonica player Curtis St. Cyr was held at the 30th annual Saturday in the Park.

Saturday in the Park is one of Iowa's largest music festivals and attracts around 50,000 people from all over.

St. Cyr was one of the original performers, performing at the first annual Saturday in the Park.

In total, he performed a record of 8 times. "No other band has done so, and no other band has played twice. It was an honor for him to be asked back each time. He was good at it,

he brought a new show each time, playing with different band members" shared Theresa St. Cyr wife of Curtis St. Cyr.

"He was very musical. He came from a very musical family. His father brought back his first harmonica from Mardi Gras, from there he started playing harmonica. That's what he specialized in was the harmonica and singing. He was asked to sing multiple times for friends, family, and relatives at funerals and he did so willing without hesitation" continued Mrs. St. Cyr.

David Bernstein the Co-Founder of Saturday in the Park said "Curt is a record holder that's for sure. Curt honestly brought legit blues. He had such a soulful voice, a beautiful voice and also was a great harp player. Curt could have been anywhere. He

could have been in Chicago, to me that's the home of the blues."

"When he left this Earth, I know Saturday in the Park was with him and we appreciate everyone who came out and showed their support. We appreciate the Saturday in the Park organization for honoring his legacy and his memory" said Garan Coons son of Curtis St. Cyr.

"We want his legacy to live on through his children, grandchildren so they know what their grandpa was all about. He was a very humble, kind hearted person. He had passion for music and his family" shared Mrs. St. Cyr.

The Winnebago Tribal Council & Winnebago Pandemic Taskforce

Approve a \$1,500 Assistance Payment to all Winnebago Tribal Members

These funds are provided through the U.S. Department of Treasury's American Rescue Plan Act of 2021 (P.L. 117-2); State and Local Fiscal Recovery Funds. The program is intended to support efforts to address negative economic impacts to communities and individual households.

Important Changes to the Child Tax Credit

Recently, there were changes made to the child tax credit that will benefit many taxpayers. As part of the American Rescue Plan Act that was enacted in March 2021, the child tax credit:

Amount has increased for certain taxpayers

Is fully refundable (meaning you can receive it even if you don't owe the IRS)

May be partially received in monthly payments

The new law also raised the age of qualifying children to 17 from 16, meaning some families will be able to take advantage of the credit longer.

The IRS will pay half the credit in the form of advance monthly payments beginning July 15. Taxpayers will then claim the other half when they file their 2021 income tax return.

Though these tax changes are temporary and only apply to the 2021 tax year, they may present important cashflow and financial planning opportunities today. It is also important to note that the monthly advance of the child tax credit is a significant change. The credit is normally part of your income tax return and would reduce your tax liability. The choice to have the child tax credit advanced will affect your refund or amount due when you file your return. To avoid any surprises, please contact our office.

Qualifications and how much to expect

The child tax credit and advance payments are based on several factors, including the age of your children and your income.

The credit for children ages five and younger is up to \$3,600 — with up to \$300 received in monthly payments.

The credit for children ages six to 17 is up to \$3,000 — with up to \$250 received in monthly payments.

To qualify for the child tax credit monthly payments, you (and your spouse if you file a joint tax return) must have:

Filed a 2019 or 2020 tax return and claimed the child tax credit or given the IRS your information using the non-filer tool

A main home in the U.S. for more than half the year or file a joint return with a spouse who has a main home in the U.S. for more than half the year

A qualifying child who is under age 18 at the end of 2021 and who has a valid Social Security number

Income less than certain limits

You can take full advantage of the credit if your income (specifically, your modified adjusted gross income) is less than \$75,000 for single filers, \$150,000 for married filing jointly filers and \$112,500 for head of household filers. The credit begins to phase out above those thresholds.

Higher-income families (e.g., married filing jointly couples with \$400,000 or less in income or other filers with \$200,000 or less in income) will generally get the same credit as prior law (generally \$2,000 per qualifying child) but may also choose to receive monthly payments.

Taxpayers generally won't need to do anything to receive any advance payments as the IRS will use the information it has on file to start issuing the payments.


IRS's child tax credit update portal

Using the IRS's child tax credit and update portal, taxpayers can update their information to reflect any new information that might impact their child tax credit amount, such as filing status or number of children. Parents may also use the online portal to elect out of the advance payments or check on the status of payments.

The IRS also has a non-filer portal to use for certain situations.

Qualification of Candidates

- Be twenty-five years of age or over and a qualified voter.
- Be a resident of the Winnebago Tribe of Nebraska, defined as having a physical presence within the reservation for six consecutive months immediately preceding the date of election.
- Be an enrolled member of the Winnebago Tribe of Nebraska.
- Not have been convicted, terminated, removed or resigned from any tribal position for reasons of theft, stealing, misappropriation of funds, embezzlement, conversion or any related offense from the Winnebago Tribe of Nebraska.

How to Apply:

1. Must meet all qualifications for candidacy
2. Submit all required documentation, your completed declaration for Notice of Intent and required drug test results to the Tribal Administration Office, of the Blackhawk Community Center
3. Submit a fee of \$50 or a Petition in lieu of the fee containing at least 50 signatures of persons eligible to vote in the 2021 Primary Election stating that they support your candidacy of office; this form is located in the Tribal Administration Office

\$1,500 coming to your bank account...What's the first thing you're going to do with it?







LeMere Family Honors Winnebago Tribal Member killed in Action in Vietnam

this kind of song. It's not forgotten. It's kept in the heart" shared from a historical article from 1971.

Written Statement from Bob Kerrey shared by Jennifer LaMere:

"The most patriotic speech I ever heard was given by one of the finest men I ever knew: Frank LaMere. Frank was a friend, a good friend. And the speech he gave was actually supposed to be an introduction of me.

His introduction was far more memorable than my speech, which even I have forgotten.

Frank talked about his brother Tony who had been killed two weeks after his twentieth birthday near Quang Tri, Vietnam on July 1st, 1971. Fifty years ago.

All Frank did to capture his brother's sacrifice was to describe all the things - good and bad - that Tony had missed.

President Nixon's re-election and resignation.

Meeting and marrying the love of his life and building the family of his dreams.

The Godfather, The Deer Hunter, Disco, and bell bottom pants.

He missed the peace agreement that ended the war and the welcome home for Americans released from Vietnamese prisons.

And more. Much more.

Frank's slow, quiet description of all that his brother missed brought tears to my eyes. Remembering it still does.

To all of you celebrating and remembering the brief, brave life of Tony LaMere: Thank you. I wish I could be with you."

Written statement by Frank LaMere, brother of Anthony J. LaMere, Childhood History and Details on Anthony J. LaMere's life:

"Specialist Four Anthony John LaMere, a member of the Winnebago Tribe of Nebraska, was killed in action on the 1st of July 1971 in the Quang Tri Province of Vietnam. He died at the age of 20 years and 20 days while walking the point position on a combat patrol when a member of his platoon stepped on a booby trap. Anthony was a member of the Bear Clan who was serving with Company B, 1st Battalion, 506th

Infantry of the 101st Airborne Division, the "Screaming Eagles." He was awarded the Bronze Star, the Air Medal and the Purple Heart for his service and sacrifice and left behind a proud Gold Star family and a people who honor and remember him.

Tony was born on June 12, 1951 and attended grade schools in South Sioux City and Winnebago Nebraska. He graduated from the 8th grade at St. Augustine's Indian Mission in Winnebago and attended Trinity Prep Seminary in Sioux City, Iowa. He graduated from Immaculate Conception High School in Stephan, South Dakota in 1970 before he enlisted in the Army on August 6, 1970.

Tony left behind four brothers, three of whom served in the Vietnam era, and five sisters. He was the son of John LaMere and Matilda Rogue LaMere. He was the grandson of Pete LaMere and Iva Littlewolf LaMere and Charlie Rogue and Fern St. Cyr Rogue. Tony's parents and his grandparents are all gone now but many nieces and nephews have come and one nephew bears his name.

He is remembered as a courageous young Winnebago boy who gave his life that people may live and may live free. He gave all of his Ho-Chunk relatives the right to stand on his shoulders and to talk of how things could be and how things should be for the people and the generations to come. It is a sacred responsibility that we who remain must undertake every day of our life. A letter received from Tony written before his death spoke to his resolve, humility and commitment and should be a testament to how we as Ho-Chunk people should face adversity. "I can take no pride like others here in saying that I am fearless or unafraid when I go into battle. I can only take pride in the fact that I go out on patrol day after day with fear and death all around me." He acted for the people and we remember our Ho-Chunk relative." Anthony is remembered on Panel 3W, Line 96."

Winnebago Reaches 70% COVID-19 Vaccination Rate for Community Members 12 Years Old and Up

Winnebago, NE – The Winnebago Public Health Department (WPHD) has announced that 70% of people living in Winnebago who are at least twelve years old have received at least one dose of the COVID-19 vaccine. WPHD has conducted weekly community vaccination clinics since January of this year and they continue to be held every Wednesday at Winnebago Public School. The clinic is open to any individual who is twelve years old and older. The vaccine available is the Pfizer-BioNTech COVID-19 vaccine, which is a two-dose series given 21 days apart.

"Reaching this milestone reflects the commitment that the Winnebago Community has to keeping their people safe. We are honored to be a part of this fight against COVID-19, and I am proud of our staff who have worked tirelessly to help get us to this point," said Mona Zuffante, WPHD Public Health Administrator.

The Pfizer vaccine is a mRNA COVID-19 vaccine and is shown to be 95% effective at preventing COVID-19 and its variants. In general, vaccinated

individuals who are infected with COVID-19 experience mild symptoms and are at less risk of mortality.

Vaccinations in Winnebago increased after the Winnebago Tribe of Nebraska announced plans to hold their 155th Annual Winnebago Homecoming Celebration on July 23rd - July 25th, 2021. To attend this free event, the Tribe is requiring all in attendance to be fully vaccinated against COVID-19. Individuals will be required to present their COVID-19 vaccination record card or immunizations prior to entry. Children 0-11 can attend the event if accompanied by a fully-vaccinated adult.

Currently, there are no active cases of COVID-19 in Winnebago and WPHD is continuing to work toward their goal of vaccinating at least 80% of the Winnebago Community. Anyone interested in receiving their COVID-19 vaccine can call (402) 878-2258 or visit www.Winnebago-PublicHealth.com/Vaccine. A representative from the WPHD will contact each patient by phone to schedule a vaccine appointment time.

Graft Union Incompatibility

Lots of trees can be grafted—fruit trees, shade trees, and even small ornamental trees. Grafting is the art of putting together two different parts of trees to make one new tree. Unlike Frankenstein, the results are not monstrous, but instead the new tree will have some of the best traits of each of its parts. The rootstock can impart things like dwarfness, winter hardiness, and soil pH adaptability, among other positives. The top of a graft union, called the scion, may bring bigger flowers, more fruit, and/or a different form than normally found (think of a lilac bush grafted onto a standard). If a cutting can be slow to root, grafting to a root system can get the plant off to a quicker start, making for a saleable tree sooner rather than later.

While nurserywomen and men seek out closely related rootstock-to-scion-wood unions to ensure grafting success, sometimes issues of incompatibility develop. These issues can occur right away, or they can develop 15 years after the tree has been planted in its permanent home. Symptoms of graft union incompatibility are odd, with a range of curious developments. The trunk may develop girth far beyond the size of the rootstock, giving the plant a bulging top-heavy appearance. Another indication of graft union incompatibility is overgrowth of roots, with roots aggressively forming, one

over the top of the other, gradually encompassing and constricting the scion itself. When this occurs, reduced leafing and branch dieback in the scion are typical. The important thing to remember with graft union incompatibility is that it is a location of weakness, leading to possible breakage at the juncture.

There are a few reasons why graft unions fail. Sometimes the rootstock and scion are not related closely enough. If the two components belong to the same plant family but not the same genus, then incompatibility can develop. Another possibility—disease-causing organisms—may be present when the parts are grafted, sealing in pathogens, and creating the perfect environment for their growth and development. A final possibility for graft incompatibility is the grafting technique itself. There are a number of grafting methods, each with its own benefit but not necessarily suited to all grafting endeavors.

Not all bulges at the base of grafted plants are indications of graft incompatibility. A slight swelling is normal. Roses are some of the most common grafted plants in our landscapes. Monitoring their growth is necessary to ensure sprouts arising from the graft union or below are removed.

"God's Wisdom found in the cross of Christ"

Paul continues: 'For since in God's wisdom the world did not know God through its own wisdom, it was his good pleasure to save those who believe through the foolishness of preaching' [1st Corinthians 1:21 Lockwood translation].

It is in the power of the cross that the just wrath of Creator God was paid in FULL by Jesus. Jesus sure appeared weak and powerless as He hung, beaten, bloody, stripped naked, insulted, ridiculed, and dying. The powerful religious and political leaders thought that they had won as they did their best to crush the life out of Jesus.

In their craving for power they did not stop at anything - paying one of his disciples to betray him, telling lies, holding court against their own rules in the dark and the dead of the night, riling up crowds to scream 'crucify him, crucify him' and even having a notorious terrorist of his day released. Their blood thirsty hunger and thirst for power was

never satisfied.

However, Creator God used their own wicked ways to fulfill His will - and the will of God was done as His very own Son suffered like a helpless lamb led to the slaughter. Jesus fulfilled the role that He knew full well when he left the glory of heaven and humbled himself taking on flesh and blood.

God's Sacred Word reveals that the apparent folly of God is wiser than people. Jesus' apparent weakness as He hung helpless and in agony on the cross is stronger than people. For those who are being saved, the cross that Jesus was crucified on is the power of Almighty God!

The foolishness of the cross made Jesus appear as if he didn't have a brain in that head of his. Jesus had been nailed to a piece of wood, much like a brainless scarecrow, without the apparent sense to answer the Roman Governor Pontius Pilate in a way that would have got him off the hook.

The spiritual leaders, the High Priests, the Pharisees, the Saducees, the Herodians, as well as King Herod - all saw Jesus as utterly foolish. And as the Good News of Jesus life, suffering, death and resurrection spread - the Greeks and philosophers could not understand the wisdom of God. Many of these philosophers had gathered in Corinth. There are countless so-called scholars and 'wise guys' of today who reject Jesus and those who believe in Him.

And yet, this foolishness is wise beyond any degree that the educated can bestow in this world.

Jesus was not 'brain-dead.' Jesus and His Heavenly Father outsmarted the brainiacs of the world. Paul brings this section to a close with these words: 'For God's folly is wiser than people and God's weakness is stronger than people' [1st Corinthians 1:25 Lockwood translation].

See what a difference of perspective one has depending on how one sees or how one understands the cross of Jesus. Now, how do you see the cross of Jesus Christ?

What does it mean when they say the air quality outside today is Good or Bad? How do they measure Air Quality?

If you google "Airnow.gov" you'll find the Air Quality Index (AQI). The AQI works like a thermometer that runs from 0 to 500 degrees. But, instead of showing changes in temperature, the AQI shows changes in the amount of pollution in the air. The closer to Zero the AQI is, the cleaner the air.

The EPA has focused on six of the most common air pollutants found in our air - also known as "criteria" air pollutants. The AQI combines information from five of the six criteria pollution data from ground-based and satellite detection equipment and report real-time levels from different parts of the country.

So, what pollutants are being looked at in the AQI?

Carbon Monoxide - This gas mainly comes from fossil fuel-driven vehicles and machinery although it's formed from burning nearly anything. The entire nation meets the carbon monoxide air quality standards, mostly because of emissions standards for new motor vehicles under the Clean Air Act.

Particulate matter (PM) - is that fine dust found in the air; measuring between 5 and 100 times smaller than the width of a human hair! PMs are emitted into the air from all sorts of activity like construction sites, driving on unpaved roads and fields, or from the release of smoke and soot into the air from burning or vehicle emissions. Breathing air with high levels of PM (especially fine particles) can go deep into your lungs and may even find its way into the bloodstream.

Ozone - O3 can be good or bad depending on where it's found in the at-

mosphere. The ozone layer found in the upper atmosphere is "good" because it protects us from harmful radiation from space. However, ozone formed in the lower part of the atmosphere is "bad". Low-level ozone occurs through a chemical reaction where radiation from the sun splits off an oxygen atom from a nitrogen dioxide NO₂ molecule. The free-floating oxygen combines with the oxygen (O₂) that we breathe, forming a chain of 3 oxygen atoms. O₃ or ozone is harmful if breathed - triggering asthma attacks, destroys living cells, and is harmful to the environment.

Nitrogen dioxide & Sulfur dioxide -- are formed from fossil fuel combustion. Both pollutants cause many adverse respiratory effects including increased asthma symptoms respiratory illness as well as environmental damage.

Lead - While lead is part of the six common pollutants, it's not included in the AQI due to the length of time required to determine real-time lead levels. Airborne Lead pollution has been reduced greatly since the banning of leaded fuels, though large lead-emitting industrial facilities still exist. Lead harms the neurological system causing all sorts of cognitive problems as well as heart disease and high blood pressure.

Understanding the quality of air you breathe is important to you and your family's health and development. So check out AirNow.gov and see what your outdoor air quality is like. If someone in your family suffers from some type of breathing problem, knowing your air quality can be a helpful tool in planning your day.



5-201 Eligible voters. Any recognized member of the Winnebago Tribe eighteen years of age and over and who has maintained residence within the reservation for a period of six months prior to the date of the regular election shall be a qualified voter. This ordinance further provides that the voter shall register in accordance with Section 5-202(3) of this Article. [TCR 04-07]

- Residence, for the purpose of this Article, shall be defined as physical presence within the reservation for six consecutive months immediately preceding the date of election, except that temporary absences from the reservation for purpose of:
 - Temporary employment.
 - Military service.
 - Attending a meeting, conference, training session or workshop.
 - Illness or physical disability.
 - Vacation.
 - Attending school, college or a university shall be considered as physical presence. Employment absences of more than twelve months shall not be considered as temporary.
 - Any recognized member of the Winnebago Tribe of Nebraska who is elderly and confined to a nursing or convalescent home but who maintained residence within the reservation for a period of six consecutive months immediately prior to being placed in a nursing or convalescent home shall be considered to have maintained residence on the reservation.
 - Any recognized member of the Winnebago Tribe who is incarcerated for a period of less than twelve months but who maintained residence within the reservation for a period of six consecutive months immediately prior to being incarcerated shall be considered to have maintained residence on the reservation.
- Recognized member, for the purpose of this Article, shall be defined as any person who is an enrolled member of the Winnebago Tribe of Nebraska. [TCR 04-07]

5-202 Election board.

- Election board members. A seven-member reservation election board shall be appointed by the

Tribal Council not less than ten days prior to the primary election for the purpose of supervising elections to be held under this Article. All reservation election board members shall be administered the oath of office. (Exhibit #1.) All election board officials shall be sent a copy of this Article.

- The reservation election board offices shall be:
 - Two judges.
 - Three clerks.
 - Two sergeant-at-arms.
- Duties of the reservation election board:
 - The election board officials are required to read this Article before election day.
 - Registration of voters. The reservation election board shall permit any eligible voter whose name appears on the "Eligible Voter List" of the Winnebago Tribe of Nebraska to register at the polls to vote once in the election. Each person desiring to register and vote at the polls shall sign the register (Exhibit #2) with his/her name, address, date of birth, period of latest residence, and if temporarily absent from the reservation, the reason for such temporary absence.
 - The eligible voter list shall be approved by the Tribal Council at a duly called meeting, which shall be held on the second Monday in June. The eligible voter list from the previous year's election shall be updated by the Tribal Council at this meeting. The eligible voter list shall contain an appendix of those persons who will turn 18 years of age between the dates of the Primary and Regular Elections. Said persons shall be considered eligible voters for the Regular Election but shall not be considered eligible voters for the Primary Election, nor shall their names be counted toward the fifty (50) signatures required for a petition in 5-217(d). The inclusion or omission of a voter's name may be challenged by any physical resident member of the reservation within five days following posting. Challenges shall be in writing and presented to the Tribal Council. The Tribal Council shall make the final decision on the voting list challenge. A final and irrevocable eligible voters list shall be posted by the Tribal Council no later than the last Friday in June.
 - Except as provided in (C), only those qualified voters whose names appear on the eligible voting list of the reservation shall be entitled to vote in the election.
 - The Office of the General Counsel shall conduct training for the Election Board to insure they receive adequate knowledge of their duties under this Article. [TCR 01-105]

5-203 Notice of election. The Tribal Council shall prepare a notice (Exhibit #3) of the dates of elections and give such notice as is appropriate to inform the eligible voters of the date, time, and polling place, including, but not limited to posting of the notice in the Tribal office, the Bureau of Indian Affairs, the local United States Post Office and other places throughout the reservation. In addition, newspaper, radio and television may also be used. The notice of election shall be posted in those places provided for herein not less than ten days prior to the election.

5-204 Qualification of candidates.

- A candidate for the Tribal Council shall:
 - Be twenty-five years of age or over and a qualified voter.
 - Be a bona fide resident of the Winnebago Reservation of Nebraska. A bona fide resident shall be defined as an enrolled member with a physical presence within the boundaries of the Winnebago Reservation for a minimum of six consecutive months immediately preceding a Tribal election and as further defined in Section 5-201 of this Article.
 - Be an enrolled member of the Winnebago Tribe of Nebraska.
 - Not have been convicted, terminated, removed or resigned from any tribal position for reasons of theft, stealing, misappropriation of funds, embezzlement, conversion or any related offense from the Winnebago Tribe of Nebraska.

- The Tribal Council shall be the sole judge of the qualifications of its own members, as defined in the By-Laws, Article II, Section 1. The decision of the Tribal Council on the eligibility of candidates shall be final and candidates must be approved through the Eligible Voter List.
- The Tribal Council shall provide a certified listing of qualified candidates for office on the Tribal Council. The secretary of the Tribal Council shall post a list of candidates in respective locations as defined in Section 5-203 of this Article at least seven days prior to the election. A copy of this Article shall also be posted in the polling place at least seven days prior to the election. [TCR 20-132]

5-205 Ballots.

- The Tribal Council shall provide the reservation election board with official printed ballots (Exhibit #4). The names of qualified candidates shall appear on the official printed election ballots in alphabetical order. A person may vote for up to three candidates. A voter may vote for a person or persons (up to three) not appearing on the published ballot by writing the name of said person or persons legibly on the ballot.
- Any ballot on which erasures have been made or on which more names have been marked than the number of vacancies for office, or which do not have the initials of the two judges and the three clerks shall be considered spoiled ballots and shall not be counted. No ballot shall be considered spoiled solely because less than three names have been marked. The election board shall certify to the number of votes cast, and the number of spoiled ballots and the final results of the election (Exhibit #5).

5-206 Absentee ballots.

- Qualified voters for the purpose of this Article as defined in Section 5-201 of this Article, who are temporarily absent or otherwise unable to cast their ballots at the polling place on the reservation for any reason shall be entitled to vote by absentee ballot. Requests for such ballots must be in writing and filed with the secretary of the Tribal Council at least ten days prior to the date of election.
- The Tribal Council shall determine the person's eligibility to vote immediately and shall give or mail an absentee ballot to the eligible voter in sufficient time to permit the eligible voter to execute and return it on or before 8:00 p.m. on the date of election. Together with the ballot, there shall be an inner envelope bearing on the outside the words, "Absentee Ballot," an envelope pre-addressed to the reservation election board, c/o the Secretary of the Winnebago Tribal Council, Winnebago, Nebraska, and an affidavit in the following form:

I, _____ do solemnly affirm that I am an enrolled member of the Winnebago Tribe of Nebraska; and I shall be eighteen years of age or over on the election date. I have resided on the Winnebago Reservation in Nebraska for the six consecutive months immediately preceding the election and am entitled to vote in the election to be held and that I cannot appear at the polling place on the reservation on the date of election because I expect to be absent from my reservation.

(Voter)

Subscribed and sworn to me before this _____ day of _____, and I hereby certify that the affiant exhibited the ballot to me unmarked; that he/she then in my presence and in the presence of no other person, and in such manner that I could not see his/her vote, marked such ballot and enclosed and sealed the same in the

envelope marked "Absentee Ballot."

(Notary Public)

- Upon receipt, by the secretary of the Tribal Council, of the absentee ballot in the special pre-addressed envelope, the secretary shall immediately secure the unopened envelope which shall be given to the reservation election board on the day of election.
- The eligible voter shall make and subscribe to the affidavit before any officer authorized by law to administer oaths, and thereupon in the presence of such officer and of no other person, make such absentee ballot, but in such manner that the officer shall not know how the ballot was marked. After marking the absentee ballot, it shall, in the presence of the officer, be placed in the envelope marked "Absentee Ballot" and the envelope sealed. The "Absentee Ballot" envelope shall then be placed in the larger envelope together with the affidavit and mailed or delivered to the secretary of the Tribal Council. Absentee ballots must be received by the secretary of the Tribal Council who shall furnish them unopened to the reservation election board not later than the closing of the polls at 8:00 p.m. on election day to be counted. The secretary of the Tribal Council shall maintain a record (Exhibit #6) of absentee ballots mailed or delivered, to whom mailed or delivered, the date of mailing or delivering, the address on the envelope or the address to where delivered, the date of the return of the absentee ballot and from whom delivered, to whom ballot given, if other than the absentee voter and a copy of this record shall be given to the reservation election board at the time the absentee ballots are turned over to them by the secretary of the Tribal Council and they shall certify the absentee ballots were received unopened (Exhibit #7). The reservation election board shall count and register all such votes after all other ballots have been counted and include them in the results of the election.

5-207 Conduct of elections.

- The reservation election board shall supervise the general conduct of elections. The Tribal Council shall provide an alphabetical list of eligible voters to the reservation election board. The reservation election board shall resolve all questions as to eligibility of voters, resolve all disputes arising from the tabulation of ballots cast in the polling place, compile the total votes cast at the election poll and the absentee ballots, certify the votes cast (Exhibit #5) and notify the Chairman and the secretary of the existing Tribal Council of those persons certified as elected to the Tribal Council immediately.
- It shall be the responsibility of the Tribal Council to make arrangements for the polling place, obtain all materials such as ballots, voting booths or other facilities, which will assure a secret ballot, pencils, ballot boxes, and to establish such records as are required by this Article.
- It shall be the responsibility of the judges of the reservation election board to verify, in the presence of the other members of the reservation election board, that the ballot box is empty of all ballots prior to the opening of the polls and the ballot box shall be padlocked.
- The judges shall:
 - Count the ballots provided by the Tribal Council.
 - Record the number of ballots received.
 - Open the polls at 8:00 a.m. at the prescribed location and close at 8:00 p.m. on the date of the election.
 - Authorize additional ballots for voters only if others have been spoiled.
 - Keep a record of all spoiled ballots.
 - Keep all spoiled ballots separated from other ballots and deliver such ballots to the Tribal Council along with the ballot box.
 - Assure that no other ballot other than official election ballots are deposited in the ballot box. (Any person depositing an unauthorized ballot in the ballot box shall be reported to the Tribal Council or other designated party who shall file a complaint in Court for election

tampering.)
H. Assure the proper tally of all votes cast in the election on the tally sheet (Exhibit #8).
I. Assure all ballots cast bear the initials of the two judges and the three clerks.
J. Prepare and deliver in the locked ballot box all properly cast ballots, all spoiled or mutilated ballots, all unused ballots and all records pertaining to the election on the reservation shall be given to the superintendent of the Bureau of Indian Affairs at the Winnebago Agency, who shall retain them for a period of ten years in a vault and thereafter shall have them destroyed.

- The clerks shall:
 - Assist the judges in carrying out the responsibilities of the reservation election board.
 - Be assigned all record keeping duties.
 - Assist the voters by determining whether they are qualified to vote by:
 - Providing eligible voters with a ballot.
 - By obtaining the signature and other required data, as defined in Section 5-202, of each eligible voter on a register and of those persons given ballots.
 - By assisting those voters indicating a need for help. In the event a voter indicates a need for help in casting his/her ballot, two (2) election clerks shall assist that individual in marking and/or reading his/her ballot.
 - Assist in the tally of votes cast.
- Sergeant-at-arms:
 - The sergeant-at-arms shall be responsible for maintaining the orderly conduct of the election and for enforcing the provisions of the ordinance.
 - The sergeant-at-arms shall have the authority to remove disorderly, disruptive persons or persons deemed under the influence of alcohol as defined under Section 5-213.
 - The sergeant-at-arms shall have the prerogative to call the proper law enforcement officers and shall have the prerogative to refer the case to the Winnebago Tribal Court for prosecution.
 - Prior to the opening of the polls, the sergeant-at-arms shall ensure all election materials are removed within 100 feet of the polling place. [TCR 20-132]

5-208 Polling place.

- The following polling place shall be used in all Tribal elections and they shall be open from eight (8:00) in the morning until eight (8:00) in the evening, Central Standard Time, on the date established for the election in accordance with the Constitution, Article V, Section 3. Alternate polling places may be used provided the election notice identifies the new polling place: Blackhawk Community Center, Winnebago, Nebraska.
- The reservation election board shall be responsible for secrecy of voting.

5-209 Conduct of election officials.

- Election officials shall not be absent from the duties of their positions from the opening of the polls until all ballots have been counted and secured in the ballot box and delivered to the superintendent of the Bureau of Indian Affairs, at the Winnebago Agency, Winnebago, Nebraska.
- The Tribal Council shall be responsible for providing all meals and snacks, which shall be delivered to the polling place, for the Tribal Election Board members and any support staff assisting with the Tribal elections. The Tribal Council shall pay two hundred fifty dollars and no cents (\$250.00) to each of the Election Board officials and any support staff assisting on the day of the Tribal election, for their services at the polling place. Such payment shall be made within two days after the date of the Tribal election.
- Election officials shall not express any preference for any candidate. [TCR 20-132]

5-210 Stickers.

- Ballots shall be secret and shall be cast by dropping into a locked ballot box.
- The use of stickers shall not be recognized as a legal method of voting for any Tribal election and shall disqualify the ballot.

5-211 Campaigning. Campaigning within one hundred feet of the polling place is prohibited.

- Any member under the influence of alcohol or controlled substance shall not be eligible to vote. The members of the reservation election board shall make all determinations under this Section and their majority decision shall be final. A person who cannot legally register his/her name on an official registration form is deemed under the influence of alcohol or controlled substance. [TCR 86-116]

- No loitering on the premises of the polling place shall be permitted during voting hours or during the official tallying of the results.

5-214 Election tampering.

- It shall be an offense, defined as "election tampering," for:
 - Any voter to vote more than once at our election;
 - To place more than one ballot in the ballot box for the same candidate; or
 - Issue, or to campaign within one hundred feet of the polling place.
- The person shall be charged with a misdemeanor, and the sergeant-at-arms shall have the prerogative to call the appropriate law enforcement officers and file charges against the individual on behalf of the Tribal Council.
- In the event election tampering has indeed taken place, the Tribal Council shall declare the election invalid, and shall hold another election which shall be held within ten days after the date of the invalidation.
 - The rules and regulations as set forth in this Section shall govern any subsequent election held because of election tampering.
 - No Primary Election shall be necessary; the names of the candidates on the ballots of the invalidated election shall appear on the ballot. [TCR 86-116]

- Alternates or substitution. The Tribal Council shall have the right to appoint a substitute or an alternate for any or all reservation election board members who are unable to serve or to carry out the duties of their offices as prescribed in this Article.

5-216 Placement on Primary Election Ballot.

- Any person meeting the qualifications for office may seek to be placed on the Primary Election ballot by filing a Notice of Intent with the Chief Administrative Officer no later than the first Monday in August nor earlier than the first Monday in July. The Notice of Intent shall be on a form promulgated by the Tribal Council and shall state that the person filing seeks to be placed upon the ballot for the Primary Election.
- The Chief Administrative Officer, or his designee, shall ensure that the Notice of Intent, along with any applicable fee as set forth in (c), or a petition as provided in (d), meets the requirements of this Article. If the requirements of this Article are met, the Chief Administrative Officer shall accept the Notice of Intent and the person filing said notice shall be declared a candidate for election and shall be so notified. This determination shall be made within ten days of receipt of the Notice of Intent. A determination that a Notice of Intent meets the requirements of this Article shall be final and may not be reversed. If the Chief Administrative Officer determines that the Notice of Intent does not meet the requirements set forth in this Article, he/she shall so state in writing, specifically

setting forth the reasons the notice cannot be accepted, and shall so inform the person filing the Notice of Intent via United States mail within ten days of receipt of the Notice of Intent. In the event the Chief Administrative Officer determines that said Notice of Intent or required submission is defective, the person filing the Notice of Intent shall be given the opportunity to cure any defects. Provided, such person shall not be allowed to cure any defects after the last day in which a Notice of Intent may be filed. Any such determination that a Notice of Intent is defective may be appealed to the Winnebago Tribal Council within five days after the determination is made. The decision of the Winnebago Tribal Council shall be final.

3. Any person filing to be a candidate for an open Tribal Council position must file a Notice of Intent along with a fee of fifty dollars (\$50.00). This fee shall be used to defray the costs of the Tribe holding the Primary and Regular Tribal Elections.
4. In lieu of the fee set forth in (c), a person may accompany a Notice of Intent with a petition setting forth at least fifty (50) signatures from persons eligible to vote in the Primary Election. Said petition shall be on a form promulgated by the Tribal Council and shall state that those persons signing support the candidacy of the person filing the Notice of Intent. Said petition must be filed with the Notice of Intent.
5. Any person filing a Notice of Intent must include the results of a ten-panel drug test, paid for by the Tribe, taken prior to submitting the Notice of Intent. [TCR 20-132]

5-217 Absentee ballots for Primary Election. Absentee ballots for the Primary Election shall be mailed out no later than the last Monday in August.

5-218 Primary election.

1. There shall be a Primary Election to determine the candidates to be placed on the ballot in the Regular Election.
2. The Tribe shall conduct a Primary Election on the first Tuesday of September. Said election shall be conducted in accordance with this Article.
3. The number of vacancies in the Regular Election shall determine the number of candidates placed on the Regular Election ballot. The number of candidates on the Regular Election ballot shall be equal to twice the number of vacancies on the Regular Election ballot.
4. The candidates receiving the highest number of votes in the Primary Election shall be placed on the ballot for the Regular Election whereby the number of candidates is twice the number of vacancies.
5. In the event of a tie for the last vacancy, all such persons tying for the last vacant spot on the ballot shall be placed upon the ballot for the Regular Election.
6. If the number of candidates for the Primary Election is equal to or less than twice the number of vacancies, then a Primary Election is not required to be held and all candidates shall automatically advance to the Regular Election. TCR #21-69

5-219 Absentee ballots for Regular Election. Absentee ballots for the Regular Election shall be mailed out no later than the last Monday in September.

5-220 Regular Election. The Regular Election shall be held on the first Tuesday after the first Monday in October in accordance with this Article.

5-221 Term of office. The three candidates receiving the highest number of votes in the Regular Election shall be declared elected for a term of three years. In the event a tie vote is received by more than three candidates on the ballot and this causes a question as to whom shall be seated, Section 5-223 of this Article shall apply.

5-222 Runoff election.

1. If candidates should receive an equal amount of votes cast in the Regular Election, which would be the determining factor as to who shall be seated, a runoff election shall be held not more than ten days after the date of the election.
- In the event a tie is still received after the second runoff election, the candidates shall draw lots to determine who shall be seated on the Tribal Council; this shall be done under the supervision of the Tribal Council. The words "Tribal Council" for the purpose of this Section shall be defined as those members whose term of office had not expired at the date of the election and those who had successfully won a seat on the Tribal Council at the just-held election who have taken the oath of office.
2. The Tribal Council as defined in this Section 5-223(2), and the reservation election board members who supervised the just-held Tribal Council election shall also establish and supervise the runoff election or elections, as the case may be, following the same rules and regulations as set forth in this Section.
3. Unexpired terms to fill all vacancies on the Tribal Council shall be filled as set forth herein.
4. Each Tribal Council member's term of office expires on the date of the election (immediately following his/her tenure in office.)

5-223 Certification and Oath of Office.

1. The reservation election board shall certify to each newly elected member of the Tribal Council of his/her election by mailing a certified, registered, return receipt requested letter (Exhibit #9) to each newly elected Tribal Council member. This shall be done within twenty-four hours from the date of the election.
2. The oath of office (Exhibit #10) shall be administered within forty-eight hours after the return of the registered letter is received by the Tribal Council or the Tribal office. The oath of office shall be administered by any officer qualified to administer an oath.
 - A. The newly elected Tribal Council members shall meet within ten days of the receipt of such certification and shall proceed to organize as provided in the Constitution, Article III, Section 3.
 - B. A majority of the Tribal Council as constituted after the election shall set the date, time and place to organize by notifying all Tribal Council members by an announcement which shall be certified with a return receipt requested (Exhibit #11). The letters shall be signed by a majority of the Tribal Council members.

5-224 Election Code Amendments. There shall be no amendments to this Article 2, Title 5, 90 days prior to the Primary Tribal Election by resolution or any other method of amendment. [TCR 20-132]

5-225 Emergencies. In the event of an emergency, as defined by this Article, the Tribal Council may adjust the election process with the commitment to execute fair and transparent elections. The Tribal Council must take all precautions to protect the right to vote in the Tribal election process and ensure the due process of the candidates. [TCR 20-132]

5-226 Unexpired Seats on Ballots

1. Pursuant to Article VI, Section 3 of the Constitution and the Bylaws of the Winnebago Tribe, when a councilmember is removed from office, dies, or resigns, the Tribal Council, by a 2/3rds vote declares the position vacant and, by a 2/3rds affirmative vote, appoints a qualified individual to fill the position until the next general election.

5-227 Special Vote to Determine Qualified Individual to Fill a Vacancy

1. In the event a councilmember is removed from office, dies, or resigns, and the Tribal Council, by a 2/3rds affirmative vote, declares the position vacant, then a Special Vote shall be held within twenty-one (21) calendar days to determine a "qualified individual" to fill the vacancy until the next general election.
2. The Tribal Council shall establish the candidate list, provided that all such persons must meet the criteria for Tribal Council candidates set forth in Section 5-204(1).
3. The Tribal Council shall provide a certified list of candidates for the vacant position. The secretary of the Tribal Council shall post a list of candidates in respective locations as defined in Section 5-203 of this Article at least seven days prior to the Special Vote.
4. The Tribal Council shall appoint a seven-member election board not less than ten days prior to the Special Vote. The election board shall be comprised of those offices set forth in Section 5-202(2), shall have those duties set forth in Section 5-207, and shall be compensated at the same rate provided for in Section 5-209. If practicable, the election board shall be the same persons from the most recent Regular Election unless a new election board has been appointed for the upcoming Regular Election. In such case, the election board shall be the newly appointed election board.
5. All persons on the Eligible Voter List from the most recent Regular Election shall be entitled to vote in the Special Vote.
6. A person may vote for one candidate per vacancy. Spoiled ballots shall not be counted.
7. There shall be no write-in candidates in the Special Vote.
8. The person with the highest number of votes shall be declared to be a "qualified individual" to fill the position until the next general election.
9. The Tribal Council shall vote to appoint the "qualified individual" to fill the vacant position until the next general election.
10. In the event there is a tie, the Tribal Council shall vote on the top vote getters to determine the "qualified individual." Once the "qualified individual" is determined, the Tribal Council shall vote to appoint that person to fill the vacant position until the next general election.
11. No person shall be seated unless there is an affirmative 2/3rds vote of the Tribal Council to appoint that person to fill the vacant seat.
12. Unless otherwise stated in this Section 5-227, the other provisions of Title 5, Article 2 shall apply.

5-400 Definitions.

1. "Candidate for Election" shall mean any person having duly filed a Notice of Intent as set forth in 5-402, and said Notice of Intent having been accepted by the Chief Administrative Officer of the Tribe.
2. "Notice of Intent" shall mean the document set forth in 5-402. Said document shall be on a form promulgated by the Tribal Council containing the following language and signed by the person seeking to become a candidate for election:

I, _____, pursuant to Title V, Article 4 hereby declare my intent to be a candidate for election to the Winnebago Tribal Council. I certify that I meet the qualifications to be a candidate as set forth in 5-204 of the Winnebago Tribal Code. I further tender with this Notice of Intent a filing fee/petition (circle one) as required by Sections 5-403 & 5-404 of the Winnebago Tribal Code. [TCR 98-19]

5-401 Repealed [TCR 98-19, 16-122]

5-402 Filing.

1. Any person meeting the qualifications for office may seek to be placed upon the Primary Election ballot by filing a Notice of Intent with the Chief Administrative Officer no later than the first day of August in the year the person seeks to be placed on the ballot, and not earlier than the first day of July of said year.
2. The Chief Administrative Officer, or his designee, shall ensure that the Notice of Intent, along with any applicable fee as set forth in 5-403, or a petition as provided in 5-404, meets the requirements of this Article. If the requirements of this Article are met, the Chief Administrative Officer shall accept the Notice of Intent and the person filing said notice shall be declared a candidate for election, and shall be so notified. This determination shall be made within ten days of receipt of the Notice of Intent. If the Chief Administrative Officer determines that the Notice of Intent does not meet the requirements set forth in this Article, he shall so state in writing, specifically setting forth the reasons the Notice cannot be accepted, and shall so inform the person filing the Notice of Intent via United States mail. In the event the Chief Administrative Officer determines that said Notice of Intent or required submission is defective, the person filing the Notice of Intent shall be given the opportunity to cure any such defects. Provided, such person shall not be allowed to cure any defects after the last day by which a Notice of Intent may be filed. [TCR 98-19]

WARHORSE UPDATE



WARHORSE™

With the closure of the Nebraska Legislative session, the process of opening WarHorse casinos around the state took a notable step forward. The state legislature passed LB 561, a bill that established the Nebraska Racing and Gaming Commission as a state entity and officially legalized sports wagering at the future casinos.

Though the bill moved the process forward, there are several milestones from a state government perspective that need to be met before Nebraska will see any casinos.

Most significantly, the new Racing and Gaming Commission has submitted rules and regulations for the casinos to the governor to review and approve. This document needs the approval of the governor before any casino can be built in the state. The regulations will establish a method for casinos to apply for a gaming license with the state – something that will be mandatory to open a casino. It will also provide a method for casino employees to be licensed with the state, which will be mandatory to work in the casinos. In short, the rules and regulations need to be signed for any casino to hire staff and open.

Though the opening of the casinos is dependent on approved rules and regulations, it is not preventing WarHorse from moving forward with the development of the properties. The architectural designs of the properties' exteriors are essentially complete, and the interior elements are wrapping up for both Omaha and Lincoln.



The parking at WarHorse Omaha was able to be reconfigured without the need for a parking garage. With no longer needing a multilevel parking garage, the construction costs for Omaha were reduced by \$20 million. Additionally, the City of Omaha has approved \$17 million in tax increment financing (TIF) to assist in the construction to the infrastructure in the area, including the road, sewage and so on – work that would have been paid for outright during the construction.

WarHorse Lincoln has seen similar success with the local city government. The development process has not faced opposition to date. The City of Lincoln was also the first city in the state to approve zoning for casino gaming, and did so with a unanimous vote of approval.

Both the Lincoln and Omaha facilities will break ground later this summer, but WarHorse Lincoln will have phased opening with a modest offering of slot machines.

"Once licenses are issued for the facilities, we plan to open a pilot operation in Lincoln of roughly 300 slot machines," said Brian Chamberlain, WarHorse Gaming LLC executive director. "This will allow us to start building a revenue stream, even while construction is underway."

WarHorse South Sioux is not as far along in the process as the other properties. The land for the South Sioux City location was purchased in late June. The site will be developed into a full oval racetrack, rather than the current candy cane shape of Atokad. Plans also include the eventual development of a hotel and event center to be added onto the casino structure.

The slower development of the South Sioux property has a strategic purpose as well.

"Omaha, Lincoln and their suburbs represent roughly 56 percent of the population of Nebraska. As significantly larger markets, it's important to move these properties along as rapidly as possible to start driving revenue as soon as we can," said Brian Chamberlain, WarHorse LLC executive director. "Ideally, we will be able to use revenue from Omaha and Lincoln to self-fund the development of South Sioux. Doing so would mean we're able to claim the profits from the property immediately, instead of paying back loans."

The current timelines show Lincoln opening preliminarily in early 2022, with a grand opening later that year. Omaha's opening is planned for mid-2023, with South Sioux City being the last of the casinos to open.
