



WINNEBAGO, NE--Twelve Clans Unity Hospital Communications Manager Emilee Longuski answers important questions and explains what we need to know about the Delta variant using information directly from the Center for Disease Control (CDC).

What is the Delta variant?

Viruses like COVID-19 can change through mutation, and new strains of the virus emerge. These strains are called variants. The B.1.617.2 variant is also known as the Delta variant and was first identified in India. This variant spreads much faster than other variants and is currently the predominant strain of COVID-19 in the United States.

What are the symptoms?

People with COVID-19, including the Delta variant, have had a wide range of

symptoms. These symptoms can appear in anyone and range from mild to severe illness. Symptoms may appear 2-14 days after an exposure to the virus and can include fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, runny nose, diarrhea, or nausea or vomiting.

Is it dangerous like COVID-19?

According to the CDC, some data suggest the Delta variant might cause more severe illness than previous strains of COVID-19 in unvaccinated persons. Fully vaccinated people who get the Delta variant are called "breakthrough infections" and can spread the virus to others. However, vaccinated people appear to be infectious for a shorter period of time. Unvaccinated people remain the greatest concern.

Winnebago, NE—Do you receive any services from the tribe? Being counted on the US Census provides services to you and your family.

The US Census Bureau website and the Planning and Development Department shared important information about the census and how it directly affects Winnebago tribal members.

What is Census?

Basically, a census is an official count or survey of a population, recording various details of an individual.

The Decennial Census is conducted every 10 years by the U.S. Census Bureau. It is a count of everyone residing in the United States on the census date of April 1st. The 2020 Census was conducted on April 1, 2020.

2020 was a tough year as many of us know and this may have affected your ability to respond to the US census due to the COVID-19 pandemic.

Why is the census important?

The census data tells and helps the nation, communities and tribes with various programs. It helps the government decide how to distribute funds and assistance to states and localities.

The census has a great deal of influence on policy for the upcoming decade.

It is used to influence and distribute funds to tribal, state, and local governments. Data gathered serves as the

foundation for policymaking, research, and program evaluation.

How does the census directly affect Winnebago?

In addition to being a tool for voting representation, demographic statistical data collected by the census play a critical role in the distribution of funding to the Winnebago Tribe of Nebraska and its programs.

Programs currently receiving formula funding, it is based on information provided to the census. These programs include:

Food distribution

Housing programs dealing with victims of crimes

Transportation

Court services

Law Enforcement services

Historic preservation efforts

WIC

Human Services Support services

Child and Family services

Healthcare

Education services including Head Start/Educare support

Without census participation, we risk losing funding for so many Public Services.

Furthermore, we rely on economic development funding for Indian Health programs, housing, Elder Abuse Preven-

tion, and water/sewer projects, roads to name a few.

When will the data be released?

Initial results of the 2020 Census record were released April 2021.

The Census Bureau will publish in-depth demographic statistics from 2020 on Monday, August 16, 2021.

Expect release of in-depth demographic statistics on tribal areas September 2021.

Census surveys results are a powerful source of information because of this we plan to challenge the use of the Decennial number provided in this census by providing alternate data sets to accomplish this and to ensure all voices are heard and that all people are counted, we request increased participation in taking census surveys such as the ACS American Community Survey. ACS is an ongoing survey.

For tribal data tabulation and information specific to Winnebago Tribe of Nebraska refer to My Tribal Area on the United States Census Bureau website at Census.gov. This a Census website that provides quick and easy access tribal data statistics from the American Community Survey.





Per, the Winnebago Tribe Election Code Section 5-218, (6): "If the number of candidates for the Primary Election is equal to or less than twice the number of vacancies, then a Primary Election is not required to be held and all candidates shall automatically advance to the Regular Election".

So, there is no need for a Primary Election in the 2021 Tribal Council Election. The Winnebago Tribe of Nebraska Regular Election is Tuesday, October 5, 2021.

Winnebago is the Pfizer vaccine. This is a two dose shot that is given 28 days apart. COVID-19 vaccines continue to be highly effective at preventing hospitalization and death, including against this variant.

Do we need a 3rd shot or booster shot? When will the health department offer those?

The FDA and CDC are currently recommending a third dose of a mRNA vaccine for people whose immune systems are compromised. Both the Pfizer and Moderna COVID-19 vaccines are mRNA vaccines. This includes people who have been receiving active cancer treatment for tumors or cancers of the blood, received an organ transplant and are taking medicine to suppress the immune system, received a stem cell transplant within the last 2 years or taking medicine to suppress the immune system, have a moderate or severe primary immunodeficiency (such as DiGeorge syndrome, Wiskott-Aldrich syndrome), have advanced or untreated HIV infection, or active treatment with high-dose corticosteroids or other drugs that may suppress your immune response. Patients should talk to their healthcare provider about their medical condition and whether getting an additional dose is appropriate for them. To schedule your vaccination appointment,

patients can call the Winnebago Public Health Department at (402) 878-2258 or go online and fill out the form at www.WinnebagoPublicHealth.com/Vaccine.

Most people with underlying chronic medical conditions (such as high blood pressure, diabetes, asthma, etc) are NOT recommended to receive an additional dose at this time.

Is the hospital still doing COVID testing?

Yes, Twelve Clans Unity Hospital is still offering COVID-19 testing for any patient. Drive-up testing is available BY APPOINTMENT ONLY and patients should call the Outpatient Department at (402) 878-3404 to schedule their testing appointment.

Many people are saying there is no way to tell if a person has the Delta variant, how does the process confirm if it's the delta or not?

COVID-19 variants can be identified through genomic sequencing, where a positive COVID-19 test is then sent to an outside lab for further testing. This process can take up to a week, but the information of an identified variant case does not change the approach to a patient's care. It is done for public health monitoring purposes only.

The Winnebago powwow being all vaccinated did that work or limit the spread?

There have not been any positive COVID-19 cases linked to the Winnebago Powwow.

My name is Tripp Letterman and I am the Library Coordinator who serves as Winnebago's Public librarian and Little Priest's Academic librarian. I've gotten a few questions and comments that has led me to believe that the community might not know about all the services and the things we do for the community so I wanted to put together this quick guide of our services just so that you are aware of them.

Communication

You might think that the only way you can get in touch with your local library is by coming in and speaking to us face-to-face and while we certainly look forward to your patronage we realize you may not always have time to come in so below, you'll see the different ways in which you can reach us.

Email – The library has an email in which you can use to contact us.

You can shoot us an email asking any questions about the library that you might have or you can use it to place holds on items in the catalog for pick-up.

As you might know, the library has a Facebook page that it manages and posts the majority of its news and events so be sure to give it a "like" and a "follow" so you can always keep up on all the library news.

Services

You might think that the only thing the library does is check books in and out and for the most part you would be right. But, in addition to that, we have other services that you might not be aware of.

Catalog – This is the first resource that can tell you what's new at the library. We're continuously adding new items that range from Books, DVD's, graphic novels, audiobooks, and coming soon (hopefully): Manga. You may not be aware but it is possible to place holds on items for pickup. You'll need to make sure you have a pin set up with us beforehand but afterwards you can login to your account and then start placing holds.

Our catalog is located on our official page. To navigate there, there are two options. The first is to go directly to our FB page and click the link on the left-hand side, this will take you directly to our revamped site and allow you to navigate our page with new changes. On the homepage, you will see the "Search Catalog" and "Search Children's Catalog", and the soon-to-be added "Search Electronic Collections". The second way is to navigate to LPTC's website and look for our tab under both "Community Resources" and "Student Resources". Both have the library under their respective tabs so you'll have easy access to them.

When you do access our catalog, the carousel on the main page is everything that has been recently added and cycles out as we add new items so be sure to check often for new items.

Printer/Fax – The library has the capacity to print and fax items.

Black and white – 10cents per page

Color – 25cents per page

Faxing – 10cents per page

Interlibrary Library – Items can be requested through the Nebraska Library Commission with some restrictions:

Recently published, popular or rare books

Entire copy of a journal

Microfilm or fiche

Thesis or dissertation

Audiovisual materials

Electronic Materials – The library has access to academic databases provided through NLC and the IMLS grant.

NebraskaAccess can be accessed on the library's main page under popular links

The library has access to two scholarly databases through EBSCO: Academic Search Complete and ABC-CLIO American Indian Experience

Specialized Help – We realize that navigating our catalog and online databases can be annoying especially if equipment is slow or unresponsive.





WASHINGTON - The National Park Service (NPS) today announced \$569,086 in grants for 12 preservation projects from across the country to support the protection of America's Indigenous cultures.

"Through these competitive grants, the NPS is able to work with American Indian Tribes, Alaska Native and Native Hawaiian communities to help preserve their cultural heritage and connect people with traditions of the past," said NPS Deputy Director Shawn Benge.

From an oral history project documenting recollections of an American Indian boarding school to regenerating the skill in cultural dance regalia making, these projects are critical to preserving Tribal heritage for future generations. Other projects funded by these grants will locate and identify cultural resources, preserve historic properties listed in the National Register of Historic Places, support comprehensive preservation planning, preserve oral history and cultural traditions, provide training for building a historic preservation program and support cultural and historic preservation interpretation and education.

There were 12 Tribal Heritage Grant Award Recipients including Winnebago Tribe of Nebraska.

Congress appropriated funding for the Tribal Heritage Grant Program in 2020 through the Historic Preservation Fund (HPF). The HPF uses revenue from federal oil leases on the Outer Continental Shelf, assisting with a broad range of preservation projects without expending tax dollars, with the intent to mitigate the loss of a nonrenewable resource to benefit the preservation of other irreplaceable resources.

Established in 1977, the HPF is authorized at \$150 million per year through 2023 and has provided more than \$2 billion in historic preservation grants to states, Tribes, local governments, and nonprofit organizations. Administered by the NPS, HPF funds may be appropriated by Congress to support a variety of historic preservation projects to help preserve the nation's cultural resources.

**Have you been wondering that you
don't know what to believe anymore?**

This is an age old problem. However, it has become a more pronounced problem with the so-called 'misinformation' that is out there. Who should I believe, especially when people have lied to me or misled me in the past?

Where should one turn? I offer one place where you can still read and hear the truth. That place is the Sacred Word of God. Let me refer you to the opening chapter of King Solomon's book of proverbs:

"The proverbs of Solomon son of David, king of Israel: to know wisdom and discipline, to understand words of understanding, to acquire discipline for acting sensibly: righteousness, justice, and fairness, to give gullible people prudence, to a young man knowledge and foresight--may a wise person listen and increase [his] learning, and may a person with understanding acquire guidance--to understand a proverb and an enigma, the words of wise people and their riddles. The fear of YAHWEH is the beginning of knowledge. Stubborn fools despise wisdom and discipline" [Proverbs chapter one, verses one through seven as translated by Andrew E. Steinmann].

The word that I would like to focus on is 'gullible.' Fourteen times in the book of Proverbs - Solomon uses this word. How does one define the word 'gullible'? To be gullible can mean: 'easily persuaded to believe something; easily deceived, cheated or duped.'

I do not think anyone wants to be gullible. And yet, how many times have you been deceived or duped? Children are often deceived. They are deceived even by their parents. Teens are easily deceived by their peers - or they easily deceive their peers. Teens can often deceive their parents.

A young person who is inexperienced and immature is open to the influences of fools and can easily be deceived and misled. Sometimes older people, through their preconceived notions are

lead to believe what they want to believe. This happens even when someone presents the facts.

Given enough exposure to the ways of foolishness, this person can become a fool who delights in his foolishness and waywardness from God, eventually suffering the punishment that awaits all fools. Not merely temporary isolation from God but everlasting and complete separation from God.

Solomon, blessed by Creator God with wisdom, had these proverbs recorded so that one would not be gullible but rather to be prudent. Please reread the first seven verses found above. One of the key teachings found in this book is 'to give gullible people prudence.'

What does the word 'prudence' or 'prudent' mean? Prudence is 'the quality of being prudent; cautiousness; the ability to govern and discipline oneself by the use reason.' And prudent means: 'acting with or showing care and thought for the future.'

When it comes to one's future one has to be wise in the present. Where is such wisdom to be found? We turn to the last verse of this text: "The fear of YAHWEH is the beginning of knowledge. Stubborn fools despise wisdom and discipline."

YAHWEH, the Hebrew name for Creator God as He revealed to Moses, is to be feared, loved and trusted above everything else. This is the first and greatest command. When one fails to fear Creator God then one is gullible and such a person will continue to fall for the lies of 'the father of lies', i.e. Satan.

When one has proper fear or respect of Creator God then one has nothing to fear, even from God. Put another way, when one knows the unconditional love of God and trusts in Jesus as one's Lord and Savior then one has nothing to fear. One of Jesus' closest disciples, John, inspired by the Spirit of God, put it this way: 'There is no fear in love, but complete love casts out fear; because fear has (to do with) punishment' [1st John 4:18 Bruce G. Schuchard translation].

On Common Ground

Food Sovereignty is both tangible and verifiable in the community of Winnebago. During the 2021 growing season, Little Priest Tribal College Extension has added 36 new members to the group that we call Common Ground Gardeners. We have recently sent out requests for photos of community member's gardens and have had some wonderful results.

As evidenced by the Tribal Garden employees selling produce at the Village Market Pavilion, it appears that they also are having a successful growing season with fresh produce varied enough to satisfy many of the members of this community.

Along with discussion of a meat processing unit and a greenhouse as well as new wells being dug, it is apparent that the Winnebago Tribe is moving in the right direction as befits a Sovereign Nation.

We, at LPTC Extension, have also been busy with projects which will culminate in a fresh stand of buffalo grass covering the grounds at the Village Market and hopefully by next spring will also include a diverse number of interactive raised garden beds, fruiting trees and vines on the property.

Angelica Parker, our Lead Gardener and Extension Assistant has been busy this summer with the campus garden beds. With weeding, transplanting, mulching and watering, Angelica has been as busy as the proverbial "cranberry merchant" as some of the "old timers" used to say. She has also had to battle the terrible hot, dry conditions to maintain the wonderful variety of plants adorning the campus.

Garden Update

Week of August 16, 2021

National Potato Day August 19

In honor of National Potato Day, let's pay homage to the spud. Here are some things to know about potatoes and potato plants:

- There are blue, white, and gold-fleshed potatoes, as well as round ones, oblong ones, lumpy ones, and fingerlings. Skin colors are red, russet, blue, and golden.

- Seed potatoes should be certified disease-free to prevent transfer of diseases to new crops and contaminating the soil. Late blight, Phytophthora infestans, will long live-in infamy as the pathogen that set into motion the Irish potato famine. The fungal spores of late blight and other pathogens can persist in soil for many years, affecting the health of future potatoes planted there.

- Seed pieces (divided potato sections with at least one eye) can be planted in early spring, 3-5 inches deep. Plants will handle a light frost but not freezing temperatures and extended cold. As plants grow, soil can be mounded up around stems to provide more opportunities for tubers to develop.

- New potatoes can be harvested by carefully pulling away the soil from the potato hill, gently pulling a few potatoes, and then replacing the soil, leaving the plant intact to continue growing.

- Juglone, the naturally occurring herbicide emitted by black walnut trees, is highly toxic to potato plants and will cause wilt. Plant potatoes well away from any black walnut trees.

- Flea beetles and leafhoppers feed on potato foliage but the most voracious eater, the Colorado potato beetle, can be the toughest to manage. The CPB has developed resistance to many of the insecticides used to manage their numbers. In a home garden, pluck beetles and their spongy offspring and drop them into a bucket of soapy water.

- Some potato varieties flower and set fruit atop plants. The green fruit is about the size of a cherry tomato and full of seeds, which do not carry pathogens like the tubers do. Indigenous people saved seeds to start plants the next year when disease problems accumulated in tubers.

- Potato scab is a flaky, crusty abrasion on the skin of the potato itself. While unattractive, it is only cosmetic, and potatoes with scab can be eaten when peeled. Scab tends to develop on potatoes growing in a soil environment with a high organic matter content.

- Potato tubers are stem tissue and capable of photosynthesis, turning green and producing an alkaloid that is toxic to humans. Keep harvested potatoes out of light and stored in a cool dry place prior to eating them.

- Potatoes and tomatoes are closely related. Hybridizers have tried crossing these plants in the hope of getting seeds that produce both tubers and tomatoes from the same plant, but, alas, got plants that produced neither. The effort has been successful, however, by grafting a tomato top to a potato root system.
