All applicants must turn in required documents to the Higher Education office:

- \* School transcript: Attendance/Grades
- \* Proof of tribal enrollment **or** Tribal Id (new applicant)
- \* Copy of Social Security card **or** Birth Certificate (new applicant)
- \* Resume
- \* Release of Information Form
- \* Drug & Alcohol consent form
- \* Must provide income for last 30 days

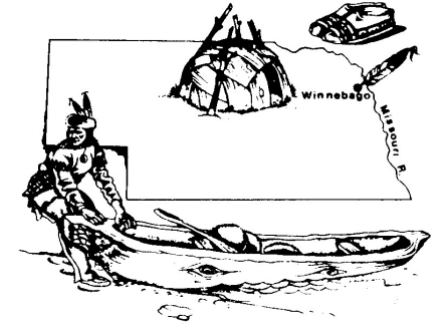

## Our Mission

To provide valuable summertime work opportunities to our community's youth.

## What is Summer Youth Employment?

Summer Youth Employment allows the youth of our reservation to receive on the job training and receive first-hand knowledge of learning new skills and build a strong work ethic for future employment within our community or surrounding area.



## Who is eligible for the Summer Youth Employment Program?

1. Must be an enrolled member of the Winnebago Tribe of NE or any federally recognized tribe
2. Must be 14-18 years old (Up to 21 for Disability/IEP)\*\*
3. Must reside on the Winnebago Tribe of NE reservation
4. Must be enrolled and attending a secondary school
5. **Must maintain a 2.5 GPA for the 2023-2024 academic year**  
*(GPA waived for Disability/IEP Students)*
6. **Must not exceed over 12 unexcused absences for the 2023-2024 academic year**

If there are applications that meet the same requirements the following priorities will give an applicant precedence:

- A. Attending Winnebago Public School
- B. Students with Special Needs or with an Individualized Education Plan (IEP)
- C. TANF clients will be given priority for TANF summer youth employment funding.

**\*\* Disability and IEP, currently (or last semester attended) enrolled in an approved program with the Winnebago Public School**
