WPS BEGINS 24-25 SCHOOL YEAR

[Winnebago, NE] The new school year has begun for the Winnebago Public Schools. The first official day of school was Thursday, August 15th, 2024, here. "It's always an exciting time for our kids. The staff is really looking forward to another great year." Kamau Turner, Superintendent for the Winnebago Public Schools told the Winnebago Indian News. Turner went on to speak about the new staff members for the school as well as the ever-growing spatial crunch they are facing due to the growth of the student body. He said, "Most people don't realize how large the [student body] is. We have really been digging into the discus-

sion of what kind of space we need to have in order to meet all of our student's needs." With a staff of well over one hundred people, the Winnebago Public Schools system is one of the larger employers in the area. Superintendent Turner spoke about the outreach capabilities of the staff despite having to struggle at times with space limitations. "When the students get to know the new staff members, I think they'll like the additions we're making," he added. Along with the academic goals set for all the students, the school also works to ensure the extracurricular activities receive their due attention from the staff and administration. "Our coaching staff is growing. It's good to see our programs grow even into areas not traditionally thought about. Our exposure to

a wide range of experiences will continue to push forward. We intend to open as many doors as possible for our students while they're here with us. I'm very excited about what we have in store this year." For NSAA [Nebraska School Activities Association] events, Winnebago Public Schools are a Class C-1 size school, which is large for our area. Even with consolidation, other school districts struggle with class sizes – a mark of rural Nebraska life across the state. "Winnebago's growth continues. Soon we will need more space. Everyone involved is looking at where we can expand and what kind of expansion will make the most sense." Turner said with a smile. The challenge is

BIG BLUE GEARS UP

[Winnebago, NE] There are few things in Winnebago that get our people fired up like the onset of the school sports seasons. Earlier this month all Fall Sports teams were allowed to officially begin practice here. The WIN had the unique opportunity to capture some photos of the teams in early action, and we spoke with the coaches about their upcoming seasons. "We have some goals to hit this time around." Girls Golf Coach, Kenny Blackhawk said.

Each of the teams must abide by NSAA (Nebraska School Activities Association) rules. It is the NSAA which governs nearly all aspects of interscholastic competition.

"We are really looking forward to this coming season, and it looks like we're going to have a [large] group of girls coming out too." Darla LaPointe, Head Volleyball Coach said as they were heading into practice. The Winnebago athletes must also complete individual physical health examinations prior to beginning any athletic training. "That part we have a few struggling to complete on time. But they'll all get it done I know." LaPointe continued.

Strength training and conditioning are always a part of the early days of competition practice. Over the summer many student athletes participate in allowable activities to keep their progress moving while fighting off the lack of organizational contact. "It's nice to be able to finally get out there and do the

real thing.", said one of the young players. This year the beginning of the season has also had the benefit of milder weather. The football players worked hard on their first day, grinding into their own level of conditioning, but the sun and heat didn't eliminate their time on the field like it can.

Winnebago Activities Director, Adam Tranmer, has each of the programs set and ready for the new season. Abiding by all rules for play, Winnebago Public Schools takes the health and safety of the student athletes seriously. "We want to make sure the players can play without injury and enjoy their time out there." WPS Superintendent,

Kamau Turner told the WIN earlier this week. "Conditioning is a big part of getting the [athletes] prepared. If you miss a day, you will make it up. We need everyone ready to play and compete.", said Coach Klüber as their volleyball team began its rigorous training.

While volleyball did not seem to have much issue with player numbers, the other sports were not as fortunate when it came to overall participation. Superintendent Turner told the WIN, "They are having a time getting [many] players to come out this season. But that is something each of the schools in the league have said to us." As he spoke about the football program, Turner went on, "We'll have enough, but one of the other schools [in the league] may not even get a team entered. But we'll have to see how that turns out." Similarly, Girls Golf Coach Kenny Blackhawk remarked about the newness of his sport to the girls. "Some of them don't even know we're doing it. I hope we can change that because there are some really great opportunities out there for our girls, especially if they want to play beyond high school."

The beginning of the season's competition is just around the corner. The first match for Volleyball is August 22nd in Wisner. Girls' Golf is the following day at West Point. Football travels north to Cheyenne / Eagle Butte on August 29th, and Cross-Country hits the trails come September 5th down in Wisner.

Winnebago High School is currently offering athletics this Fall for football, volleyball, girls' golf, and boys & girls' cross country. Coaching staff for each is: Football – Dusty Welsh, Treivan Bear, Kobe Benne; Cross Country – Barry Bonneau and Melanie Nelsen; Girls Golf – Kenny Blackhawk; Volleyball – Darla LaPointe, Courtney Davie, Samantha Klüber. Full athletic schedules will be printed once they are released.

"Lord, show us the father"

I have attended several wakes and funerals over the past few weeks. Many take the opportunity to stand up and express themselves. Stories are told from the past. At times, someone gets up and uses his or her voice to express condemnation for various activities that led to the person's passing from this world. Such words are spoken as a warning not to walk in certain ways. Such words of warning need to be spoken. I wonder if this is the proper place and time? I wonder if such words are helpful or hurtful? Do they bring comfort or self-righteousness or do they bring shame and judgment? I wonder if such words are the only words that those gathered there will remember and reflect upon.

I would like to offer you words of truth that offer comfort. These words are often quoted at a Christian wake or funeral. These words come from the Gospel of John. Jesus said "Do not let your hearts be troubled. Trust in God; trust also in me. In my Father's house are many rooms; if it were not so, I would have told you. I am going there to prepare a place for you. And if I go and prepare a place for you, I will come back and take you to be with me that you also may be where I am. You know the way to the place where I am going." [John 14:1-4 NIV84]

Jesus was offering peace to troubled hearts. Jesus was urging his disciples, and us as well, to trust in Creator God. And not only in Creator God but also in him.

Jesus went on to say that he was going to prepare a place for those who believe in

SUICIDE IN INDIAN COUNTRY PART 53

How did suicide come to be made a sin?

The early Christians had a severe problem with suicide, because many people were killing themselves in the belief they would instantly be reunited with Jesus in heaven. These were in addition to all the other suicides that regularly occurred. Suicide was made a sin in the 4th century in an attempt to prevent these deaths. The state also made it a crime to kill oneself.

Centuries that followed saw barbarous punishments inflicted on suicides and their families. To make it worse, suicide was made an unforgivable sin in the 13th century. Degrading corpses of suicides, confiscating their money, turning their families out of their homes, and burying suicides in unconsecrated ground was prevalent. It was not until the 20th century that the last statutes were removed that made suicide a crime.

Why do people have such misguided opinions about suicide?

The taboo on suicide prevented scientific study and education about suicide by decreeing that no one could talk or learn about it, and it remained in this forbidden realm for hundreds of years. Consequently, until this century so little was known that anyone could, and did, express opinions on whether suicide is good or bad, or moral or immoral. One guess was as good as another.

Discoveries in this century of how the brain works and how it gets sick or damaged have advanced scientific knowledge about mental illness and suicide. People are replacing old beliefs and opinions now that there are medical and psychological answers and treatments.

Do people actually advocate suicide?

Yes. Some claim people should have the "right" to kill themselves, and that they should be helped to kill themselves if they are unable to do it unassisted. They publish advice on how to kill oneself, and print the names of drugs required. They insist they are humanitarians fighting for the right to a "peaceful death". Their typical candidate for suicide is a person who is painfully dying from cancer.

They stress only the extremes – the choice is between peaceful death or unbearable pain. They do not consider the fact that the pain of cancer is relieved by painkilling medicine. There is no evidence, however, that large numbers of cancer patients wish to kill themselves, but there is evidence that cancer patients who are suicidal have major depression as well.

Do rational and perfectly normal people kill themselves?

No. The mood in which people kill themselves prevents them from seeing any alternative but death. Many people believe suicide is a voluntary choice from among other options, but this is not true. The people who advocate suicide say we should "assist" people in their suicides by giving them the means and privacy to kill themselves.

They call this "rational suicide". They claim that people can look at the pros and cons of their lives, and "rationally choose" death. Proponents also say doctors should be able to give lethal injections to people who request death. These beliefs lead to ideas about the expendability of some lives which cheapens the value of all life in society. Rational and perfectly normal people, even in very painful situations, can see alternatives to death.

Troy Smith, our defensive end, made a game saving tackle, so we could win the game 38 to 36.

We went on to play another game and lost, I have no more to say about that.

*Ladies & Gentlemen – LUKE BRYAN
Concert Review: Luke Bryan*

As far as country music goes, I find myself on the shallow end of the pool when it comes to expertise, especially in the modern era of the genre. I know some classic country we all grew up with, but I would by no measure call myself a hard-core fan, to the contrary – I like to dabble. However, there is one particular artist who I've seen more than once LIVE IN CONCERT – and that is Mr. Luke Bryan. In this week's Hakewe we'll give our review of his latest show when he appeared LIVE in Omaha, NE.

Many years ago, when he first came on the country music scene, Luke Bryan was a struggling singer looking for his big break. Like so many others, he had a talent for singing, performing, and even some dancing, but he lacked the breakthrough hit that would push him over the top. Then along came a song called, "All My Friends Say". When that song hit the airwaves, country music had a new star on its hands, and it was only upward from there. In his early days, he even performed LIVE at WinnaVegas, opening for another headliner.

Luke Bryan concerts are a genuinely mixed bag in a variety of good ways. There is always the show opener, the big push to get the crowd involved, and even some sing-a-longs when the stage is filled with the other artists he tours with, or bandmates who know how to turn up the thrill factor. So, when we went to see his show recently at the CHI Arena in downtown Omaha, we knew what to expect.

Arriving at the venue, Omaha knows how to move their CHI crowds well. Parking areas are relatively easy to access and there's usually plenty of space even when the house is 'sold out.' Luke hadn't been in Omaha for a few years, so the anticipation of his arrival pushed the limits of the arena. Inside the crowds move quickly and access to our floor seats was simple. Getting there early so we could see the openers Luke brought with him, our wait time was short. Happily, a DJ rocked the crowd keeping the vibe pumped up to the first act and in between the shows.

Kicking off the night was a new face to the country charts, Dillon Carmichael. Not knowing a lot about modern country music, you can really tell the influence on the men's vocal scene from powerhouses like Teddy Swims, and Chris Stapleton. Carmichael sang his most popular songs, one even reaching number 5 on the hot singles chart. His vocal stylings were very much in the Stapleton vibe. He and his bandmates got the crowd up and going. He sang about 4 songs. Again, he was an artist still looking for that breakthrough hit.

Following the DJ driven intermission, next on stage was a young lady named Lily Rose. Now don't shoot me, but I've never heard of her. A solo artist, she arrived on stage dressed like part of the crew. But that's where her commonality ended. In short order we all found out – Lily could sing! Her tone and fullness were nice to listen to. Not knowing a thing about her I caught myself moving to her songs and feeling the good vibrations

she was sending out through the songs she chose. Her story included some background working with Luke and she again kept the growing crowd moving. Check her out if you don't know her, she did well. The DJ spun the intermission once more and the CHI Center became a Taylor Swift concert!

The final opener was Alana Springsteen. Another I had never heard of, but the crowd seemed to know a few more of her songs. Yet, despite the familiarity of the people now almost filling the CHI, her songs really left me flat. The crowd was on their feet, but the music just didn't hit for me. Sorry Alana.

The pre-set with the DJ was very much more into the country club music vibe. Remakes and DJ remixes kept the people hopping, so when Luke's show was set to begin, the roar of the crowd set the noise level to its new high. Full on light show, complete with pyrotechnics and some truly incredible audio balancing, Luke Bryan came on stage just how we expected - bigger than life.

His show was called, Mind of a Country Boy, and it began using the clubby dance banger "Country Girl Shake It For Me", but just the beats and hints from a remix. The images on his incredible and detailed light wall played to the crowd well. Needless to say, the whole place was rocking right out of the gate. Blasting onto the stage he made everyone know he was there to sing, dance, and party.

A Luke Bryan concert is always a good one for many reasons.
