GENERAL WELFARE EXCLUSION APPROVED

[Winnebago, NE] On the last day of that political year, October 7th, 2024, in a split decision, the Winnebago Tribal Council approved the payment of a General Welfare Exclusion Payment for our Winnebago tribal membership. The payment of Five-Hundred dollars (\$500) was approved for all enrolled tribal member adults with the distribution information still pending at that time. Minors were approved for One-Hundred Fifty

dollars (\$150) to be added to their trust accounts. "We must work to ensure that all our people are included in the bounty of our tribal operations. This is one way we can do that." Tribal Council Chairwoman Victoria Kitcheyan said following the passage of the measure.

Details on distribution are included below as some administrative pathways must be followed following the approval. The word needed to be shared not only about the approval, but the distributions' information is important and must reach the membership quickly. WTN CFO, Jasmine Lammers,

advised the Council that the parameters of the payment will have some important stipulations, and the membership must be armed with that information to avoid confusion. In summary, that is:

Must be enrolled by October 9th, 2024. Adult members must apply by November 15th, 2024 - NO EXCEPTIONS!

Minors do not need to apply. Their funds will be automatically deposited into their

WATER BLESSING WALK

[Hensley Spring / Big Bear Park] September 26, 2024 - On a beautiful morning down toward the Missouri River bottom area, the Ho Chunk Language Academy - Dual Language class held a special activity offering a blessing of our waters here. "We have been studying water this month. In making

the connection between science, environmental science, social studies, health, and culture, we are going to host a water walk from Hensley Springs to the Missouri River. The littles will be carrying water. They will pray for clean water for their futures and for those yet to come. Relatives are welcome to come walk and pray with us." Michelle Free-LaMere, instructor for the class, posted via their social media.

The activity was the first of its kind for the

class, as well as for those in attendance. One attendee told the WIN, "I really didn't know what to expect, but I'm so glad we came down. The weather was beautiful, and the [Hensley] spring area was quite moving. We all felt so connected to our water and it was good." Planning for the event included transportation for participants to and from the areas, including Hensley Spring, which is set deep into the river bluffs area. Tribal Council Vice-Chairman, Isaac Smith, was on hand for the event, telling the WIN how much effort has been paid to the road along the bluffs that leads to the spring area as well as the effort to keep Big Bear Park in good

As part of the event, the Tribal Council met with the US Army Corps of Engineers and invited them to the walk. The Army Corps sent a contingent to Winnebago and they indeed took part in the day's activities. Tribal Council Chairwoman, Victoria Kitcheyan greeted the visitors while the students were being transported to the spring area. "We're very happy to have our guests join us. Our land and water mean everything to us.," she told the visiting group while she and Vice-Chairman Smith regaled them with stories of tribal history and lore.

At Hensley Spring the blessing began with a prayer. Water Spirit clansman, Anthony 'Hayna-ga' Earth offered his words as

individual trust account(s).

Adults filing electronically may be eligible for ACH disbursement paid on November 26th, 2024. Details forthcoming.

For those without banking information or a bank account, paper checks will be distributed on December 4th & 5th, 2024 in Winnebago, NE @ the WTWC Gymnasium. Timelines to be provided later for Seniors/Elders and check cashing services, if possible.

ALL CHECKS MUST BE CASHED BY 12/31/24 CLOSE OF BUSINESS DAY. ABSOLUTELY NO CHECKS WILL BE REISSUED AFTER THAT DATE.

The source of the funds for this General Welfare Exclusion payment dictates that all funds claimed must be run through the payment bank account held by the Tribe prior to the close of calendar year 2024. Any checks not cashed will become void and no other check will be issued. So, make sure you get your money moved out of the Tribe's bank before 12/31/2024 or you will lose out. Do not sit on your check. Do not hold onto it. Cash it immediately. You may spend your disbursement as you wish, when you wish, but the funds must leave the Tribe's bank account before the 2024 deadline.

TRIBAL COUNCIL ELECTION RESULTS

[Winnebago, NE] The results of the Winnebago Tribal Council election were posted following the close of the polls at 8:00pm on Tuesday, October 8th, 2024, here. Those who won the three-year term were, in order, Isaac Smith, Rona Stealer, and Teresa Littlegeorge. An inauguration event was held at the Whirling Thunder Wellness Gymnasium the following morning at 10:00am. Chief Judge Zendejas for the Winnebago Tribal Court presided over the start of the event swearing in each of the newly elected council members. The Chief Judge then called for nominations for Chairperson. Victoria Kitcheyan was nominated and name Chairwoman for the Tribal Council by acclamation.

Kitcheyan then presided over the remainder of the meeting, calling for the nominations and votes for the remaining officers of the Council. Vice-Chairman was decided to remain Isaac Smith. Treasurer was decided to be Rona Stealer, and the Secretary was decided to be Teresa Littlegeorge. Chief Judge Zendejas also performed the oaths of office for the officers. Each of the officers is appointed to their posts, as such, for one year.

The entire inaugural event was LIVE streamed by the Winnebago Tribe's Communications Department. The LIVE broadcast was sent via Facebook LIVE and on the tribe's YouTube channel. Those events can be seen there in their entirety for those who may have missed the LIVE session.

Smith, Stealer, and Littlegeorge will serve a three-year term ending in 2027. Next year, Council members Kenneth Mallory, Aric Armell, and Coly Brown are up for re-election.

the wooded area lent itself to listening to the prayerful speech of both him and the Vice-Chairman. Following the invocation, the students and those in attendance were invited to participate in a smudging and cleansing from the spring waters. The students filled small buckets which they carried with them along the walking route back to the banks of the Missouri River. "When our people pray like this, the trees get quiet and become still and its very moving." said one of the group members after the people began to move through and the walkers began their trek.

The walk from Hensley Spring to the Missouri River is not a short one. The dirt road along the bluffs is the only passable route that leads to the paved road at the West end of the 'straight-away' area. The tribal firing range is just across that road as well. The overall distance is over four miles. WTN Physical Resources Director, Ireta Frazier, told the WIN, "We drove the route [prior to] and measured how far it is. It's a lot farther than most people think."

Several dozen tribal members attended the event joining the students and dignitaries in their walk. One walk participant spoke with the WIN during the trek saying, "I'm happy to get my steps in!" with a chuckle.

At the banks of the Missouri River the students each offered their spring water bearings to the channel of the river waters. More prayers were offered, and tobacco was laid down with those prayers as well. Following the completion of the walk and water blessings, a small gathering was held back at Big Bear Park. Several members of the tribe spoke and songs from the drum were sang. A to-go-style lunch was also provided for the students and those in attendance.

The Winnebago social media sites covered the event from many divergent vantage points. For instance, the Communications department provided drone footage while the WIN engaged Facebook LIVE coverage throughout the day. As of press time there has been commentary about repeating the event annually. However, no definite plans have been put forward yet. The WIN will continue to cover this event and any details that come forward.





"WARNING labels - Part 2"

In the last issue I began by asking the question: 'Do WARNING labels work? Do you pay any attention to them?'

I went on to write: 'I also got to thinking whether spiritual WARNING labels would

God's Sacred Word is filled with words of WARNING - His words. Do you know any words of WARNING that Creator God's Spirit inspired men to record?

One can not claim ignorance by not knowing God's Word. We find the reason for this in the opening chapter of the book of Romans: 'The wrath of God is being revealed from heaven against all the godlessness and wickedness of men who suppress the truth by their wickedness, since what may be known about God is plain to them, because God has made it plain to them. For since the creation of the world God's invisible qualities—his eternal power and divine nature have been clearly seen, being understood from what has been made, so that men are without excuse' [Romans 1:18-20 (NIV84)].

Note well what godlessness and wickedness of men suppresses. They suppress 'the truth.' Paul goes on to speak the truth to 'all in Roman who are loved by God and called to be saints.' [Romans 1:7a] Paul continues: 'Grace and peace to you from God our Father and from the Lord Jesus Christ' [Romans 1:7b].

One word of WARNING found in God's Sacred Word comes in the closing verses of the Revelation of Jesus Christ. Jesus reveals to John and to us 'I warn everyone who hears the words of the prophecy of this book: If anyone adds anything to them, God will add to him the plagues described in this book. And if anyone takes words away from this book of prophecy, God will take away from him his share in the tree of life and in the holy city, which are described in this book' [Revelation 22:18-19 (NIV84)].

There are many who have gone against Jesus' words of WARNING. They have either added to his words or they have taken away from his words. In other words, they have withhold or distorted the truth.

Many today do not know what is truth or where to look for truth. Truth be told this is an age old dilemma. Pontius Pilate asked this question when questioning Jesus. "You are a king, then!" said Pilate. Jesus answered. "You are right in saying I am a king. In fact, for this reason I was born, and for this I came into the world, to testify to the truth. Everyone on the side of truth listens to me." "What is truth?" Pilate asked. [John 18:37–38 (NIV84)]

Many today, like Pilate, do not know what is truth even when it is staring them right in their face. Earlier John records these words: Jesus answered, "I am the way, the truth and the life. No one comes to the Father except through me" [John 14:6 (NIV84)].

Spiritual WARNINGS do work for some, but for most they are like the WARNING labels that are found on countless items. The foolish do not heed them and suffer the consequences.





FREE household hazardous waste collections in October for residents of Washington, Burt, Thurston, Dakota, Dodge, and **Cuming counties**

The Nebraska Loess Hills Resource Conservation & Development (RC&D) Council is coordinating (3) FREE household hazardous waste collections in October for residents of Washington, Burt, Thurston, Dakota, Dodge, and Cuming counties. Hazardous chemical products can be found in almost every home in Nebraska. A product is considered hazardous if it can catch fire, react, or explode when mixed with other substances, or if it is corrosive or toxic. Special handling of hazardous chemical products is required to ensure safe disposal and to protect the environment from possible contamination. Area residents can dispose of paint, stain, varnish, lawn and garden chemicals, cleaning chemicals, insecticides, batteries, fluorescent light bulbs, car batteries, used oil, antifreeze, and most other household chemical materials at this collection. Only HOUSEHOLD QUANTITIES of material can be processed so a LIMITED number of 2.5-gallon jugs will be accepted by the HHW contractor who has final discretion on items and amounts that will be received.

This collection will NOT accept tires, electronic equipment, appliances, PCBs, Picric Acid, Science Lab Materials, radioactive materials, or biological hazards.

Materials received at these collections will be recycled if possible, or disposed of in a safe and environmentally sensitive manner. These collections are made possible through a grant from the Nebraska Department of Environment and Energy, Cargill, Papio-Missouri River NRD, Washington County Recycling, Lower Elkhorn NRD, and Lower Platte North NRD. Every so often one of the titans of music goes out on tour and they come close enough to home to be seen. Last weekend that artist was the one and only Kenneth "Babyface" Edmonds. His LIVE concert was performed at Mystic Lake Casino inside their state-of-the-art Mystic Showroom, and he most certainly did not disappoint. In the world of R&B music, there are few others who can reach for the stature and presence of Babyface. The musical catalogue he commands is absolutely immense, especially when it comes to songs that have reached the top of the charts. A feat not surpassed by even the most famous of icons. Babyface has made such an incredible impact on the world of music. When he plays music from his treasure trove its awe inspiring for so many reasons.

The venue where Babyface appeared is inside the huge Mystic Lake Casino in Prior Lake, Minnesota. That is located just to the south of Shakopee, Minnesota – a suburb of the Minneapolis metropolitan area. The casino's main event hall, which is named after the casino is called The Mystic Showroom. Kudos to the Shakopee Mdewakanton Sioux Community for creating an incredible space. It is truly a marvel to experience.

The artist, however, was the reason we were all there. Babyface! The one and only Babyface was putting on a show in the way that only he could. LIVE and in person for one night only. Replete with singers who accompanied his iconic voice and a small group of bandmates, the legendary singer, songwriter, producer, and performer led the audience through a musical journey which showcased not only his solo hits, but also chart-topping songs he wrote and produced with other artists. Writing for icons like Boyz II Men, he returned to those hits all throughout his show. "Water Runs Dry" was a harmonic blessing, and he just kept going.

From his early days with The Deele. "Two Occasions" came to the forefront, and it made the night right away for the capacity audience. Everyone was on their feet, dancing and singing along with the balladeer. But that was still only the beginning. Engaging with the fans all throughout his show, 'Face, as his friends call him, told stories of his musical experiences. He told of his humble beginnings, showing old photographs along with this tales. Even sharing with the people his very first composition – a love song for a crush long, long ago. Funny story too, because he made fun of his lyrical choices as the excited crowd laughed and settled in for a great night of music.

A true icon of music across all genres, Babyface engaged in a set list that displayed his journey that was met by so many other incredible singers and artists. As he sang through his compositions, the story was told about how the song became the focus. Even when legendary players, like Eric Clapton, took his song to "Record of the Year" at the Grammy Awards. Hit after hit after hit, it is no wonder that the industry sees Babyface as one of the most prolific

musicians of all time.

In the grandest style of what would be expected, Babyface had narrated background music that separated the performance into sections. Following one break, the Grammy winner came back to announce what was coming next. He told everyone to get on their feet, because the medley of hits was about to hit the stage. And let me tell you, boy, did he ever bring it. Brought the house down! His collaborations with everyone from TLC to Madonna, After 7 to Dru Hill, Tevin Campbell to Boyz II Men, Bobby Brown, Johnny Gill, Toni Braxton, Brandy, Mary J. Blige, Midnight Star, and more. Each song a chart topper. Each song a favorite memory. None without screams and cheers from the capacity crowd – all who were singing along and loving every note.

Near the end of this melodic section, you could tell it was coming. You could feel the vibration changing in the room. Babyface was leading you toward one artist. One icon that he worked with who he said moved him and inspired him like no other. She being the one and only: Whitney Houston aka "The Voice." His songs with Whitney capturing her iconic voice that were featured on the mega-soundtrack from the movie "Waiting to Exhale" took the stage. The title track "Exhale (Shoop Shoop)" brought the house down. Tears flowed from the audience members who remembered how immense the song was as well as how talented and beloved Whitney Houston was and always will be.

Throughout his show, Babyface played his solo hits, but he paid a lot of attention to the songs he created for others. None of those songs were unknown or obscure. For instance, his number one hit, "Superwoman" sang by R&B diva Karyn White was a real crowd favorite, as were his songs from Boyz II Men and Toni Braxton. The library of songs is just so over-filled with hits, the reputation Babyface has is beyond well-deserved, it is a revelation of musical talent and iconic lyrical genius.

Babyface surrounded himself with other singers on stage who helped carry the group melodies, like those from Boyz II Men. Those stage singers were incredible in their own right as they helped create the harmonic vibe of those iconic groups for all of us to listen to. But as the show drew to its close, the vocal presence came down to the head-liner – Babyface.

Giving time for the crowd to cheer and chant for an encore, soon the stage lights dimly rose to give the people what they were looking for. The icon returned to the stage where a single wooden stool and a microphone stand were. Under the roar of the packed Mystic Showroom, Kenneth "Babyface" Edmonds took center stage. A lone stagehand brought in his acoustic guitar and the legend soon began to strum. Those notes lilted and flowed while the venue applauded the man, we all came to see. Shortly into his solo performance the notes of his mega-ballad, "When Can I See You?" came from his guitar. The crowd erupted, waiting with anticipation to sing with him one more time. As the song played and the first chorus arrived 'Face sang the first line, "... when can I see you?" ... the crowd was mesmerized. Just then a lady shouted her answer to his question - "Tonite!" The crowd laughed and the icon shook his head in jest hearing her unexpected reply as he continued singing.

Overall, the Mystic Lake performance from Babyface was a memorable one. Memorable for many reasons. His voice. His songs. His collaborations. And his iconic career. On our world-famous HaazZaat! scale we're not leaving you with one because the icon cannot be touched. Sufficed to say it was one for the ages and if you get the chance to see him – do it. I'm so beyond satisfied and infinitely happy the opportunity came. After all there is only one, Babyface.


