

# **GET OUT THE NATIVE VOTE**

[Winnebago, NE] The national elections are just around the corner and the time is upon us all to go to the polls so we can exercise our rights to vote. Election Day is Tuesday, November 5th, 2024. This is the day when the American people will select a new President of the United States. But there are also several other electoral decisions to be made. "Honor our veterans and those who fought for our right to vote by getting to the polls on Election Day." Lorelei Decora, Tribal Council member, said in a recent meeting.

Presidential elections are considered to be the lead event for all elections, and this time around the stakes could not be higher. Earlier this year, President Joe Biden patriotically chose not to seek re-election this Fall. Although he could have served another term constitutionally. Instead, Biden abdicated his post in a rare display of humility in modern day politics. One voter told the WIN, "[] his decision was a shocking moment for us all. But I understand his choice and respect [the President] even more because of it." The move setting up Vice-President, Kamala Harris, to gain the nomination of the Democratic Party at their National Convention held in Chicago, Illinois late this past Summer.

Locally, tribal leadership has been pushing for voter turnout here in Winnebago. Tribal Council members met several times to discuss how best to create outreach for our membership and how to get them to go vote come November 5th. Garan Coons, Communication Officer for the Tribe said, "This matter is extremely important. Not only to the organization, but also to the people of Winnebago. We'll do what we can to help educate the membership when they go vote that day."

## **GENERAL WELFARE EXCLUSION APPROVED**

CONTINUING COVERAGE

[Winnebago, NE] As reported in our 10/12/2024 issue, the Winnebago Tribal Council approved the payment of a General Welfare Exclusion Payment for our Winnebago tribal membership. The payment of Five-Hundred dollars (\$500) was approved for all enrolled tribal member adults with the distribution information still pending at that time. Minors were approved for One-Hundred Fifty dollars (\$150) to be added to their trust accounts. "We must work to ensure that all our people are included in the bounty of our tribal operations. This is one way we can do that." Tribal Council Chairwoman Victoria Kitcheyan said following the passage of the measure.

Details on distribution are included below as some administrative pathways must be recognized following the approval. The word needs to be shared not only about the approval, but the distributions' information is important and must reach the membership quickly, as deadlines are soon approaching. WTN CFO, Jasmine Lammers, advised the Council that the parameters of the payment will have some important stipulations, and the membership must be armed with that

information to avoid confusion. In summary, that information remains:

Must have been enrolled by October

Adult members must apply by November 15th, 2024 - NO EXCEPTIONS!


Minors do not need to apply. Their funds will be automatically deposited into their individual trust account(s).

Adults filing electronically with banking information may be eligible for ACH disbursement paid on November 26th, 2024.

Here in Nebraska, we will also be voting for both U.S. Senate seats. Incumbent Senators Deb Fischer and Pete Ricketts are both on the ballot. Fischer is in the normal term of the seat, but Ricketts was filling the seat vacated by the untimely resignation of Ben Sasse. Fischer faces a challenge from Independent candidate, Dan Osborne. Democratic nominee, Preston Love, Jr., of Omaha faces Ricketts. Both Senate seats are hotly contested and will be filled by the voters, along with the normal re-election efforts of all three U.S. House of Representatives posts. Local House 3rd District incumbent, Adrian Smith, is also seeking re-election.

There are also a number of ballot initiatives to be decided upon as well as local elections that have choices to be made. Women's Healthcare rights are on the ballot twice, as are workers rights, and even whether public tax dollars should be used for private schools. Nebraska Democratic Party Chair, Jane Kleeb, visited the constituency of Winnebago recently telling the WIN the perspective of her party. Kleeb was elected Chair of the State Party in 2016. Speaking alongside long-time Democratic Party official, Cynthia LaMere, the duo led discussions on voter registration dates and notices, as well as their party's position on the matters identified on this year's ballot. "Lift your tribal voices so that we can be

heard." LaMere told the WIN during a recent interview.

LaMere was also a delegate to the National Convention held in Chicago. She had the unique distinction of not only introducing the State of Nebraska, but also chose to eloquently identify the Native tribes of our State in her speech. Chairwoman Kitcheyan stated following the world-wide broadcast, "It was an incredible moment for our tribe and all Indian people. Our voices matter and are being heard."

Voter registration in Nebraska is still open as of press time, and early voting has also begun. Voter resources can be found online at www.sos.nebraska.gov or you may call the Thurston County Clerk in Pender, NE for more information. Internet search engines will also help provide guidance to the resources you're seeking.

It is extremely important for all our people to be registered to vote, so please make sure you are registered to vote. Also, Nebraska law now requires a photo ID to vote in person. State issued IDs, Driver's Licenses, and Tribal IDs are valid at all polling places. We repeat, TRIBAL IDs (with photo) ARE VALID forms of identification. So, get out and vote on November 5th, Winnebago. Our native vote matters and our voices must be heard. GET REGISTERED! GO VOTE!

For those without banking information or a bank account, paper checks will be distributed on December 4th & 5th, 2024 in Winnebago, NE at the WTWC Gymnasium. Timelines for those days' distributions will be provided later. Times for Seniors/Elders and check cashing services, if possible, are also pending as of print time.

ALL CHECKS MUST BE CASHED BY 12/31/24 CLOSE OF BUSINESS DAY. ABSOLUTELY NO CHECKS WILL BE REISSUED AFTER THAT DATE.

For clarity: you may spend your funds when and how you wish. However, the source of the funds for this General Welfare Exclusion payment dictates that all funds claimed by you and paid to you must have cleared through the payment bank account held by the Tribe prior to the close of calendar year 2024. Any checks not 'cashed' will become void and no other check will be issued.

So, make sure you get your money moved out of the Tribe's bank BEFORE 12/31/2024

close of business, or you will lose out. Do not sit on your check. Do not hold onto it. Cash it immediately. Again, you may spend your disbursement as you wish, when you wish, but the funds distributed to you must leave the Tribe's bank account before the 2024 deadline.



Elected to the AIHEC executive committee are: Elmer Guy, President of the Navajo Technical University as committee chairman, Leander McDonald, President of the United Tribes Technical College as vice-chairman, Dawn Frank, President of Oglala Lakota College as a secretary, Manoj Patil, President of Little Priest Tribal College as treasurer, and Eva Flying, President of Chief Dull Knife College as member-at-large.

"While all the Tribal College and University (TCU) presidents are members of our board, the commitment of those serving on our executive committee will be more demanding as we will rely on their ambitious and visionary outlook for all out TCUs," said Ahniwake Rose, AIHEC President & CEO, "Those represented in this new executive committee is a great mix of seasoned and new leadership that will not only help us in maintaining our history and culture but also utilize new ways to do so. I am excited to collaborate with this new executive committee as we continue our Advocacy efforts for our TCUs."

AIHEC's fall board meeting will continue until noon tomorrow. The board will meet again in February 2025 during the Annual AIHEC Legislative Summit in Washington, D.C.

#### "Remember the Sabbath Day"

We turn to chapter two, verse one and following as we give quality time to God and His Sacred Word:



Elizabeth Betz was born the oldest of four girls on November 12, 1934, at home on the farm near Lauingen, Germany, to Josef and Rosina Metzger Betz. While yet a teenager, her vocation became clear to her while on a retreat in St. Ottilien. She later attended the Mission School in Tutzing and entered the Missionary Benedictine Sisters on September 15, 1953.

While still a postulant, she was transferred to the Norfolk, Nebraska community where she continued her religious formation and her studies in education. Sr. Frances made first profession on January 13, 1956, and final profession in 1959.

Sr. Frances found great satisfaction and joy in her teaching career, be that at St. Leonard's in Madison, Nebraska, Assumption Academy and Norfolk Catholic High School, and St. Augustine Mission School in Winnebago. She embraced her teaching ministry with full energy and commitment, desiring to help

In May 1983 she was called to serve in parish ministry in Jackson, Kentucky. This, however, was a prelude to her next teaching assignment. In 1989 she traveled to South Africa where she taught Zulu girls in a secondary school. This was especially challenging and dangerous during the time of Apartheid.

In 2000 Sr. Frances returned to the Norfolk Priory and was again assigned to St. Augustine School in Winnebago, where she loved the children and the children loved her. In 2017 she retired and returned to the priory house in Norfolk. During her senior years she visited the elderly, tended her garden and helped in the community.

Sr. Frances found great fulfillment in her life dedicated to Christ in her community and ministry. It was in prayer that Sr. Frances integrated every challenge and every joy. One sister said, "No matter what the day brought her, Sr. Frances lived it as fully as possible in generous and loving service to Christ."

Sr. Frances surrendered all to Christ on October 22, 2024.



Empowering Our Community: The Path to Tribal Sovereignty through Right of Way Consent for Fiber Optic Expansion

In an era where connectivity is essential, Jājąp proudly stands as the telecommunications department of our Tribe, dedicated to fostering a robust and reliable Internet Service Provider (ISP) for our community. With a clear mission to enhance digital access and empower our members, Jājąp has embarked on an ambitious journey to bridge the digital divide that affects many Native communities. Thanks to generous funding, we have successfully launched this initiative, marking a significant step forward in our commitment to improving the quality of life for all.

A major milestone in our journey has been our funding agency's completion and approval of the environmental review. This achievement not only reflects our dedication to responsible development but also sets the stage for the next crucial benchmark: securing the right-of-way consent from landowners along the proposed route. This step is not merely a legal formality; it is a pivotal moment in our collective effort to enhance our sovereignty, create job opportunities, and build a brighter future for everyone on the reservation.

As we move forward, we urge community members to engage in this process, recognizing that their consent is vital to our success. Together, we can pave the way for a connected future that honors our heritage while embracing the opportunities that technology brings.

The path to the right-of-way consent!

We understand that securing right-ofway consent requires clear communication and mutual understanding. That's why we are reaching out directly to our tribal members to explain the benefits of this project and address any concerns. We will be mass-mailing all owners of the land the fiber will be running through. With the mail would be a letter of consent for you to sign and mail back and a legal description of you and where the fiber would be laid in the ground.

The fiber optic network we are building will be the backbone of Jājap Telecommunications. It will connect homes, schools, healthcare facilities, and businesses, ensuring that our community is no longer left behind in the digital divide. But beyond the technical aspects, this

project is about more than just faster internet speeds—it's about empowerment.

Our team is here to answer your questions and provide all the information you need to make an informed decision. This is not just a government initiative; it's a community-driven effort that requires the participation and support of every tribal member.

A Steppingstone to Economic Independence

Establishing Jājąp Telecommunications is a monumental step toward economic independence. The fiber optic project and the establishment of Jājap Telecommunications represent a turning point in our history. By coming together and granting right-of-way consent, we are taking control of our future. A variety of acceptable and readily attainable IDs\* may be used for voting purposes, including:


- Nebraska driver's license/state ID

- Nebraska college or university ID





#### **Concert Review:**

# Dad takes son and daughter to \$uicideboy\$ concert in Lincoln at the Pinnacle Bank Arena

Warning, what I am about to tell will get you mad, disappointed, and angry. I would advise that you don't read the following review as it could change the way you think about concerts. Last chance to stop reading, you might even get so worked up that you might write a letter to the editor.

Well, if you made it past that statement buckle up as I will review my experience of \$uicideboy\$ concert. I will try to answer a few of the following questions you might already have, like who the heck are \$uicideboy\$? Why even write about them? I hope to answer these at the end of the article.

It was held on Friday evening, a twohour road trip to Lincoln, NE at the Pinnacle Bank Arena. I love going to the Pinnacle Bank Arena aka PBA, reminds me of Winnebago playing state basketball and I took my oldest son to his very first concert at the PBA when he was 12 years old. He is now 17 and a senior in high school. He mentioned this concert back in July. I didn't think much of it except I never heard of the group. I asked him was it a band or just rappers? He played me a sample of a song that he liked, and I didn't understand one word but thought they sounded like white guys trying to mimic Bone Thugs and Harmony. I have been a fan of Bone Thugs since back in my high school days, they had a unique delivery and fast rhymes but as I age, I noticed my taste in music delivery has changed. For example, when I was in high school I was listening to songs with titles like "Murder was the case", "Natural Born Killaz", "Mo Murder" and "Hail Mary". Now that I am 43 and a father, I cringe at the thought of being really into those songs. Crazy huh? I tried to warn you to stop reading.

So, a day before the concert when my son asked me to go to the concert I was like "eh". I didn't like their name, I worked the whole day and I didn't know any of their songs. In fact, I hate suicide, so I didn't want to give money or my time to a group who flaunted suicide in everyone's face. I eventually decided to go and the reason I went will be revealed at the end of this article. I asked my other kids to go, my 17-year-old daughter said, "heck ya!" and we jumped in the van with no tickets in hand. After stopping at Raising Canes for dinner we made it to PBA a little after 8:30 PM. I personally didn't want to sit through the opening acts. We walked up to the box office and got some decent tickets purchased. We caught the end of the co-headliner Denzel Curry who was pretty good. He got the place jumping. After his final song they took a 10-minute intermission so they could prep the stage and crew for the headliners.

Finally, a little after 9 PM, Suicideboys started their show to a packed arena of over 13,000 attendees. The place erupted! They rapped over a backdrop of a huge LED screen, thousands of moving lights, and huge blasts of pyrotechnics. It was pretty impressive. They played most of their catalog of music and performance time on stage was 90 minutes.

My honest review, they were not the most talented rappers I ever heard, and the music production wasn't of the highest quality. Their DJ was a guy that had the moniker "DJ CrystalMeth", weird huh? Here

are some other observations, remember the mosh pit? They now call it a hurricane, where all the people run in a circle in the middle of the floor. If you get in the way you get blown over. One of the main observations I made was I wondered when the S word would be promoted. When would I hear the depression and go kill yourself songs. It never happened, I am here to tell you that I judged a book by the title, and I was totally wrong. In fact, by the end of the concert I was filled with hope and a sense of family. Right before the very last song, which in my concert experience is the most famous song they play, they stopped the music and they both come out and just talk. They open up their hearts and told the crowd "I hear a lot of people that come up to us and say that our music saved their life, well we are here to tell that you actually saved us". What is impressive is that they filled up the arena by just being themselves. They didn't have hits on the charts, they didn't hit it mainstream, they are known as a group that goes against the grain.

This made me think of human nature. We seem to gravitate towards conflict, drama, and being rebellious. Think of Elvis Presley, he was banned from TV for wiggling his hips. This got people talking about him. Think of when the rapper's had beef like 2pac vs. Biggie, JaRule vs. 50 cent, and Drake vs. Kendrick Lamar. Have you ever been on social media to follow some drama? We are all guilty of it. Think of the Superbowl, there is a team against another team. There is conflict. This started to make me think of my kids, if I banned them from listening to a group named \$uicideboy\$ more than likely they going to listen to them anyways or it would push them to. I remember my parents finding a Metallica CD and said don't listen to that as it is devil worshipping music. Don't tell anyone but I still listened to them.

Ultimately, I think we should listen to our kids. They might turn us onto something that looks bad but is actually good. Are \$uicideboy\$ a group I would recommend to other parents to have their kids listen to? Probably not. However, their message to the fans is impactful. During their talk they mentioned that they had it all including money, fans, and could party every night. They said even then they were missing something and that was family. They hit rock bottom, got help and they vowed to help anyone that was thinking about Suicide. At the beginning of this article, I said to stop reading that you would get mad. I was trying to create drama and conflict so that your rebellious side would finish the article. Maybe it worked or maybe it didn't.

Overall, this concert made me think a lot. How I shouldn't judge a group by their name, how drama, conflict and going against the grain impacts my life, and how I can be a better person by offering to help just by listening. We never know what people are going through and the words we say could save a life. One of the most memorable parts of the concert wasn't sung or delivered by rapping. They simply said, "Suicide is a permanent solution to a temporary problem, and temporary problems never last forever". Through love and getting help we can prevent suicide.

#### We Are Partnering With Tribal Nations and Native Communities

Donald Trump challenged Tribal land rights and desecrated sacred lands

Vice President Kamala Harris and Governor Tim Walz will safeguard and strengthen the bonds between our nations, uphold our trust and treaty obligations, honor Tribal sovereignty, and ensure Tribal self-determination. They have made it a priority to improve health, education, and safety across Indian Country through enhancing the nation-nation relationship and partnering with Tribal Nations. Throughout her career, Vice President Harris has prioritized the well-being of Native women, children, and families, and throughout his career, Governor Walz has affirmed the right to self-governance and self-determination of the Minnesota Tribal Nations.

#### Vice President Harris and Governor Walz Have Taken Unprecedented Steps to Advance Tribal Sovereignty and Self-determination.

Vice President Harris and President Biden reinstated the White House Council on Native American Affairs, reinstituted the Tribal Nations Summit, and appointed a historic number of Native Americans—including Interior Secretary Deb Haaland, U.S. Treasurer Marilynn Malerba, and over 80 appointees serving across the Biden-Harris Administration.

Vice President Harris and President Biden ushered in the next era of Tribal self-determination by signing an executive order affirming that Tribal governments must be treated as permanent, equal, and vital parts of America's overlapping system of government. This enables Tribal Nations to have greater autonomy over how they invest federal funding.

In Minnesota, Governor Walz signed legislation that codified government-to-government relations, and is the first governor in state history to visit all eleven Tribal Nations in Minnesota. He serves alongside Lieutenant Governor Peggy Flanagan, currently the country's highest-ranking Native woman elected to executive office.

#### Vice President Harris is Working to Protect Tribal Lands and Water.

Vice President Harris and President Biden have created, restored, or expanded 10 National Monuments and signed more than 190 co-stewardship agreements. As a Senator, Kamala Harris championed the San Gabriel National Monument expansion, and this year celebrated the protection of an additional 106,000 acres.

Vice President Harris helped to advance settlements of Indian water rights claims and made placing land into trust easier, helping to right the wrongs of past federal policies.

The Biden-Harris Administration restored protections to Arctic waters and the Bering Sea, the Tongass National Forest, and the Arctic National Wildlife Refuge in support of conserving 30 percent of America's lands and waters by 2030.

# Trump Actively Undermined Tribal Sovereignty Across the Country.

**Trump never convened a White House Tribal Nations Conference**, nor did he reestablish the Obama-Biden Administration's White House Council on Native American Affairs.

Trump ignored Tribal recommendations and took the unprecedented step of removing 85% of land from the first Tribally sponsored national monument protecting Bears Ears.

Trump reduced the amount of land placed into trust by the Interior Department from 560,000 acres to 75,000 acres.

**Trump made it harder for Tribes to regain ancestral lands** and even sought to disestablish the Mashpee Wampanoag Tribe's reservation.

# Vice President Harris Has Helped Deliver Historic Tribal Investments.

Vice President Harris cast the tie-breaking vote that led to the single largest Tribal investment in history—\$32 billion—to help Tribal economies devastated by the COVID-19 pandemic.

Vice President Harris and President Biden made the largest investment ever in Tribal infrastructure through the Bipartisan Infrastructure Law—\$13 billion—directly to Tribal communities for high-speed internet, roads, bridges, clean water, and improved sanitation.

The Biden-Harris Administration invested more than \$720 million specifically to support climate resilience, including drought mitigation, home electrification, clean energy development, and Tribal community-driven relocation offerts.

Vice President Harris and President Harris invested \$3.5 billion in and implemented a predictable funding method for the Indian Health Service (IHS).

**Proposed the largest-ever investment in Tribal housing**, including more than a billion dollars to support new housing and community development projects.

#### **Trump Pushed Aside Tribal Nations.**

Trump excluded many Tribal businesses from applying for the first round of the Paycheck Protection Program emergency relief funds. He favored well-connected big businesses.

**Trump issued a rule to limit the power of states and Tribes** to review the harmful effects of pipelines, dams, and other projects on Tribal lands.

**Trump proposed cuts to IHS funding** and tried to cancel funding for the CDC's health and wellness initiative.

#### Vice President Harris and Governor Walz Will Help Native-owned and Other Small Businesses Start, Innovate, and Expand. They:

**Will provide a dramatic 10-fold expansion of tax relief** for starting a small business by increasing the startup expense deduction from \$5,000 to \$50,000.

**Will make it easier for small businesses to operate and expand** by cutting unnecessary red tape, making it easier for small businesses to file taxes, and reducing barriers to getting occupational licenses across states.

**Will help existing small businesses grow**, by providing low-and no-interest loans to small businesses that want to expand, boost access to venture capital, and support innovation hubs and business incubators.

**Have set a goal of 25 million new business applications in their first term**, which would generate over 10 million more business applications than Trump saw during his term.

# Vice President Harris and Governor Walz Strongly Supports Native Children and Women.

The Biden-Harris Administration successfully defended the Indian Child Welfare Act (ICWA) in the U.S. Supreme Court. The law establishes minimum standards for the removal of Native American children from their families, as well as a preference for Native American children to be placed with extended family members or in Native foster homes. Vice President Harris knows the Indian Child Welfare Act well. As San Francisco's District Attorney and California's Attorney General, she used it to protect the rights of Native children.

Vice President Harris is standing up the Federal Indian Boarding School Initiative, a comprehensive effort to recognize the troubled legacy of federal Indian boarding school policies and work with Tribal Nations to ensure victims of this legacy have redress.

Vice President Harris helped establish a Missing and Murdered Unit within the Department of the Interior focused on analyzing and solving missing and murdered cases involving American Indians and Alaska Natives.

Vice President Harris helped reauthorize the Violence Against Women Act (VAWA) in 2022 which includes expanded criminal jurisdiction for Tribal courts to prosecute non-Native perpetrators of sexual assault, child abuse, stalking, and sex trafficking.

Under Vice President Harris and President Biden, the Department of Justice successfully defended the constitutionality of the Indian Child Welfare Act, a vital statute that protects Indian children, families and communities.

Under Governor Walz's leadership, Minnesota launched a first-of-its-kind Missing and Murdered Indigenous Relatives Office to tackle the epidemic of cases in Native American communities.

# Vice President Harris is a Strong Advocate for Cultural and Language Revitalization.

Under Vice President Harris and President Biden, the Department of the Interior created a systematic and streamlined process for returning human remains, collaborating on programming, resource development, and policy.

Some 40 federal agencies of the Biden-Harris Administration are revitalizing Native languages, collaborating on programming, resource development, and policy.

The Biden-Harris Administration released a first-of-kind guidance for federal agencies to better recognize, respect, and include Indigenous Knowledge in federal research, policy, and decision-making.

Vice President Harris helped enact the first-ever proclamation of Indigenous Peoples' Day.

In Minnesota, Governor Walz protects Native children's inherent right to their culture, language, and Tribal identities by investing in Native Language Revitalization Grants and expanding the Minnesota Indian Teacher Training Program.

# Under Trump, Native People Endured Constant Attacks.

**Trump destroyed Indigenous sacred sites and burial grounds**, including Monument Hill in Organ Pipe Cactus National Monument, to construct his U.S.-Mexico border wall.

**Trump repeatedly attempted to cut funding for Native education programs,** including by slashing funding for the Bureau of Indian Education facilities.

Trump refused to reauthorize VAWA and repeatedly proposed cutting Tribal public safety and victim services budgets.
