In ancient times, the Fish Clan may have held a special significance, given the name of our people is a compound word beginning with Ho, reflected in the name Hocak. Families belonging to the Fish Clan include: Big Head, Blackfish, Fischer, Houghton, and Sharpback. 

WCHS Receives 5,000,000 in Network Cutover Reimbursement

Winnebago, NE – Winnebago Comprehensive Healthcare System (WCHS) has negotiated and justified an over 5-million-dollar reimbursement from Indian Health Service (IHS) for the transitioning of their information technology network and systems earlier this year. During the network cutover, the Health System rebuilt their entire network infrastructure from scratch to become independent from the Indian Health Services' D1 network.

The expansive cost of rebuilding a health facility's IT network and infrastructure is what holds many native health facilities back from self-governance. WCHS is only one of a handful of native facilities who've managed this transition, forging the path for others who

may want to follow.

"This transition was a significant investment and undertaking for WCHS, the new network has already begun to enhance collaboration throughout our organization and has allowed us to work toward improvements we couldn't even dream about before." Monti Molzen, WCHS Information Technology Manager, explains.

The new network allows the organization to manage all network servers, switches, internet, security, and phone systems enabling WCHS to prevent outages that could impact patient experience. Since the network cutover, there have been no phone outages, a feat WCHS and its patients could not go 30-days without experiencing prior. Round-the-clock phone services, stable internet

connections, reliable servers' storage, and trusted cyber security practices are crucial for emergency services and healthcare facility operations and the patients they serve.

"Earning reimbursements for the network cutover positively reinforces the strategic decisions we have made and enables us to continue moving in the best direction for our patients." David Edwards, CEO of WCHS, expressed. "Our new network capabilities, enhanced bandwidth, functionality, reliability, and digital independence will help support us as we strive to lead the nation in indigenous healthcare."

WCHS's actions of self-governance will greatly improve the quality of care received by the Winnebago community, while setting an example for more tribal health facilities to follow suit.

WTN GWE PAYMENT HELD

[Winnebago, NE] It is called General Welfare Exclusion, and it is this year's payment made to the Winnebago tribal members. First approved on October 7th, 2024, by the Winnebago Tribal Council, in a split decision, the payment of \$500 dollars was set to begin with electronic payments on November 26th, 2024, for those with banking information. A paper check option was available, with that distribution being set for December 4th, and 5th at the Blackhawk Community Center Gym.

"People are pretty excited about the payment. We're looking forward to making

sure all of our people have the chance to claim the GWE payout." Garan Coons, Communications Department head told the WIN prior to the payment dates being past. The application process for the payment was set to expire on Friday, November 15th, 2024. However, leading up to that deadline there were still hundreds of tribal members who had not completed the online process. Coons continued, "You could see that too many people just didn't hit that deadline. For whatever reason, they just didn't get it completed."

After the payments began to hit bank accounts, those tribal members and their families who found themselves in the incomplete pool began to reach out to various

Tribal Council members asking what could be done. The Winnebago Tribal Council heard the matter at their meeting held on Tuesday, December 3rd, 2024, where another motion was passed, again in a split vote, to allow all tribal members to have their checks printed. Speaking at their meeting about his motion to fulfill payment to all tribal members, Councilman Aric Armell, told the council, "[w]e were elected to represent our people." Armell's motion passed on a 4-3 vote gaining the support of Chairwoman Kitcheyan to break the tie.

The paper-check payment dates are always a hub of activity, and this year was no

different. The Whirling Thunder Wellness Center parking lot was abuzz. One tribal member said outside the event, "A lot of smiling Hochunks today. I love seeing it!" Inside, the WTN Finance staff was well-prepared taking time for tribal elders to come in first and then opening the doors to everyone a few hours following.

The source of the General Welfare Exclusion payment was not casino revenue - as had been the case in years past. The source of funds utilized by the Tribe in 2024 determined how the applications for payout were to be submitted and filed on behalf of the membership. However, the online system was beyond the reach of some for a variety of reasons. The actions of the Tribal Council to determine a full payout came in the best interests of the people, especially those most in need. "For [most] of our people \$500 is a big deal." Council member Armell stated during his debate of the vote to finalize payout.

'The season of Advent'



Winnebago Veterans Invited to California

[San Pedro, CA] During the week of November 18th, 2024, the Winnebago Veteran's Association travelled to Southern California. After receiving an invitation to come out to the Coast Guard base located along the Long Beach area seashore, WVA Commander, Gordon Rave, gathered members of the troupe to take the trip West. Rave told the WIN, "[t]hey're trying to get Native organizations to help out. So, we said we'd come." The overall activity was part of the Coast Guard's honoring for Native American Heritage Month – which was November.

WTN Communications Department associate, Kevin Ebert, who is also a veteran himself, was one of those selected to make the journey. About his experiences Ebert writes, '[t]he Winnebago Veterans Association was invited out to San Pedro California, by the United States Coast Guard Los Angeles-Long Beach. We marched in the colors just feet away from the ocean. It was really a sight to see.'

Ebert represented the WVA and the Winnebago Tribe along with other members of the WVA. Commander, Gordon Rave, was also joined by Karl Baker, Taylor Bass, November Fiscus, Anthony Bassette, Tony Snake, Alfred Lopez, and Winnebago Tribal Councilman Aric "Dusty" Armell. All of whom are veterans from the various branches of the U.S. military. Ebert continued, writing 'once we marched in the colors, Lt. Commander Spadafino gave the opening remarks. All our veterans gave a speech on where we came from and what it is [for] us to be Native American. [it] was Native American Heritage month.'

During their time WVA Commander Rave and Tribal Councilman Armell expressed their gratitude as they described their own thoughts and well-wishes to the gathered crowd. Base Lt. Commander Spadafino was presented with items by the WVA members. Ebert wrote, 'Our Commander Rave and Councilman Aric "Dusty" Armell presented Lt. Commander Spadafino with a Tribal Flag. Taylor Bass presented MST-3 Berry with a medallion made by a tribal member.' Each of the items was well received.

About the trip, Ebert finished, 'It was sunny and beautiful our whole stay in California. [The] weather seemed to stay around a constant 65° F. The atmosphere was positive and uplifting. The whole base treated us like royalty.' During his interview with the WIN, Rave told our readers that the Coast Guard activity was one that occurred yearly - again as part of the Native American Heritage Month celebrations held every November. 2024 happened to be the first time the Winnebago tribe could attend. Rave spoke of how the Coast Guard would like to have even more of a tribal presence during their ceremonies. "They said they wanted people, if they can, to be in regalia. They asked if we had princesses who wanted to go out there." Rave stated. Mirroring that sentiment Ebert wrote, 'Overall it was a very invigorating experience for our veterans. They [U.S. Coast Guard] invited us to come back next year and would like to have singers and dancers for the event. [It] would be really awesome if we could make that happen.'



Editor's Movie Review:

"Weyland-Yutani Leftovers" Alien: Romulus

There are few movie franchises that have the staying power to last more than 4 decades. Our movie review for this issue is with one of those phenomena – Alien: Romulus. As the latest episode of the story that first debuted on the big screen over 40 years ago, Alien: Romulus premiered in Los Angeles in the late summer of 2024. Taking its place among the widely varying movies that have come from the first telling of the Alien story in 1979, this newest chapter has both the modern CGI to push a new movie, while tying it to the reason we all keep coming back - the xenomorph with the winning smile.

Directed by Fede Alvarez, the Uruguayan storyteller takes the helm to a divergent part of the timeline that places us after the first Alien movie events have taken place, but before those of the powerhouse sequel Aliens (1986). That mega-hit blockbuster of course directed by Hollywood icon. James Cameron [Terminator / Titanic / Avatar]. Alvarez gets the chance to deepen the Alien storyline. His ability as a horror genre director meets its maximum, because while we all know the villain, in Romulus, we do not know the hero.

The Alien franchise has had a tough time tearing itself from the long shadow cast by Sigourney Weaver's portrayal of anti-heroine Ellen Ripley. Weaver's screen presence was immense, with her character becoming the center of at least four full-length feature films. Aliens (1986) is also in my personal top 3 of All-Time Sci-Fi movies. So yes, the task is daunting indeed.

Romulus begins as set on another exoplanet, LV-410. It is a perpetually dark mining world run by galactic mega-conglomerate Weyland-Yutani. The company notorious for its dark and sinister actions designed to consume everything in its path regardless of who becomes expended along the way. The main character, Rain, is played by newcomer Cailee Spaeny. Rain works for years to earn her way to a planet with sunlight but is then denied by the company, who changes the goal line as it sees fit. Frustrated, Rain visits her ex-boyfriend, Tyler, who tells her about a plan. A plan to commandeer a spacecraft with the ability to take them to a secretly discovered drifting space station, Renaissance. Renaissance is divided into two parts - Romulus and Remus, all of which is on a crash course with LV-410s icy rings.

Aboard the drifting craft is the equipment required for cryostasis sleep. A necessity for the long journey the young group of associates nopes to make as they flee from the darkness of LV-410. In tow with Rain is a malfunctioning cyber-human brother figure, Andy. A gift from her deceased father, Andy

finds out he would not be welcomed at their new home light-years away. But time is also of the essence. The Renaissance space station's orbit is decaying rapidly and will soon be destroyed by the planet's

Once aboard the Renaissance, the team encounters Rook, a nearly destroyed cyber-human. Reactivating Rook also reactivates the plan programmed into the system by Weyland-Yutani - capture the xenomorph and return it for further study. From there the story takes off and begins to go along familiar paths, as the cocooned aliens are reanimated accidentally - or so Rook says.

The CGI scenes are exceptional and the updates to the xenomorphs are right where you want them to be. Replete with translucent fangs, more saliva than you could ever measure and some additional ingredients I don't want to spoil. 2024 is a long way from the original design of the aliens crafted by H.R. Geiger that has lived on in each of the movies. The legacy of their creation is alive and well. But that's where the enigmatic presence of the alien franchise slows here.

The actors are new, and I like not knowing them, as we did so well with Ripley. But the presence of the actors is not very dynamic, and their story lines are too hurried to feel anything for them as the aliens do their thing. Late actor lan Holm, who played Ash in the original film has his likeness used for the character Rook, and the CGI gives him more depth than the living actors to be honest.

At nearly 2 hours, Alien: Romulus is a good way to spend time watching a popcorn flick. Perhaps I'm just too much of a franchise fan to hope for less. It is a good movie; just didn't pack the punch I hoped it would. On our world-famous HaazZaat! scale Alien: Romulus is getting 3 out of 5 Haazs. Wonderful CGI, cool story premise, just didn't hit me like I hoped it would have. I'd still recommend you see it though. And I can't wait to see what story they tell next.
